<u>CC&R AMENDMENT</u> <u>BALLOT</u> <u>- MAILED</u> <u>OUT</u>

By the time you receive this issue of the Seashore News, home-owners should have already received, by First Class Mail, your ballot and related information. This ballot deals with amending the Master Declaration (CC&Rs), and certain Supplemental Declarations, regarding slope area responsibilities. Please refer to the material enclosed with the ballot on the specifics of the proposed change.

Homeowners will have an opportunity to hear about this proposed change and ask questions at the March 17 Open Meeting.

Tom and Scott are with Converse Consultants and will be able to answer technical questions about the slopes. Converse has been advising the many Board of Directors since 1978/79 about the slopes throughout this community.

PLEASE DO NOT CALL THE OFFICE WITH QUESTIONS ABOUT THE PROPOSED AMENDMENT! Come to the Open Meeting on March 17 to hear about this amendment and receive answers to your questions!

Do call the office if you have not received your ballot and related information by March 6. The office will mail out a duplicate after March 8.

Be sure to return your ballot to the association by April 12.

Meeting will begin at 7:30 pm for regular committee reports and other association business. Beginning at 8 pm, the Board of Directors will discuss the proposed CC&R amendment and will answer homeowner questions.

FEBRUARY BOARD ACTIONS

- 1. Requested the ACC to provide the Board of Directors with a list of homes that require repainting. List to be provided by early May.
- 2. Authorized reimbursement of \$177.85 to a homeowner whose sewer line was clogged by common area tree roots.
- 3. Accepted Recreation Committee Chairperson's request to appoint homeowner Kathy Buskirk to committee and to remove Edith Patterson and Donna Rosecrans.
- 4. Declined Recreation Committee's suggestions to add tetherball, shuffleboard and four square concrete courts to greenbelt area at community center.
- 5. Accepted series of three reports compiled by Converse Consultants:
- a. Association-wide slope failure potential assessment update.
- b. Results of ground water level monitoring of existing wells.
- c. Comprehensive survey of lower Nauticus Isle slope.
- 6. Authorized management to send a copy of the lower Nauticus Isle slope survey to each homeowner on Nauticus Isle. A copy is mailed each year after acceptance by Board.
- 7. Authorized management to have proposed CC&R slope amendment ballot, cover letter and attachment sent to printer and mailed out First Class. Material to be in mail by February 26, 1993.
- 8. Office staff is to no longer provide recommendations on service contractors to residents that inquire. Residents can obtain recommendations from their neighbors or use the phone book.

TOT LOT RENOVATION

Some of you are aware that the renovation work on the Tot Lot has been delayed. This delay is due to the adverse weather and the discovery that additional State laws need to be reviewed and complied with.

Management has been reviewing the options for the Board of Directors and the associated additional costs to implement. It is expected that the Board will make a decision in March so that the installation can be scheduled.

At this time, we do not know if the installer has time available to do the work in March, but we expect that the equipment can be installed by mid-April. Again, the weather will have the greatest impact on scheduling.

The NSCA managewants to know about problems the gate, but would prefer the details have in WRITING. Complaints submitted in writing carry more weight with the management of the guard company. A first hand account of the problem is much better than hearsay.

When submitting problems, please provide the following:

- Your name and address
- Date and time encounter occurred
- Did the problem involve the Mariner Gate or patrol
- 4. Specific details of the problem

The office staff is forwarding all written complaints to Westridge's management for review and follow-up.

It is unfair to verbally criticize the guards in general without specifics. Some of their personnel are doing a good job and have picked up our procedures well. By giving an approximate time and date, both the NSCA management and Westridge management can isolate the problems and help to improve those individuals who are not performing properly.

Your help in providing WRITTEN comments and complaints is greatly appreciated by both management staffs!

Landscape Projects for March

If the weather cooperates during the month, the following will be accomplished or started:

- 1. All the eucalyptus trees along the east side of Leeward, between Spinnaker and Marlinspike, will be safety pruned and thinned. These trees have not been trimmed in many years.
- 2. Landscape material on the Stonehill slope, between Niguel Road and Niguel Shores Drive, will be severely trimmed if its height exceeds the top of an adjacent homeowner's fence. Homeowners affected by this work will receive a letter prior to work beginning.
- 3. Will begin to add landscaping around boulders installed on green-belt in Sea Terrace I.
- 4. Finish pruning of shrubs in beach parking lot.

REMINDER - TRASH PICKUP DAY HAS CHANGED

The day of pickup has changed for many of you:

Sea Terrace II & Villas - TUESDAY

Balance of Community - THURSDAY

Please do not put your containers out more than 12 hours prior to pickup and remove your empty containers by the following morning.

BE SURE THAT YOUR TRASH CONTAINERS ARE NOT VISIBLE FROM THE STREET AFTER YOU PUT THEM AWAY. As of March 8, management will start sending violation letters to those homeowners who are violating the rules, and those who are flagrant about violations will also be referred to the City's Code Enforcement division.

Residents are subject to fines assessed by both the Association and the City for not putting away containers or putting them out too early.

Please cooperate so that this action is not necessary! Your Board of Directors and neighbors will appreciate it!!

RECREATION COMMITTEE REPORT

It was noted that Thursday, February 11, was the last day to join the Country Western Square Dance class.

The new ping pong table and the new rules for its use were discussed as was the status of the special committee to locate several new facilities including horseshoes and croquet.

It was announced that there has been no change in the Friday Night Movie program except that the video store in the Dana Point Plaza has changed owners. The committee also voted to schedule just one lecture on a topic of wide interest and appeal this spring.

The committee has also proposed that the Board conduct a census of the community to determine the number and ages of children in the community among other things.

SOLAG DISPOSAL RECYCLING PROGRAM UPDATE

Several homeowners were at the February 17th Open Board Meeting at which the Mayor of Dana Point was present. The Mayor made several statements that need to be clarified. Our General Manager spoke with both Gary Dysart, Deputy City Engineer, and Jim Koutroulis, General Manager of Solag, about those statements. The following is the current status:

- 1. The Mayor said that a resident who had both 35 gallon size containers could replace the smaller "black" trash container with a 60 gallon trash container. We have been informed that the City and Solag are still reviewing this situation and no decision has been made. If this change is allowed, then you would probably be billed at the higher rate, as though you had all 60 gallon size containers.
- 2. The Mayor indicated that if a resident already recycled items used in the home, it may be possible to exchange the "blue" recycle container for another "black" trash container. At this time, we have been informed that this is not possible. Please read the information that came with the containers as to the items that are to be put into the recycle bin. The list is much broader than simply newspapers and aluminum cans.

It is hoped that the above clarifications are sufficient. If we are notified of changes in the recycling program, they will be published in future issues of the Seashore News.

(NSCA Rule 9101; Orange County Ordinance, Title 4)

NIGUEL SHORES PAPER SALVAGE PROGRAM

The salvage program being established in Dana Point in conjunction with Solag Disposal Service should have no effect upon our own salvage program which has been in effect since February, 1978. There is no law or rule that requires that our residents contribute their papers to the city program. The S Company will now charge us The Solag for trash and recycled pick-ups, they will make no payment to city for their income from the sale of these materials.

On the other hand, the paper collected at our salvage room on the west side of our community center is sold for \$12 per ton to Dalton Enterprises, and the money received is used for the exclusive benefit of our own community.

Mr. Dalton has been very firm in his request for all paper to be contained in a package. You may use large grocery bags, grocery plastic bags, even cardboard cartons, or the papers may be tied with cord, but he requests, NO LOOSE PAPER.

Again, as in the past, all types of paper are acceptable. News-papers are the most desired, but telephone books, magazines, junk mail, envelopes, catalogs, etc., are all welcome, but no large cut up cartons are wanted. Cartons used as containers, however, are okay.

This is an appeal to all residents, particularly those who have not participated in this program in the past.

PLEASE DO NOT TRASH YOUR PAPERS WITH SOLAG. LET NIGUEL SHORES CASH THEM FOR THE JOINT BENEFIT OF ALL.
