BOARD ACTIONS FOR FEBRUARY

- 1. Accepted revised draft of the Homeowner Request Form. Directed management to have it printed up and to include a copy with the March issue of the Seashore News.
- 2. Adopted revisions to Rule 3152 Basketball Backboards. Revisions to Rule became effective February 1, 1995. Copy of revised Rule is attached to this issue of Seashore News.
- 3. Accepted Andy Boush's resignation as member and Chairperson of Finance Committee.
- 4. Adopted revised wording for Bylaw Section 1210(b) Chief Financial Officer. Directed management to mail the revised section to all homeowners using the April 1, 1995 assessment statement mailing.
- 5. Adopted revised rules for use of the Community Center MPR by residents. The major change in the rules allows homeowners, as well as registered tenants, to pay a fee to use the MPR for social parties. Residents wishing to have a copy of the revised rules may obtain them from the NSCA office.
- 6. Accepted offer from Recreation Committee to split the cost evenly for a new concrete picnic table for the beach bluff. Table to be purchased and installed by the end of April.
- 7. Accepted cost from Sweetwater Pool Service for purchase and installation of new pool heater and purchase and installation of new filters. Total cost not to exceed \$10,250. Work will be completed in March.
- 8. Accepted bid from ADP for use of computer software program for in-house calculation of staff payroll and filing of quarterly payroll tax returns. Cost will be \$41 per month.



USE OF GARAGE AND/OR DRIVEWAY FOR PARKING VEHICLES OVERNIGHT IS REQUIRED BY RULE 6505

The Board of Directors would like to once again remind residents that they must follow Rule 6505 as it pertains to decaled vehicles using common area parking overnight. Residents are expected to use their garage, then their driveway before placing a vehicle within common area parking spaces.

Residents must understand that parking in front of their driveway, on the street, is considered using common area spaces. This practice should be discouraged, especially in light of our many narrow streets and the fact that a fire lane, under the jurisdiction of the Orange County Fire Department, must be an unobstructed twenty (20) feet wide.

SEA TERRACE II & VILLAS RESIDENTS - NEW ACCESS CODE/VISITOR PARKING PASSES COMING

The four-digit access code that currently opens the Manta and Garibaldi gates will be changing on April 3. All Sea Terrace II and Villas residents will receive a notice listing the new code, and will receive new visitor parking passes by March 27. The new visitor parking passes must be used as of April 1.

If you do not receive the mailing by March 27, come to the NSCA office during regular business hours to receive a copy of the notice and visitor parking passes.

STREET SWEEPING SCHEDULE

The scheduled date for street sweeping this month is Monday, March 6. You are requested to have your vehicles off the streets and out of the parking bays. This will allow the sweeper to do a better job.

NEW PROCEDURE FOR ANNOUNCING THAT HOMEOWNERS HAVE SUBMITTED PLANS FOR SPACE ADDITIONS AND/OR **ROOF DESIGN CHANGES**

Last month, there was an article about the Board's intention to include in the Seashore News the names and addresses of those homeowners who have submitted plans for space additions and/or roof design changes. problem became evident with this process. The Board decided it was unfair to these homeowners to wait until the near end of the 45 day time frame the Architectural Committee is allowed to review plans that are submitted.

In a more workable procedure, an article in the Seashore News each month will state that a list posted at the Community Center will provide names, addresses, dates plans were submitted, and the last day to turn in written comments to the NSCA office for transmittal to the Architectural Committee. It is very important that written comments for the Architectural Committee be submitted prior to the date listed on the posted information sheet. Comments submitted late may not receive Architectural Committee consideration at time they review plans.

TRAFFIC & SAFETY COMMITTEE

Turn on your outside lights!! Age and weather have taken a toll on our community's outside lighting and have caused havoc with our automatic gates. We realize the increase in our vulnerability to becoming victimized. You can help by turning your outside lights on during the hours of darkness.

A residential burglary took place up in the Villas between the hours of 4:30 and 10:00 pm. The suspect entered by removing a kitchen window with a screw driver. He ransacked and took jewelry and silverware -- he wore gloves and is thought to have been on foot as he left a silverware chest behind.

A second burglary has now taken place across the street from this one during the time residents were attending Sunday night's Potluck. The similarity of the two burglaries would indicate that they were accomplished by the same person.

QUARTERLY ASSESSMENT PAYMENTS MUST BE SENT TO THE SERVICE BUREAU

Every quarter you are sent a billing statement that must be paid within 30 days of the due date listed on the statement. To avoid a late charge and interest charge, your mailed payment must be canceled by the Post Office by the 30th of the month the assessment is due. Look for assessment billings in the months of January, April, July and October.

Several homeowners have been sending their assessment payment to the NSCA office. Doing this will not keep a homeowner from receiving a late charge or interest charge. ALL ASSESSMENT PAYMENTS MUST BE SENT TO THE SERVICE BUREAU'S ADDRESS LISTED ON THE QUARTERLY ASSESSMENT STUB, REGARDLESS OF WHEN THE PAYMENT IS MAILED. The only exception to this applies when the office staff directs you to make the payment(s) directly to the office.

Assessment payments are not accepted at the NSCA office because it is not set-up to safeguard the payments, and the office does not have an adequate number of employees for proper internal accounting controls.

LANDSCAPE COMMITTEE UPDATE

The Committee has spent the last several months working on its plans for 1995. During March, the following work will commence:

Atlantic Garden Homes - the pine trees along Atlantic Dr. and Atlantic Ave. will be thinned out so that light can get to the turf, shrubs, and ground covers planted near the base of the trees. This thinning is done every five years.

Sea Terrace I - The several homes on Marlinspike will have their front yard shrubs/ground cover renovated. This work is a continuation from the 1994 Landscape Budget.

POOL WILL BE CLOSED IN MARCH FOR MAJOR EQUIPMENT OVERHAUL

The Board of Directors has approved the replacement of the existing pool heater and changes to the filtration system. The work has not been scheduled as of the writing of this article. It is expected that the pool will be closed for approximately ten(10) days towards the end of the month.

Please look for notification of the specific closing dates at the Community Center on a poster. If problems develop and the pool cannot open on the date listed, a new poster with the revised opening date will be installed.

The spa and locker rooms will be open throughout this process; however, our maintenance staff is going to take the opportunity to thoroughly clean the locker rooms while the pool is closed. Signs will be posted advising of the work and the staff requests resident patience at the time the work is being completed. Some women may be inconvenienced while the staff is working. We apologize; however, the work is necessary and asking staff to leave will cause unnecessary delays in completing the work.

3154 Garages (04-16-86)

A. All required garage spaces shall be fully enclosed and garage doors shall be kept closed except when in use.

B. Garages shall not be converted into living quarters, sleeping quarters, offices, or other similar use.

3155 Mail Boxes (04-16-86)

Mail boxes shall be built into or attached to building walls or fences, with the specific location to be approved by the committee, except in Tracts 8602 (Sea Terrace II) and 9098 (Villas) where mail boxes must be on posts already provided.

3156 Service Yards (04-16-86)

All service yards and clothesline areas shall be enclosed or fenced in such a manner so that they will be reasonably obstructed from view of any adjacent lot or street.

3157 Signs (08-18-93)

Commercial, political and signs other than occupant identification, private security company, or street number are not permitted, unless one of the following exceptions apply:

- A. A member may display one sign advertising residence for sale, lease or rental exchange. A second sign may be placed on the real property of another, with that person's consent, advertising directions to the member's residence. The sign(s) shall be no larger than four square feet, including any informational rider, and shall be done in a professional manner. Realty signs shall be removed within five days following entry into escrow. No sign shall be permitted to remain because of a contingency. Notification of continued showing shall be handled through normal realty channels. See Rule 2711 (Architectural I-D) for enforcement and penalties.
- B. The sign may be placed inside the home, facing out through a front window. The sign may also be affixed to a metal stake that is less than one inch in diameter and placed in the front yard. Signs may not be affixed to wooden 2x2 or 4x4 posts or affixed to the home's exterior building surface.

Signs, as authorized in Section A, may not be placed upon the association's common areas and slope easement areas. Those placed on these areas will be immediately removed by the association and taken to the association office for storage. Signs not claimed by their owners within five days of removal will be disposed of by the maintenance staff.

Note: When approval request received, Architectural Control Committee will consult on-site with homeowner and specify painting requirements for property. Colors as provided blend and have been selected to maintain a harmonious appearance in the tract. Color chips are on file in the NSCA office for review.

E. Berkus Homes (Tract 7447)

The outside of the perimeter fences may be required to be painted Dunn Edwards #51 Birchwood. These fences may be considered for this treatment on an individual, partial or total basis.

- F. Gutters, metal flashing and vents (pipes) on top of roofs to be painted to blend with house.
- G. Repainting/restaining shall be accomplished within ninety (90) days after approval.

3146 Private Parking Areas (04-04-90)

Existing open parking spaces on private property shall not be reduced to less than the space necessary to park two automobiles.

3150 General Regulations (04-16-86)

Regulations relating to the utilization of existing structures are shown in Rules 3151-3158.

3151 Exterior Antennas (04-16-86)

Exterior antennas of any kind are not permitted.

3152 Basketball Backboards (02-01-95)

- A. Only one basketball backboard permitted per residence.
- B. Permanent basketball backboards must be solidly constructed and firmly affixed to garage or other portion of house. Backboard, including target strip, must be completely painted or stained to match structure to which attached and must be neatly maintained and painted when necessary.
- C. Use of a portable standard with basketball hoop is permitted, but must be removed from the front yard and stored away from the view of neighboring properties and streets each day by <u>sunset</u>, or <u>when not in use</u>. The portable standard is not permitted to be placed on sidewalks or streets at any time.

3153 Flag Poles (03-20-91)

- A. Flag pole brackets may be positioned on house at owner's discretion.
- B. Free standing flag poles must be submitted for approval, with diagram showing location and height of pole.
- C. Free standing flag poles must not constitute a view blockage either from the standpoint of height, location of pole or size of flag.
