The new Shores Gate is operational. For more details, please be sure to refer to the article in this issue titled "Shores Gate".

Water Reclamation Up Date As outlined during two previous Board meetings and in the March issue of the SEASHORE NEWS, the South Coast Water District has made us a proposal regarding a contract for reclaimed water to be used for irrigation purposes. During the water district's presentation, the Board was advised that before the 1980's are over, many areas of Southern California will be forced to take a hard look at the practice of irrigating with drinking water.

A committee composed of Don Lutz, Norm Pomeroy, Bill Merrithew, Jim Guthrie, Dick Smiley, John Bulleit, and Ken Knight was appointed to study the matter. The group was asked to explore the pros and cons of the project with resultant information to be made in a report to the Board not later than the first meeting in June.

The committee report was presented to the Board at the March 24th meeting. In essence, the group feels that as presently designed, the proposal is not economically feasible and contains some "gross inequities".

Accordingly, the Board has directed the General Manager, Dick Smiley, to draft an outline for an indepth study of the water reclamation program to be presented to the Board at its next meeting. Subsequent to Board approval, Mr. Smiley will contact a professional firm such as David A. Boyle Engineering to determine the costs of such study. The outline should include the following:

- .. Costs of retrofitting to provide service to the whole community.
- .. Costs of relandscaping, should a water shortage occur.
- .. Probability or possibility of potable water becoming unavailable
- .. Water district's willingness to do more than they have currently offered.
- .. Risks the Association may experience if we do not provide for reclaimed water.

The Sea Terrace II Suit On December 24, 1979, Sea Terrace II initiated a lawsuit against Niguel Shores Community Association. In essence, the subject matter of the lawsuit is that Sea Terrace II does not wish to be charged or pay any extraordinary assessments to Niguel Shores Community Association. Niguel Shores Community Association's legal position is that said assessments should be paid as provided in the C.C.&R's of Niguel Shores Community Association.

As of this date, there is a mandatory settlement conference scheduled for June 1, 1981, and trial has been set for September 28, 1981. Both of the above shall take place at Orange County Superior Court in Santa Ana.

Our regular Board meeting will be cancelled this month due to Easter vacation time.

Dear Members,



THE LAGUNA NIGUEL COMMUNITY ASSOCIATION ELECTIONS

The election of Directors for the Laguna Niguel Community Association (LNCA) will take place throughout Laguna Niguel from April 8-13. Ballot boxes will be located in Monarch Bank and the Dana-Niguel Library during business hours on these dates and from 10:00 A.M. to 5:00 P.M. on Saturday and Sunday, April 11 and 12, at Safeway and Alpha Beta. Ballots will be printed in the Wednesday, April 8 edition of the CAPISTRANO VALLEY NEWS. Extra ballots will be available at the aforementioned shopping centers on that week-end.

The LNCA Directors are elected for a two year period and any resident of Laguna Niguel is entitled to vote for one Director from their district, and five at-large members. Niguel Shores is District #10.

Directors of the LNCA, which was formed in 1966 to serve the interests of the community, represent the views of Laguna Niguel's citizens on a variety of important issues such as development, road safety, county services and school problems. There are seven committees that both the Directors and other interested citizens from the community work on: Planning, Parks and Recreation, Cultural and Social, Public Safety, Education, Governance, and Membership. The LNCA meets at 7:30 P.M. on the second Monday of each month at the Community Center on Crown Valley Parkway. All citizens are invited and encouraged to attend these meetings and to express their views and concerns. Remember the dates, April 8-13! This is your opportunity to elect your representatives who will make your voice heard in this community.

District 10 Candidates

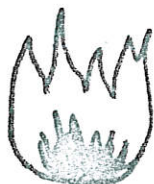

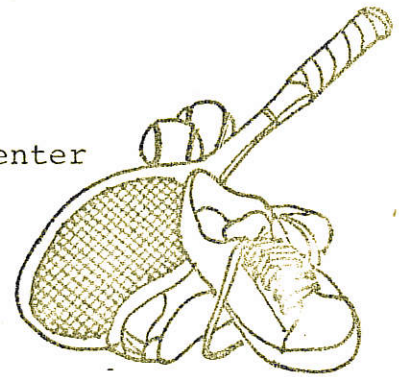

Court Jester: Ginny Jester (with that last name, she's a natural) assisted by gigglers Doris Adams and Lorraine Polik.


