In the recent issues of The Seashore News we have asked for opinions regarding means of dissuading outsiders using the recreation facilities at the Community Center. We received many responses. Most respondents said they were concerned about misuse, and that many uninvited nonresidents were "free loading". These respondents wanted us to begin requiring the use of key-cards or identity tags. They said they had seen unacceptable conduct by apparent residents, and outsiders using our swimming pool, spa, bathrooms, and play ground areas, etc. On the other hand, some respondents said they were not aware of problems that warranted curtailing the completely free and unrestricted use of these facilities by NSCA members.

Several months ago, I suggested, in effect, that in an ideal society there is little need for detailed laws or rules and someone to enforce them. This was based on my belief that there is no better practice than treating others as you would have them behave toward you. Still, we know that we are not living in an ideal world.

In fact, not all residents in The Shores appear to accept that with freedom there is a commensurate necessity for self discipline and acceptance of responsibility.

The following are examples that apply to some residents, guests or uninvited people: (a) unless challenged, individuals fail to register at the recreation desk; (b) children are sent or allowed to go to the Community Center unaccompanied or unsupervised by a parent or reliable adult; (c) friends and relatives of residents are invited to use Community recreational facilities without accompanied by the hosts; (d) unsupervised children recklessly/dangerously roller-skate or skate board in the Community Center and in the parking lot, and destructively in the newly reconditioned tennis courts; (e) people trash the bath rooms; (f) individuals enter the swimming pool and spa without first showering-whether or not having just come from the beach; (g) surfers walking in carrying their boards, showering and even changing clothing and then walking out the Mariner Entrance; (h) persons when challenged regarding such matters become angary and confrontational when observed by our clerical our staff who generally are the only employees present. Is there a need to list still more examples?


Next Board Meeting for Committee Reports

\*Meet the Candidates for the NSCA Board of Directors\* Customary swimming pool safety and sanitation rules must be followed. These include: showering before entering the pool area; no running or aggressiveness or fighting; proper lavatory practices by children; and pool use only by residents and qualified guests. The Board of Directors has decided to end the contractual life guard service because of concerns about performance. Therefore, children less than 14 years of age will have to be accompanied by a responsible adult.

The uncooperative behavior of some persons while at the Community Center and the obvious divergence of opinions as to how or whether or not to do anything about such behavior has been thoroughly considered by the Board of Directors. The Board, on an experimental basis, starting during the Easter Holidays, has decided to assign a non-uniform employee with good interpersonal skills to generally oversee activities to assure the pleasure, safety and welfare of all residents and their guests while using Community Center.

### COMMUNITY CENTER LOCKER ROOMS TO RECEIVE RENOVATIONS DURING APRIL/MAY AND WILL BE CLOSED FOR RESIDENT USE

The Board of Directors is in the process of completing a contract with Center Point Industries for the renovations inside the locker rooms. Listed below are highlights of this work:

- New flooring in the restroom portion of the locker room, using six-inch square non-slip tiles.
- New fixtures such as sinks, toilets, lights and mirrors to be installed.
- New toilet partitions to be installed. After completion of the work, the mens room will have two toilets and one urinal and the womens room will have three toilets. The new configuration will allow for one handicapped accessible stall in each room.
- The existing door openings to the locker rooms will be boarded up, the area used for maintenance storage rooms and new entrances created. Currently, a person has to enter at least two doors and the new configuration will allow entry using one door. Outside the locker rooms new entry doors, slumpstone walls will be erected to screen the entry from the pool area.
- The interior of the locker rooms will be repainted.

As of the writing of this article, the work will start in the middle of April and last until the middle of May. LOOK FOR POSTERS AT THE COMMUNITY CENTER FOR THE SPECIFIC DATE WORK WILL START. When the work does start, both locker rooms will be closed for resident use until the work is completed.

Arrangements will be made to bring in portable restroom facilities. The Board and staff ask for residents' understanding with the location chosen for placement of the portable facilities. Staff is making every effort to use facilities that do not resemble "outhouses." The facilities will be serviced each week, and we have our janitor who will assist in keeping them clean and stocked.

The contractor and staff are going to make every effort to have the work completed before the Memorial Day holiday weekend. schedule calls for our contractor to work on weekends so that the work will hopefully be completed within five weeks.

It is the desire of the Board and staff to receive residents' understanding and cooperation while this work is underway.

### STREET SWEEPING SCHEDULE

The scheduled date for street sweeping this month is Monday, April 1. You are requested to have your vehicles off the streets and out of the parking bays. This will allow the sweeper to do a better job.



### LIFEGUARD FOR THE POOL WILL NOT **BE PROVIDED THIS YEAR**

Children under fourteen years old, using the pool area, MUST be accompanied by an adult at all times. This is the current State law and the Association's Rule 5103(16). Under-age children, not in the presence of an adult, will be asked to leave the pool area by staff.

The Board of Directors has made a determination that the funds spent for a lifeguard service will be better spent on monitoring the Community Center facilities.

### MAINTENANCE STAFF/OUTSIDE **CONTRACTORS PROJECTS THAT HAVE** OCCURRED OR ARE PLANNED IN 1996

Our maintenance staff or outside contractors are in the process of completing or will start the following projects:

Villas - several mailbox racks are being rebuilt and painted because the wood is old and insect infested. All homes will receive a new mailbox address tag mounted below the mailbox, during the first week in April. At the same time, several homeowners will be receiving new mailboxes.

Shores Garden Homes - Throughout this portion of the community, there are concrete pedestals covered with wood which act as seating areas. Maintaining the wood has been costly and time consuming. Many are continually sprayed by the irrigation systems. All wood tops will be removed and new 18" square masonry pads will be installed on top of the pedestals, then grouted. This replacement material should be relatively maintenance free for many years.

Sea Terrace I - New walkway lighting will be installed along the sidewalk behind the Halyard homes below Moonsail. The height of the fixtures and intensity of the light has been considered so that neighboring homes are not unduly affected.

Community Center - The locker rooms shall be renovated to allow greater access and use by all The interiors will receive new flooring, new wall covering, new toilets, sinks and stalls, then new paint. The existing entries to the rooms will be abandoned and new door openings created so that only one door is necessary to enter. Once all this work is completed, the exterior of the Community Center will be repainted.

Sometime during the Summer, a new flat roof will be installed on top of the patio cover/hallway.

The interior of the MPR is in the process of receiving touchup painting.

Mariner gatehouse - The exterior of the building will be repainted.

Streets - An evaluation will be made by an outside expert as to how many locations and the type of repairs needed. Many of our streets have exceeded their useful/serviceable life. The Board needs expert input as to how best to make repairs and extend the life of our streets. Actual work would not start until Fall.

### **2301** Accounts Unpaid for **30** Days (02-02-94)

Members, whose accounts have a balance outstanding for more than 30 days, are assessed a late charge of 10% or \$10.00, whichever is greater, plus interest figured at 10% per year. The mailed quarterly assessment payment must be canceled by the U.S. Post Office by the 30th day of the month due. If not, then the late charge and interest will be assessed. Reminder billings, with the late charge and interest due, are sent by the NSCA office staff.

### **2302** Accounts Unpaid for **60** Days (10-05-88)

Members, whose accounts are 60 days delinquent, are noticed by certified mail that if payment in full is not received within 15 days, a lien will be filed against the property.

### **2303** Accounts Unpaid for **75** Days (10-05-88)

Members, with delinquent accounts of 75 days, are liened. Members are assessed a charge for lien filing and administrative costs (minimum charge \$50.00).

### **2304** Accounts Unpaid for **90** Days (10-05-88)

Members, whose accounts are 90 days delinquent, are referred to the Board of Directors for suspension of Association voting rights and use of common area/facility privileges (including participation in committees, clubs and organized community events), which includes use by the member, his guests and tenants, pursuant to suspension procedures.

### 2305 Accounts Unpaid for 90 Days (03-06-96)

A member's account which is 90 days delinquent, will be referred to the Association's attorney for collection. The member will be assessed a minimum charge of \$300 for attorney fees plus other related costs.

## **2306** Accounts Unpaid for **120** Days (02-01-85)

Failure to cure a delinquency of more than 120 days may result in foreclosure proceedings against the property.
