Our Auditors: Taylor, Inouye & Clarke have the following comments to make regarding our 1981 audit:

"As a result of the work performed during the course of our certified audit, we generally issue a report commonly known as a "management letter". In this letter we generally describe weaknesses in the system of internal controls and recommend changes which could strengthen the system. More often than not our letters reiterate problems which were highlighted in previous year's letters, as well as additional weaknesses not previously noted. year's letter is a bit unusual in that management has satisfactorily resolved all issues raised in the previous management letter and we were unable to locate any additional significant weaknesses which should be brought to the Board of Director's attention. We believe that your staff has done a commendable job in that there were significant overall improvements of the accounting systems at Niguel Shores Community Association, and it was performed in less than one year. Given the conditions that surrounded our audit at December 31, 1981, we believe that the improvements contributed to imely completion of our audit within budget. Therefore, we wish to express r appreciation to Mr. Dick Smiley and his staff for their efforts which made our job easier and, also, for the courtesies extended to our represent-

atives during their visit to your office."






UNAUTHORIZED TREE


