As members of Neighborhood Watch we can provide invaluable assistance to Sheriff's Department in the prevention of crimes and in the apprehension of those who commit crimes. It is simply a matter of being observant and reporting unusual or suspicious activity in our. neighborhoods.


When you have something to report, this is what the Sheriff's Department needs to know:

- Where the suspicious person or activity is located.
- 2. A description of what is happening or has happened.
- 3. When you observed the person or activity and whether the activity is in progress. (This should be a 911 call.)
- 4. A description of the person or persons involved including estimated height, sex, race, clothing and any distinguishing features.
- 5. A description of any vehicle involved including the license number, make, model and color.
- 6. If the person or persons involved have left, the direction they took.
- 7. Whether or not injuries are involved.

In order to coordinate our Neighborhood Watch effort in Niguel Shores, the community has been divided into seven separate areas. Each one has an Area Coordinator who serves as the contact person for the Block Captains in that area. Because we have several new Coordinators, the revised list is as follows:

#### VOICE OF THE PEOPLE

It was encouraging to see both the quantity and quality in Board candidates at the open meeting. Their genuine interest in serving us deserves appreciation.

Several candidates agreed that more openess in conducting business and better dissemination of information are needed. Coviously there are times when immediate disclosure may not be proper, but eventually the basics and most specifics should be made available. Such a change in procedure may not be forthcoming because it is easier to do otherwise, as was the case when two questions related to the firing of Mr. Smiley were dismissed.

The proposal by Ed Adams that the Board concentrate its activities on establishing policy and seeing that it is enforced should be adopted and closely followed. Leading the way can easily become getting in the way if any other course is used. The Board should hire a manager equal to the task, provide essential guidelines, and let him do the job.

The question about Breakers Isle slope received a commendably appropriate answer from Tom Brooks; maintenance of our ultimately assigned portion is the responsibility of the whole community per COMAs, with no exceptions.

I urge you to vote in the upcoming election — another responsibility.

# 3105 Required Painting (4-16-86)

Any modifications or replacements shall be painted with the colors approved for the existing structure unless approval for a change has been obtained from the Committee. All exterior wood surfaces shall be painted or stained with colors approved by the Committee. Any exterior metal such as gutters, down spouts, vents and trim shall be painted to match the house trim.

#### 3106 Correction of Violations (4-16-86)

The Committee has the right to require any modification which is in violation of the CC%Rs or these Regulations to be corrected, improved or destroyed. Oversight or failure of the Committee to note violations with respect to approved plans will not be binding on the Committee nor constitute approval, and the Committee may require all such violations to be corrected.

## 3107 County Approval Required (4-16-86)

Approval by the Committee does not eliminate the need to obtain proper permits from the County of Orange, where required, and such approval will be null and void without such permits being obtained. Any deviation approved by the County must be re-submitted for approval by the Committee. Construction must be in accordance with Committee-approved plans. Construction may not be started until a copy of the County approved plans has been brought in to the Association office for comparison with the plans which were approved by the Committee and for retention in the Association files.

#### 3108 Consulting Architect (4-8-86)

The Committee may use the services of a consulting architect for all new structures and exterior design modifications or additions to existing structures. The architect may inspect the property as part of his review of the plans and may also check the job upon completion to ensure compliance with the approved plans. Such approval will be in writing for attachment to the file copy of the plans stating that the work has been satisfactorily completed.

#### 3111 Committee Meetings (4-16-86)

- A. The Committee will meet not less than twice each month on a regularly scheduled basis.
- B. Applications containing all the necessary information and plans must be filed in the Association office at least one week prior to the established meeting date in order to be reviewed by the Committee at that meeting. Applications filed late will be held for review at the next regularly scheduled meeting.

# 3115 Committee Approval or Disapproval (04-06-88)

- A. An application may be approved or disapproved at any regular or special meeting of the Committee at which two or more members cast votes. Should only one member be casting a vote, the Board liaison representative shall be permitted to cast the second vote. An application shall be considered approved if there are more "approved" votes cast than there are "disapproved" votes cast. An application shall be considered disapproved if there are not more "approved" than "disapproved" votes cast.
- B. In the event the Committee fails to either approve or disapprove a timely and complete application within thirty days after submittal of the application to the Committee, it shall be conclusively presumed that the Committee has approved such application as submitted.
- C. The approval of an application for new construction or alterations to existing structures shall be for one year from the date of approval. If construction is not started within one year, such approval shall be null and void and a new application will be required and will be subject to the regulations and requirements in effect at the time of re-submittal.
- D. Any additions or alterations to any portion of the approved plans shall be re-submitted to the Committee for review and approval prior to construction. Construction of any work approved by the Committee shall be diligently pursued to completion within six months from commencement.

#### B. Final Plans

Two sets of final construction plans shall be submitted to the Committee for approval. When approved, one set will be retained in the Association files and one set will be returned to the applicant. Approval will be contingent upon payment of additional architectural fees and/or construction deposit, if required. Construction drawings shall contain the following information where pertinent to the construction proposed:

- 1. Plot plan, drawn to scale, showing lot layout, dimensions, north arrow, easements, topographical information (such as property line and pad grades when changed from originally approved lot grades), top and toe of all slopes, building outline, drives, walks, fences (including heights) and other site improvements. In addition, a plot outline of adjacent property shall be included.
  - a. Building sites shall drain in accordance with the originally approved grading plan in a manner to prevent erosion.
  - b. It is the owner's responsibility to obtain accurate lot layout and topographical information.
- 2. Floor plan with dimensions identifying the area being added or altered and a sufficient portion of the existing structure to permit orientation.
- 3. Roof plan, indicating roof materials. Samples may be required.
- 4. Exterior elevations showing all doors, windows and roof lines, indicating all materials used on exterior, including planters and fences. Indicate roof pitch and height relative to that of the existing building.
- 5. Perspective sketch, if necessary, to clarify design.
- 6. Skylights
  - a. All plans for skylights must be submitted to the Committee for approval.
  - b. Skylights which are visible from other properties must hereafter be bronze or gray in color.
- 7. Exterior paint colors. Colors other than those previously approved shall be submitted for approval on color chips or painted material.
- 8. Exterior surfacing materials including colors. Samples may be required.

- E. During the course of construction and until final completion, the NSCA "Work in Progress" placard shall be conspicuously displayed on the front of the property at a point that is clearly visible from the street.
- F. The applicant may appeal any Committee action to the Board of Directors for their review. The requirements and procedures for an appeal to the Board may be obtained from the Association office.

#### 3121 Architectural Submittal Requirements (4-16-86)

Plans must be submitted for all modifications to existing premises as set forth under the preceding sections.

Items required for submittal are as follows:

- Completed application form obtainable at Association office.
- 2. Payment of architectural fees. See fee schedule, Section 3181.
- 3. Two complete sets of plans, drawings and specifications as set forth in Rule 3122.

#### 3122 Plans for New Construction, Additions, Remodels (4-16-86)

#### A. Freliminary Plans (Optional)

Homeowners wishing to obtain an advisory opinion from the Architectural Control Committee prior to the preparation of final working drawings, may submit an application for preliminary review along with preliminary plans, clearly labeled as such, for Committee consideration. Such plans shall be submitted in duplicate in sufficient detail to provide the Committee with a clear picture of the proposed construction. One copy of such plans will be returned to the owner with advisory comments by the Committee which may serve as a guide in the preparation of a completed application. The review of such preliminary plans by the Committee is advisory only and any comments, written or oral, made by the Committee shall not be construed as its approval or disapproval of any plans and specifications and/or construction as required by Article VII, Section 3 of the CC&Rs or otherwise; such approval or disapproval is subject to the submission of a formal application for review and approval of final plans in accordance with subparagraph B below.
