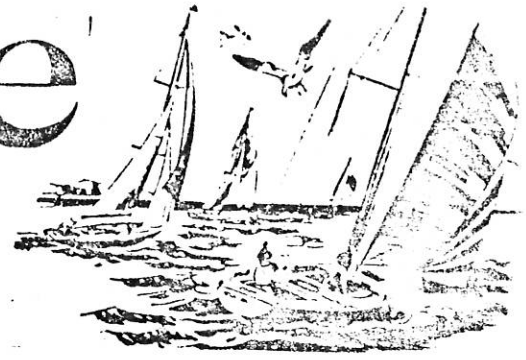

FIRE ALERT

The recent rash of area fires caused by illegal fireworks indicates that all of us should be particularly alert and ready to take appropriate action during the July 4th holiday.

The Board has:

Appropriated \$4,000 to hire J. M. Montgomery, Engineer, for a reclaimed water feasibility study
On the Manager's recommendation, directed him to invest surplus funds in high interest rate treasury bills.
Accordingly, \$160,000 has been invested at the rate of 17½%.
Received the Nominating Committee's report from Jim Paul, Chairman. The candidates for the two directors' posts to be filled are: Ken Knight, Joe Schaefer, Lois Songer, and Ed Tisch. They will be presented at the July monthly meeting.
Set the date for the Annual Meeting as August 19, and designated Betty Rolapp as Chairperson of the Elections Committee.
Adopted revised rules and regulations governing vehicle decals, key cards, and passes.
Expressed its appreciation to volunteers who were involved in the issuance of key cards.
Heard Bernie Svalstad explain the upcoming Municipal Advisory Council election and urge its adoption.
Directed the Manager to write letters to three homeowners, informing them that they are in violation of the CC&R's because of the colors which they have painted their homes.
Rejected the claim of a guest who stated that two tires were ruined as he exited the community.

Dear Residents:

I'd like to take this opportunity to thank Dave Ohrn, Chairman of the Security Committee, and those dedicated members who gave considerable time in the last few weeks in assisting the staff in issuing the new key cards to the community. Without naming names, my personal "Thank you".

The new security company has been with us for about two weeks and we have received many favorable comments about the service. The change in security companies was the first step in improving the security at Niguel Shores. In the next few weeks and months, my staff and I will work closely with ABCO Security Company to establish procedures and policies which will accomplish our goals.

The Board of Directors and the Architectural Control Committee cooperated in devising a Solar Energy policy, which was adopted at the regular meeting of the Board on June 2, 1981. The guidelines are included elsewhere in this newsletter. If you are thinking about installing a solar energy device, be sure to contact the Architectural Control Committee.

A word about recreation and Community Center activities:

It is now summer, and the pool is open until 10:00 p.m. We want all members and their guests to enjoy the facilities. We must remind you, however, that the staff will be strictly enforcing the Center rules which require that guests be either accompanied by a member or tenant, or be registered as a guest at the Association office by the tenant or member. All persons using the facilities must sign in when entering the Center. Periodic checking of sign-ins will require that you be prepared to provide proper identification to preclude any inconvenience to your and/or your guest.

Water Conservation

Free water conservation kits can save big energy dollars for homeowners.

Saving water saves energy and money. Residents in Orange County can save over \$47 yearly by installing just one flow restrictor in your present showerhead. This figure includes \$28 in gas savings and \$19 water savings, based on three 6-minute showers per day. And you can start saving this money now.

The California Department of Water Resources has already mailed to you a free water conservation kit. This is part of a vital campaign to cut water waste and water usage in Orange County. But why is the state undertaking this campaign? We haven't had a dry winter, so there's plenty of water, right?

Wrong. Even in years with lots of rain, we never have local water to fill our needs and, in fact, must import large amounts of water. The elaborate, costly water supply network that collects, transports, cleans and delivers our water takes energy to operate. Lots and lots of increasingly costly energy. And these high energy costs don't end once the water flows into each home. More energy is then used to heat that water.

How do these simple devices reduce your expenses? The most important device is the shower flow restrictor, easily installed in the shower head. By reducing the surge of water that gushes from the shower -- and wastes lots of expensive hot water -- water and money are saved. And your family will get just as good a shower as before.

The simple toilet tank water bag is installed in a few minutes and can typically save 1,200 gallons of water per person per year. In addition, the dye tablets in the kit that check for toilet leaks can potentially save the 73,000 gallons that a leaking toilet wastes annually.

Your big saving is on water-heating energy. But reducing general water usage by the 10 percent a year that will occur by installing these kits can also cut down on your general water bill. And water and energy will become much more expensive in future years.

There's another reason to install these devices. It won't directly save you money, but it's why the State has undertaken this campaign. We take the rain for granted, but we won't always get what we need. We have to save water now for a possibly dry tomorrow.

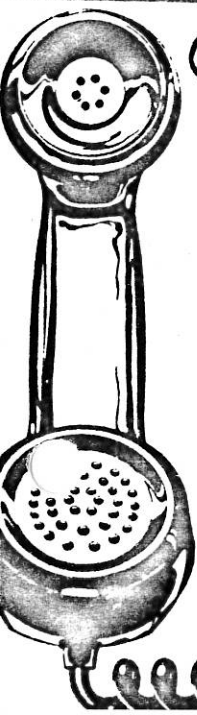


SOLAR ENERGY GUIDELINES

It is the intent of the N.S.C.A. to assist its members in designing the installation of solar energy facilities which will fulfill the requirements of applicable statutes, while retaining, to the extent feasible, the attractive appearance of the community. In achieving this objective, each member of the N.S.C.A. will be asked to be considerate of his neighbors and to cooperate in this joint venture.

Individuals contemplating solar energy systems are reminded that an application must be submitted to the Architectural Review Committee for approval, as is required for any exterior building modification. During its review of the plans, the committee will take into consideration the appearance of the installation and its effect on neighbor's views. The contractor will be asked to attend a committee meeting with the applicant to discuss any details or recommended changes with the committee. Committee members will also be in a position to discuss the economics of solar energy with members and perhaps provide insight not volunteered by the salesmen. The entire review and approval process will be carried out with statutory requirements in mind, but cooperation will be an essential ingredient if Niguel Shores is to remain the attractive community its members desire.

CHANGE IN ADMINISTRATIVE OFFICE HOURS

Effective July 1, 1981, the administrative office will be open from 9:00 a.m. to 5:30 p.m., Monday through Friday, for all business related transactions, and will continue to be closed on weekends and holidays. This 30-minute change in office hours has been made to balance the administrative work flow and staff working hours, and should cause no inconvenience to the members.

The office will remain open for use of the recreational facilities and equipment and will still be overseen by the office aides from 5:30 to closing (9:00 p.m. during winter months and 10:00 p.m. during the summer) weekdays, and from 9:00 a.m. to closing on weekends and holidays.

EXTENSION OF QUARTERLY/SERVICE PASSES

The Board of Directors has recently adopted revised policies and procedures for issuance of decals and passes, which will be put into effect during the next month. In the meantime, quarterly passes and service passes due to expire June 30, will be automatically extended through the month of July, unless notification is received from the authorizing owner/resident to cancel the pass. Owners and residents are requested to notify guests and service personnel that the passes need not be renewed prior to August 1.

Sea Terrace II

Beginning July 1, the regular assessment for Sea Terrace II moves from a quarterly to an annual payment basis. All homeowners have been billed for \$244 which carries them for the full year through June 30, 1982. This assessment is in addition to the regular Niguel Shores Association's quarterly assessment. It is primarily used to cover the cost of fire and liability insurance and outside maintenance of the buildings, including painting. Homeowners with questions about this assessment are invited to contact any member of the Sea Terrace Board.

Sea Terrace II homeowners with pets are requested not to leave uneaten food outside overnight. This is because food left out attracts skunks, with the obvious unpleasant results.

LAGUNA NIGUEL COMMUNITY ASSOCIATION

The Laguna Niguel Community Association is sponsoring the formation of a Municipal Advisory Council (MAC) for Laguna Niguel. The MAC would be similar to the MAC in Mission Viejo.

The Mac is an advisory body to the Board of Supervisors, State agencies and other governmental institutions concerning local matters such as planning, health and safety. The council members would be elected on the same ballot as our County, State and Federal representatives. The MAC offers several advantages to Laguna Niguel and Niguel Shores:

1. A formally elected Council sanctioned by State law would provide a much stronger voice in speaking in behalf of the interests of Laguna Niguel before the County and the Coastal Commission and with area developers.
2. A Council elected under Registrar of Voter auspices would provide greater identity to our beautiful community and perhaps provide a more "hometown" feeling.
3. A MAC would establish boundaries for our community and better protect our community from territorial incursions from surrounding jurisdictions.
4. A MAC would eliminate any confusion between the fourteen homeowner associations such as the Niguel Shores Association and the current Laguna Niguel Community Association.
5. A MAC cannot under State law lead to any increase in taxes.

Currently, the Community Association is distributing petitions which will lead to the MAC formation question being placed on the November 1981 ballot. All registered voters will have a chance then to decide if a MAC is right for Laguna Niguel. PROTECT YOUR PET

A resident of Dosinia Drive reported that she was awakened at 4:00 a.m. the end of last month to find two coyotes in her backyard mauling her pet cat. She went outside with her dog hoping to scare the coyotes away, but they instead started to come toward her.

The Animal Control says that due to the grading, hot weather and possibly wildlife having young ones that food and water may not be readily available to them, so they are coming into our community. When coyotes are hungry, they will attack.

For your own protection and your pets', please be alert and keep your animals inside during the night.

RECYCLING PROGRAM

Most of you supporters of our recycling program are already aware that the new storage shed has been completed. The building was ready for use on Thursday, May 28 and it was full to overflowing by the following Monday when our first paper pickup was made. Again, the shed was overflowing by the following Monday but pickup was not made until Thursday, June 11. The following are the weights collected during the first 14 days:

We realize that the rapid collection of paper was merely the result of two months buildup in garages, etc., and that future collections will probably come more slowly, but our community can be proud of this patriotic support by our residents.

The shed will be open from 9:00 a.m. to 9:00 p.m. each day and residents may deliver their accumulation of paper, consisting of newspaper, magazines, brochures, telephone books and junk mail during those hours. Sorry, the recycler cannot take cut up cartons. The paper must be contained in some way - either in grocery bags, tied with string or in cartons. No loose paper, please.

Aluminum recycling will continue as before, but again we ask that beverage cans be flattened so that they not take up so much room.

Over our entire recycling experience, we have collected 576 tons of paper, equivalent to a forest of 9,792 trees normally cut down to produce that amount of paper.

Aluminum amounts to 3,732 pounds, approximately 70,900 beverage cans. This much recycled aluminum will generate about 67,400 NEW CANS.

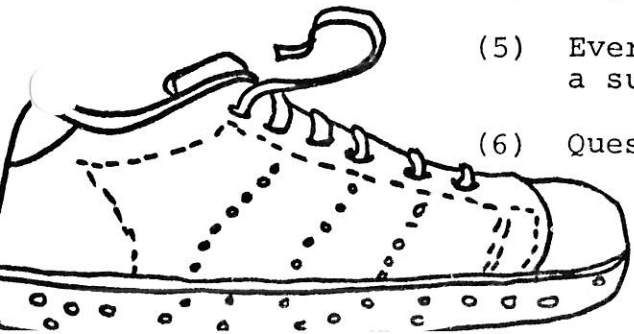

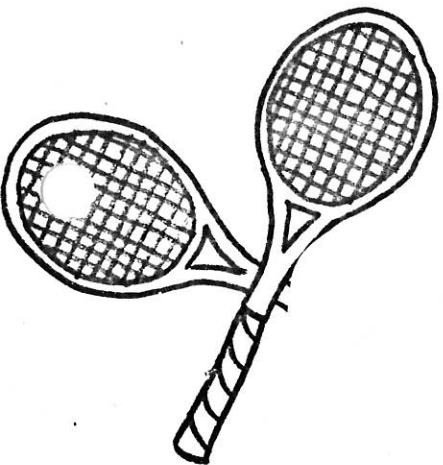
MEN'S TENNIS LADDER

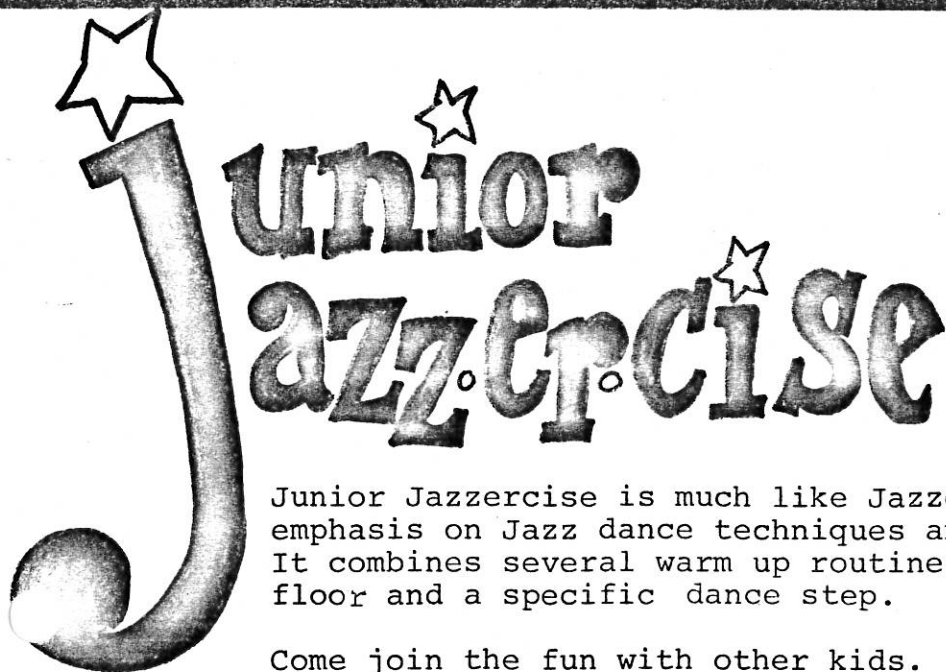


LADIES DAY TENNIS

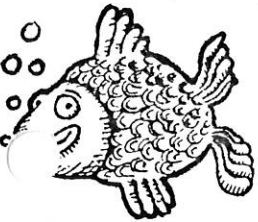

SHORES GATE

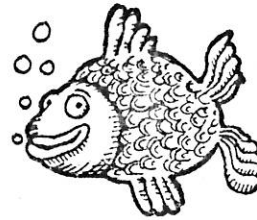

SWIMMING POOL RULES

Summer is just underway, and we are already having problems at the pool.

Pool Rule #12 provides that hair which touches the shoulders when wet must either be tied back or contained in a bathing cap while the individual is in the pool or pool area. Many swimmers are ignoring this rule, with the result that the pool drain and filtering system are clogged and need costly cleaning and repair.

Swimmers who violate Rule #12 will be instructed to leave the pool area until their hair is contained as required. Please bring a rubber band or bathing cap if hair is at the maximum length or longer. Rubber bands will not be provided at the Association office.

PEPSI COLA NBA HOTSHOT BASKETBALL SKILLS CONTL

Pepsi Cola/NBA Hotshot, a national recreation program for community youth organizations, now enters its sixth year. It is the largest program of its kind, involving more than 1,300 youth athletic groups and close to 2.5 million youngsters. It is open to boys and girls, ages 9-18. There are six categories of competition; three for boys and three for girls.

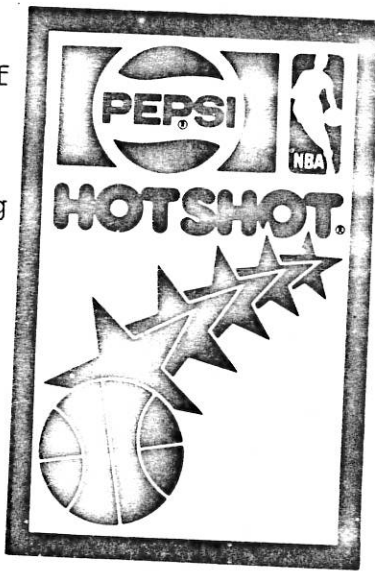
Hotshot is a form of athletic competition based on a one-minute display of basketball skills. Winners from local youth organizations participate in area playoff in 23 NBA cities. Area winners then go on to represent NBA teams in national competition.

Despite its competitive aspects, Hotshot is a game that every youngster can play and enjoy, no matter what his or her level of skill. Awards are given to all participants and at all levels of competition.

You have one minute to dribble from half court into the shooting range. Shoot from the hotspots in any sequence you prefer or shoot lay-ups. You will only receive scores for two lay-ups. All other shots must be made from any or all five hotspots marker on the court. If you choose to shoot from all five hotspots, you'll get bonus points. One point is subtracted for each infraction, walking, palming, or double-dribbling.

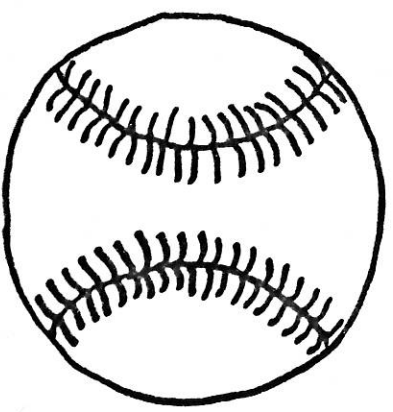

DANGEROUS FIREWORKS

Last year during the Fireworks Season the Orange County Fire Department responded to 93 fires and 17 injuries related to fireworks. The majority of these fires and injuries were attributed to dangerous fireworks.

WHAT ARE DANGEROUS FIREWORKS ?

Dangerous fireworks include cherry bombs, firecrackers, bottle rockets, sky rockets, M-80's and others. Dangerous fireworks should not be confused with fireworks classified by the State Fire Marshal as Safe and Sane which bear the State Fire Marshal's seal on each package.

If you have fireworks without the State Fire Marshal's Safe and Sane seal and they have not been purchased at a fireworks stand, they are dangerous fireworks and illegal.

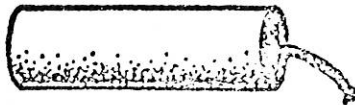


Any person who manufactures, uses, possesses, stores or offers for sale dangerous fireworks is in violation of the law. A person who causes injuries or damage with fireworks may be held criminally and civilly liable for damages.

PARENTS SHOULD NOTE THAT THEY MAY BE HELD LIABLE FOR DAMAGE CAUSED BY THEIR CHILDREN USING FIREWORKS.

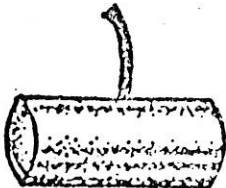

ORANGE COUNTY FIRE DEPARTMENT DO'S AND DON'TS FOR FIREWORKS

DO'S

1. ALWAYS READ THE INSTRUCTIONS AND WARNING LABELS THAT ACCOMPANY FIREWORKS.
2. USE FIREWORKS ONLY WITH ADULT SUPERVISION.
3. HAVE A BUCKET OF WATER HANDY TO PUT USED FIREWORKS IN.
4. KEEP FIREWORKS OUT OF THE REACH OF SMALL CHILDREN.
5. MOVE A SAFE DISTANCE AWAY AFTER LIGHTING FIREWORKS.
6. STAY AWAY FROM SMALL CHILDREN WITH LIGHTED FIREWORKS.

DON'TS

1. NEVER LIGHT FIREWORKS IN THE HOUSE, GARAGE, PLAYHOUSE OR ANY OTHER BUILDING.
2. DON'T IGNITE FIREWORKS IN OR AROUND ANYTHING THAT WILL BURN ESPECIALLY DRY GRASS AND VACANT FIELDS.
3. NEVER PLACE LIGHTED FIREWORKS IN CANS, BOTTLES OR OTHER CONTAINERS.
4. NEVER THROW SPARKLERS OR ANY FIREWORKS.
5. DON'T GO NEAR FIREWORKS THAT HAVE BEEN LIT, BUT HAVE NOT GONE OFF. DOUSE WITH WATER, LET THEM SIT FOR A REASONABLE PERIOD OF TIME, THEN CAREFULLY PUT THEM IN A BUCKET OF WATER. USE A SHOVEL, NOT YOUR HANDS.
6. IF YOU SEE A FIRE STARTED BY FIREWORKS, DON'T PANIC. REMOVE ALL PEOPLE FROM THE AREA AND CALL THE FIRE DEPARTMENT.

REMEMBER

ALL FIREWORKS MUST BE REGISTERED WITH THE STATE FIRE MARSHAL.
EACH PIECE OR PACKAGE MUST BEAR THIS SEAL.

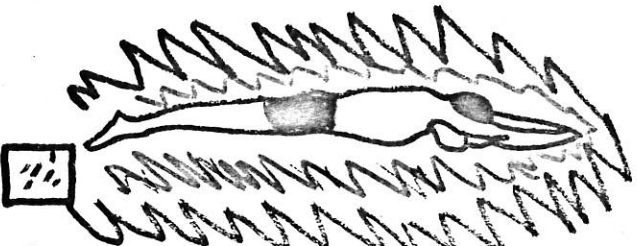



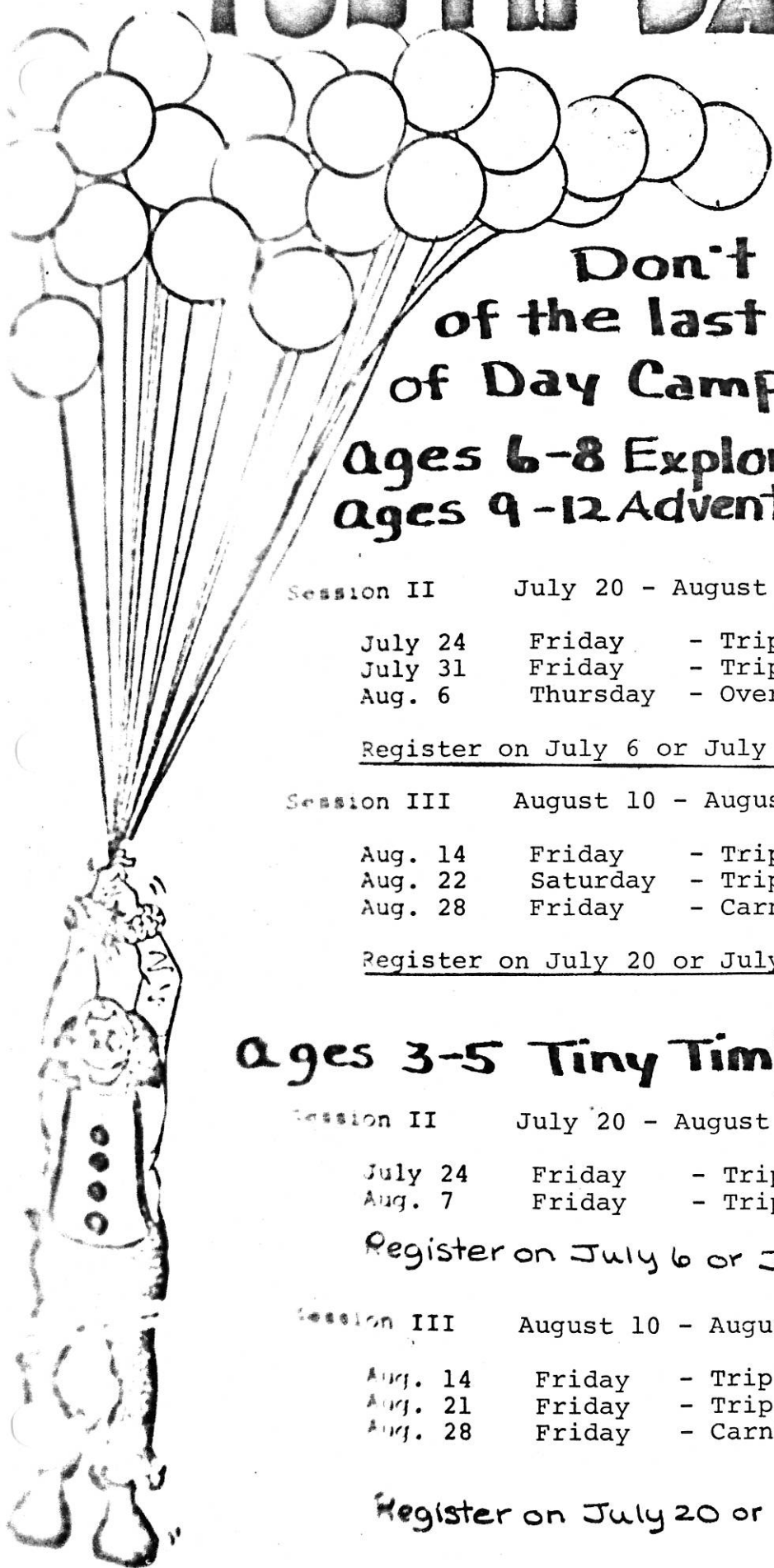
MICROWAVE ORANGE SPIRITED CARROTS

4 medium-sized carrots, slivered
1/3 cup Vodka
1 tsp. sugar
1 tbls. grated orange peel
1/4 cup butter or margarine

1. In a deep, 1-1/2 quart, heat resistant, non-metallic casserole, place slivered carrots and Vodka. Sprinkle sugar and grated orange peel over carrots. Dot with 1/4 cup butter or margarine.
2. Heat covered, in microwave oven 10 to 12 minutes or until carrots reach desired degree of tenderness. Stir occasionally.

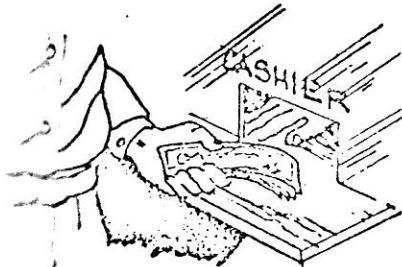
