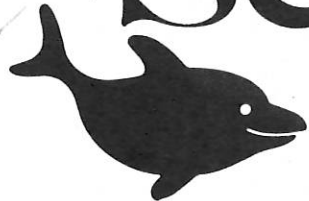

VANDALISM COSTS EVERYONE!

The Board of Directors has requested that homeowners be kept informed as to how much is being spent for vandalism repairs. During the month of May, the Association had spent approximately \$166.25 for replacement of broken gate arms and damaged glass.

Help the Association stop vandalism! There is a reward for individuals who provide information leading to the arrest and conviction of anyone who vandalizes the association's property. (Rule 9401).

HOME SECURITY

Most of you are aware that the Shores experienced a number of break-ins this spring. We are now in the summer months and this type of activity will be on the increase.

It is very important that residents make provisions for their own home security! The Association does not provide this service. The patrol service enforces the Association's rules and watches the common area for vandals. Please refer to Article X, Section F as to the Association's duties in this regard.

Listed below are excerpts from a booklet published by the State that discusses what to do when you are away on vacation or a prolonged absence:

1. Notify the Sheriff's Department of the dates you will be gone.
2. Lock all doors, windows and the garage door. Merely having an automatic door opener mechanism is not sufficient on the garage door.
3. Cancel all regular deliveries to your home, such as newspapers, milk, etc.
4. Have mail held at the post office or forwarded.
5. Use automatic timers for lights and radio. Have them go on and off at different times of day/night.
6. Arrange to have yard work done in your absence.
7. Do not advertise your absence to just anyone. Ask a trusted friend/neighbor to regularly check the home.
8. Have a list of valuables, listing a full description and serial numbers. Also list the cost of these items. Put list in a very safe place.

MECHANICAL GATES - WHY THE TEETH WERE DISCONNECTED

There are several rumors floating about as to why the teeth to the gates have been disconnected. The Board of Directors would like to explain their reasons for this.

During the last several years, the Association has had to pay claims for damages to tires. There have been various reasons why individuals have driven over the spikes; usually they claim the gate malfunctioned. In any event, the Board has been compelled to reimburse the documented claims. Currently, the General Manager has approximately \$2000.00 in claims that the Board is reviewing.

There has been discussion for several months as to how the Board could limit its responsibility for these claims, yet maintain the ability to control vehicle traffic. It was suggested that the Board have the maintenance staff disconnect the spikes for a trial period of 90 days. The Board accepted this recommendation and has set the trial period to end after Labor Day.

The Board is monitoring this situation closely. In the first 30 day period, three (3) gates had been vandalized, with vehicle entry gained in two of these situations.

Be assured that the Board is very concerned with this situation and is attempting to find a way to balance the costs associated with the mechanical gates and to keep unauthorized vehicles from entering.

The Board would like to thank residents for their understanding while they work on this problem.

In using our entrances and exits, please use caution and be alert to any changes in the systems.

COYOTE ALERT!

Residents should be aware that there have been daytime sightings of coyotes in our community. We have confirmed one attack on a cat in mid-June.

Experts advise that coyotes shy away from people. However, they have become more aggressive in the last few years.

You are requested not to keep food and water outside for your pets. You should consider keeping your pets inside at night. Keep a close eye on small children who are outside and playing.

USE OF JACUZZI

Residents are reminded that only individuals over 18 years of age can use the jacuzzi. There is no exception to this rule and proof of age may be required. Minors are precluded from using the jacuzzi for health reasons.

Another problem that is starting to appear is after hours use of the Community Center. Using the pool and jacuzzi after 10 pm is not allowed. Individuals found using these areas are subject to arrest as trespassers and can additionally be fined by the Board of Directors.

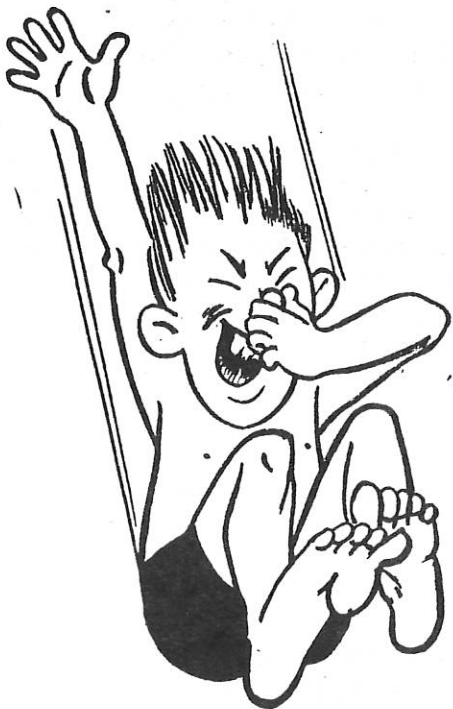
SUMMER LIFEGUARD SCHEDULE

The Association will have a lifeguard on duty, Monday through Sunday, from 10 am to 8 pm. It is hoped that this schedule will begin on July 1 and be carried through to September 4.

Parents are reminded that any minor under age 14 cannot use the pool area without an adult present from your household. The only exception to this rule is when a staff lifeguard is on duty. Children who have passed the swim test given by a staff lifeguard and have a signed release statement can use the pool without an adult present. We do encourage parents to always come to the pool with their minor children!

The swim test/release exception applies only to the minor who has passed the test. It does not allow guests to accompany the minor. All guests must be with an adult resident or they will be asked to leave the center.

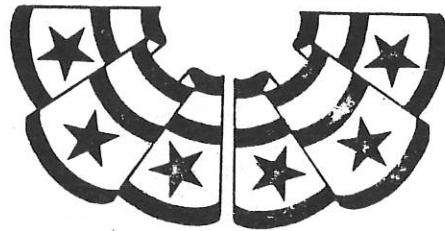
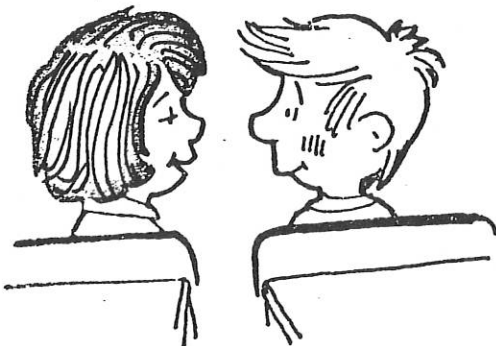
NEW - BOOK DISCUSSION GROUP

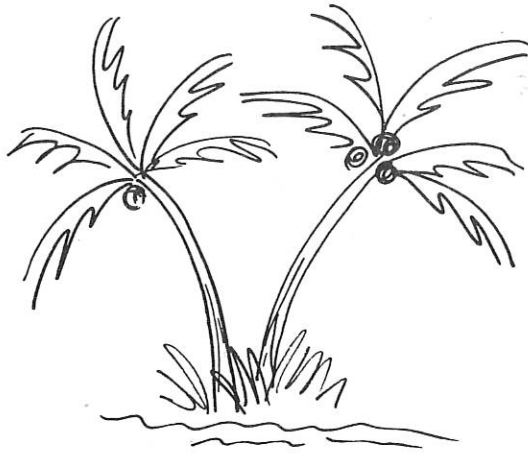

3145 Painting (06-19-91)

1. Approval must be obtained from the Committee for painting/staining or repainting/restaining, including fences, walls, planters, etc. Color chips must be provided with the submittal. Color choices are to be designated for each area of the house to be painted/stained; for example, stucco walls, wood siding, garage door, garage door trim (if any), fascia board and/or underside of eaves, window trim, doors, patio or house overhangs and posts.

2. Garden Homes (Tracts 6782, 8038, 6883, 7302, 7573).

A. Colors are to harmonize with the existing slumpstone.

B. Fascia board color must be the same on all four sides of house/garage, including side of house at the lot line.

3. Broadmoor Homes (Tract 6935). All exterior walls and trim are to be painted the same color scheme at the same time.

4. Villas (Tract 9098).

Stucco: All four house and garage walls and all walls except exterior (side and/or rear) walls. Choice of following Dunn Edwards (or equivalent) colors:

60 Navajo White	407 White Sands
14 Baja White	06-51P Milkweed
70 Pearl White	514 Bone China
427 Bone White	

Exterior (Side and/or Rear Walls): All exterior walls (those facing street or common areas) to be painted Dunn Edwards 427 Bone White.

Trim: Dunn Edwards 79 Norfolk Brown (or equivalent); or approved house color; or color selected by homeowner for approval.

Preparation: All vines must be removed prior to painting.

Note: When approval request received, Architectural Control Committee will consult on-site with homeowner and specify painting requirements for property.

Colors as provided blend and have been selected to maintain a harmonious appearance in the tract. Color chips are on file in the NSCA office for review.

5. Gutters, metal flashing and vents (pipes) on top of roofs to be painted to blend with house.

6. Repainting/restaining shall be accomplished within ninety (90) days after approval.

3146 Private Parking Areas (04-04-90)

Existing open parking spaces on private property shall not be reduced to less than the space necessary to park two automobiles.

3150 General Regulations (04-16-86)

Regulations relating to the utilization of existing structures are shown in Rules 3151-3159.

3151 Exterior Antennas (04-16-86)

Exterior antennas of any kind are not permitted.

3152 Basketball Backboards (03-20-91)

A. Only one backboard permitted per residence.

B. Backboards must be solidly constructed and board and hoop firmly affixed to garage or other portion of house.

C. Backboards, including target stripe, must be completely painted or stained to match background structure, and must be neatly maintained and painted when necessary.

3153 Flag Poles (03-20-91)

A. Flag pole brackets may be positioned on house at owner's discretion.

B. Free standing flag poles must be submitted for approval, with diagram showing location and height of pole.

C. Free standing flag poles must not constitute a view blockage either from the standpoint of height, location of pole or size of flag.

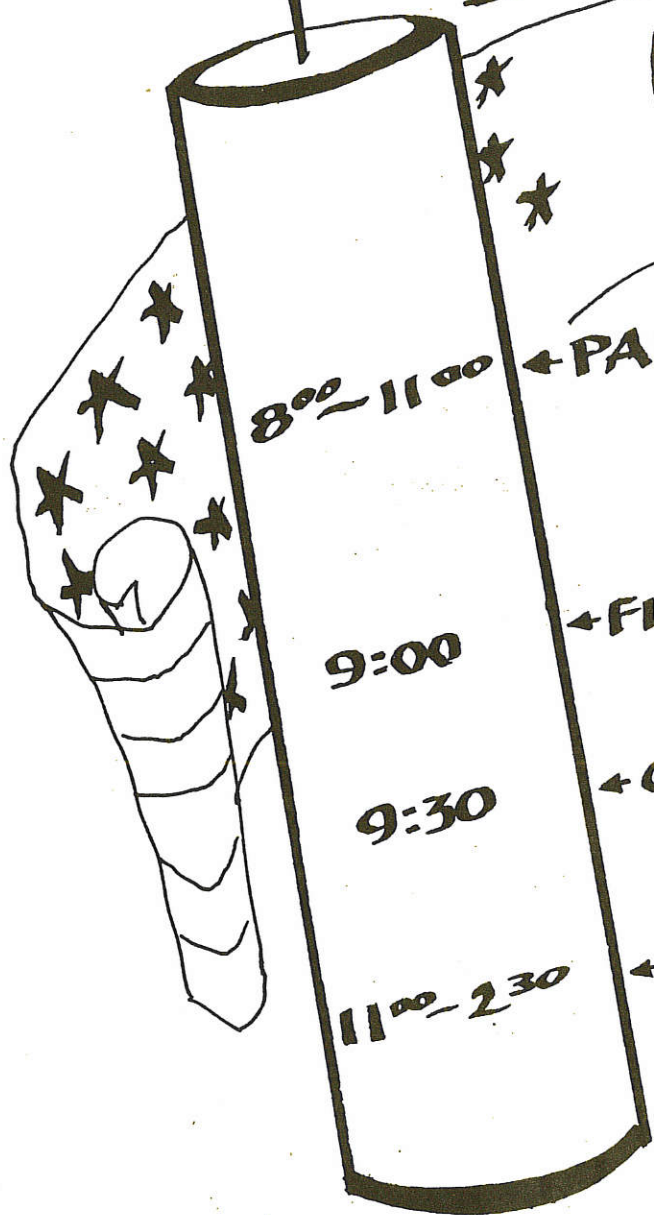
3154 Garages (04-16-86)

A. All required garage spaces shall be fully enclosed and garage doors shall be kept closed except when in use.

B. Garages shall not be converted into living quarters, sleeping quarters, offices, or other similar use.





