RE: ANNUAL MEETING AND ELECTION - AUGUST 18, 1976

Dear Member:

On July 13 last your President, Mr. Robert Risteen, wrote you concerning your Annual Election to be held at 7:30 p.m. on August 18, 1976. There is a great need for your help in voting, either by attending the meeting or by proxy so that we have a quorum.

You have been sent an official Notice of Meeting, a combined Designation of Voter, Proxy and Ballot, Resumes of the candidates nominated by your Nomination Committee, and a return envelope for your proxy in the event you cannot attend the meeting in person (which we sincerely hope you can do).

The Declaration of Covenants, Conditions and Restrictions of Niguel Shores provides that only one person may exercise the vote of a lot and requires that co-owners of a lot designate which of them is to exercise the vote. For instance, if a husband and wife own their home as community property, or as joint tenants, they must designate which of them is to be the designated voter. We have therefore combined a Designation of Voter form with a Proxy for use at the Annual Meeting. At the top of the form all owners should execute the designation of voter portion indicating which of them is exercising the vote of granting the proxy. The designated voter should then be the person to execute the proxy at the bottom of the form.

If you plan to attend the Annual Meeting personally you should still return the Designation of Voter form so that you will be qualified to vote at the meeting.

The voting is for the election of three Directors for the terms of two years. You are entitled to cast a total of three votes for each lot owned or proxy held. You may cast:

- 1. All votes for one candidate, OR
- 2. One vote for each of the three candidates,
- 3. Two votes for any one candidate and one vote for another candidate.

The total votes cast for all candidates cannot exceed three (3) per lot owned or proxy held, otherwise your ballot will be void. Cast your vote by writing the number of votes for a specific candidate in the square opposite the candidate's name.

If voting by proxy, please carefully complete the form, designating one of the five Directors or, if you desire, write in the name and address of another homeowner who has agreed to attend the Annual Meeting and is a designated voter as your proxy holder. Also write in the name of your choice among nominated candidates for Director, or, if you desire, write in the name of a candidate of your choice; date and sign the form, complete with your address, and deliver it either to your designated proxy holder or to the Recreation Center Office, or return it in an envelope.

Your Board urges you to vote either in person or by proxy as a quorum is necessary to conduct an election.

# BATHING YOUR DOG CAN BE FUN AND HEALTHY

Before bathing a dog, it should be thoroughly checked for fleas or granular "flea dirt", mats should be removed, and the animal preliminary brushed out. The hair should be plucked from the ears of Poodle or Terrier type dogs and mineral oil or vaseline should be placed in the animals eyes to shed off soapy water. Cotton balls should be placed in each ear to prevent moist ear infections as a result of soapy water.

To prevent frightening an animal, apply the water to the animal rather than submerging the animal. Wet the animal down well, then shampoo with a mild shampoo (i.e., baby shampoo or mycodex), as necessary. Rinse the animal well; a nozzle spray works best, being careful to cleanse the underside throughly of soap. Then use a dip to prevent the fleas from coming back. The dip should be used once a week. Let the dip dry on the animal. Do not rinse it off. Brushing while drying will increase drying rate. Groom and comb copletely when dry.

Remember, there is no bath that can substitute for frequent, routine brushing and combing. Don't wait for a skin problem to appear before bathing or grooming as it will not always stop the itching or chewing. If wounds are present, consult your veterinarian. Your animals appearance reflects your personal care.


