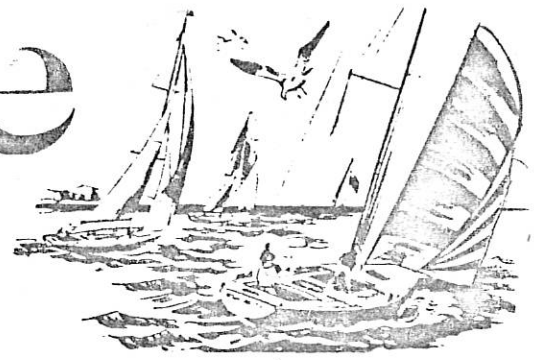

FROM THE HELM

Board Election -- Important Notice

Instructions have been mailed to all homeowners. Read the directions carefully. Send in your proxy immediately if you do not intend to attend the Annual Meeting.

The Board has agreed to the following:

"After full consideration of the alternatives, the Board of Directors endorses the formation of an Assessment District for the purpose of providing reclaimed water for irrigation of all the common and landscape easement areas within the Association. This endorsement is based upon the premise that the South Coast Water District will provide all property owners with detailed information regarding the formation of the district and the cost involved, and will hold public hearings on the matter."

Other Items:

1. At a meeting held on July 26 between the Board, Ad Hoc CSD Committee and concerned citizens, the Board passed a motion to; "Withdraw its sponsorship of the CSD application, thereby disbanding the Ad Hoc Committee, and expressing appreciation for the efforts of the Committee." The motion passed on a four to one vote.
2. Recent vandalism involving street and parking lot signs has elicited the reminder that there is a standing reward offer of up to \$100 for information leading to the conviction of, or restitution by, anyone guilty of wilfully damaging association property.
3. See the Manager's Report, this issue, regarding illegal parking and tow-aways.

Comment:

I appreciate having had the opportunity to work with other members of the Board, Staff, and committees during the last three years. It has been a memorable and rewarding experience. Our system of governance is sometimes frustrating, but an amazing amount of work does get done thanks to the dedication, cooperation and abilities of homeowner volunteers, management and staff. A NEWS RELEASE FROM THE POSTMASTER, LAGUNA BEACH



"Dog bite injuries are becoming a serious problem with the Postal Service so local Postmasters are taking several measures to fight back.

Postmaster David Rios has instructed his letter carriers that if an unrestrained animal threatens their safety at a particular residence, that they should not risk injury by attempting to make a delivery. Letters have also gone out warning customers of dog problems.

If the situation persists, the Postmaster can require the resident to move his mailbox to the curb or cut off home mail delivery.

In addition, under a new program started in January, 1981, the Postal Service, or its employees, is filing suit to recover medical costs, salaries, and damages for injuries caused by a third party. In the majority of cases filed, the injury is usually a dog bite.

In three recent cases in Southern California, claims resulted in settlements for over \$24,000.

With the summer months approaching, the Postmaster is concerned that the problem can worsen. Postal officials note that dog attacks usually increase in the warmer months as a result of more doors being open, more pets outside and children home from school.

Last year, the Postal Service reports that about 7,800 letter carriers were attacked and injured by dogs, nation-wide. One incident, in the San Bernardino area, resulted in a fatality. Officials estimate the annual cost of bites at around \$2.4 million.

The Postmaster urges pet owners to:

- 1) recognize that they are responsible for controlling their pet,
- 2) teach each family member what they can do to prevent dog bites,
- 3) let your carrier know you are taking action to protect him or her against bites, and
- 4) keep your pet leashed, fenced or confined."

If you take "fido" for a walk, take along a "pooper-scooper". Do not permit your dog to run loose - keep him in your yard or on a leash; almost all dogs bark but a little is enough. Please try to control the "noise" created by your pet(s). Remember the Orange County "Leash Law" has been adopted by your Association and incorporated into your rules and regulations and enforcement is being pursued.

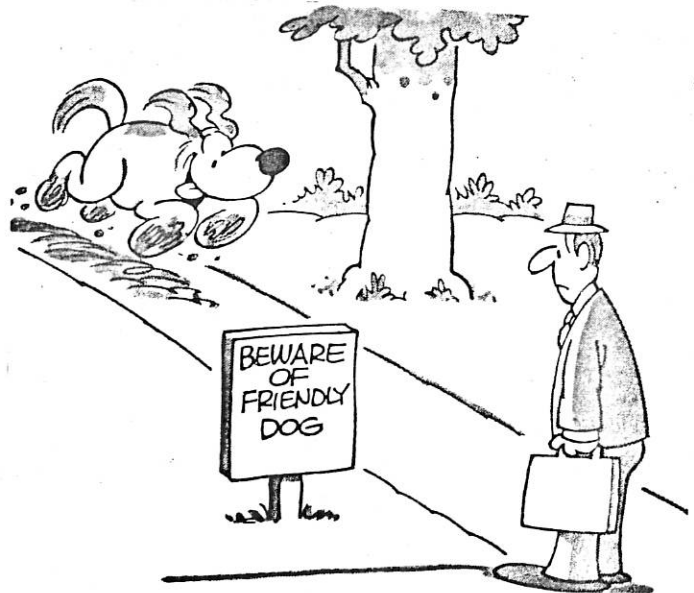
Selling your car? Moving out of Niguel Shores?

A WORD ABOUT GUESTS

Many members have complained about the number of guests parking in the beach parking lot in areas reserved for residents only.

It has become evident to both Management and Security that many residents are authorizing admittance of guests, and allowing these same guests to use the beach facilities without the resident's supervision, and without advising the guest of the beach parking restrictions.

Residents should remember that they are responsible for the conduct of guests, and by extending an "open door" policy to any and every one, a burden is placed upon the facilities and staff, and the convenience and pleasure of other residents is greatly inhibited.

All members and residents are urged to respect the rights of other residents, and to instruct guests specifically that parking in the lower two levels is reserved for members and residents only, all guest vehicles must be decaled or bear a current day pass, and all guest vehicles must be parked in designated parking spaces.

NOTE: Keep your "No-Call" lists up to date. Security is being directed to make spot-checks on entries of non-decal vehicles to the community.

CANDIDATES FOR THE N.S.C.A. BOARD OF DIRECTORS

Candidates for the Board were invited to submit statements for publication in the Seashore News. As of presstime, five statements were received. They are printed below, four of them reprints from the July issue.

PEGGY PHILLIPS BUCCI - 23861 Bothnia Bay

Peggy Phillips Bucci has been a professional writer and public relations specialist for 40 years. She was Director of Publicity for Center Theatre Group in Los Angeles' Music Center's Mark Taper Forum and Ahmanson Theatres, as well as Director of Publicity for the L.A. Civic Light Opera in the Dorothy Chandler Pavilion. She has been a publicist for theatre, films and related performing arts in New York, England and California. A produced Broadway playwright, she is also a film and television writer with credits on most of the major network TV shows, including several years as chief writer for the ROBIN HOOD series in England, and head writer for NBC-TV's DAYS OF OUR LIVES.

Her government experience includes five years serving the City of Los Angeles as Public Relations Director, first for the L.A. Public Library System; and then for the Municipal Arts Department, working closely with all facets of municipal government including the Mayor's Office and the City Council.

Her community experience in Niguel Shores includes service on three committees; Communications, Tennis and Recreation.

PERSONAL STATEMENT: "An informed community is a strong and effective force for action. If elected, I pledge to keep this community informed on every major issue that concerns us all".

TOM KIRBY - 33482 Dosinia Drive

My name is Tom Kirby. I am 38 years old and have been a resident of Niguel Shores for 9 years. I live on Dosinia Drive with my wife and two children, ages 5 and 10.

I am employed by Bushard's Pharmacy in Laguna Beach as Pharmacy Manager. Subsequent to graduation from the University of Southern California School of Pharmacy, I was self-employed for 8 years. I spent 3 years in commercial real estate after selling my business. I am currently a member of the Board of Governors of the Laguna Niguel Racquet Club, having been so for 3 years.

My reasons for seeking a Board seat are these:

- I am deeply concerned with the manner in which the County is implementing inclusionary housing.
- I would like to see our Community Center returned to family atmosphere eliminating costly "over-security" measures.
- I believe that instead of considering concepts like a Community Services District, we should find places to cut the cost of running the Association.
- I am strongly in favor of reclaimed water to maintain common areas.

CANDIDATE STATEMENTS, continued

HOWARD T. MAGWOOD - 23852 Casandra Bay

I am retired. I was formerly president of Rose-Magwood Productions, a film and TV company with offices in New York, London, Chicago, Toronto and Hollywood. I have been a resident of Niguel Shores just over two years. Previously, I served on the Board of Directors of the Whitley Heights Home Owners Association in Los Angeles, and before that served as president of the Greenhaven Home Owners Association in Rye, New York. It seems to me that the Niguel Shores Community Association is very well managed by its paid staff and the current Board of Directors. I would certainly suggest no drastic changes.

Comments on current issues:

- 1) CSD? I feel it is a good idea, but see no need to rush it through before a thorough investigation has been completed.
 - 2) Reclaimed water is an excellent idea. We must find out what are the costs?
 - 3) Affordable housing? It is the law, so I am in favor of it. However placing this housing on prime property at the beach, nowhere near the areas of employment, is totally inept. I'm against this project.
 - 4) CC&R's must be enforced. If the homeowners wish to change them, it should be done by legal means.

BURR B. MC KEEHAN - 14 Breakers Isle

I, Burr McKeehan, am 39 years old, the father of three children, and have been a resident of Niguel Shores for eleven years as well as a Laguna Hills' podiatrist, specializing in foot surgery, for twelve years. I have been an active member of the community as a participant in local church affairs, a doctor serving on the staff of three local hospitals, a participant on the Laguna Niguel Chamber of Commerce, a member of El Niguel Country Club, a coach for AYSO and Youth Baseball, a member of the review committee for Salt Creek Hotel development, specifically as it related to view blockage and traffic hazard for Shores' residents, and, finally on the Concerned Citizens for Local Land Use Committee (Selva-West Affordable Housing Project) concentrating on the density factor, the schools' overcrowding and the effect on property value and how all these factors affect us as Shores' residents.

I will work for beautification of our community, pride in our development, strict enforcement of the CC&R's and swift reprisals for those not in compliance. I favor reclaimed water for irrigation if it can be proved economically beneficial to Shores' residents.

In conclusion, I hope to make this a better place to live.

DAVID S. PARRETT - 33535 Moonsail Drive

Dave Parrett will provide knowledge and experience in several fields.

For the last eleven years he has been a Business, commercial and industrial real estate salesman and broker. He has appeared on zoning and other matters before Planning Commissions and Boards.

During the preceding twenty years Dave rose to responsible positions in both general management and accounting/finance. As a General Manager he coordinated such functions as purchasing, engineering, quality control, manufacturing, etc. As a Controller he was in charge of corporate borrowing, billing, accounting, payroll, etc. He has utilized his legal education, J.D., in business.

Dave has served his political party as a Precinct Committeeman and as County Finance Chairman. He has helped his church as a member of the Governing Board and as Treasurer. He has served the Sea Terrace I Townhomes as Treasurer and Niguel Shores, first as a Legal Committee member, now its Chairman, and on various other committees. 3. *REMINDER: Class fees are payable in advance, by check. Stamped receipts are required on the first day of instruction.*

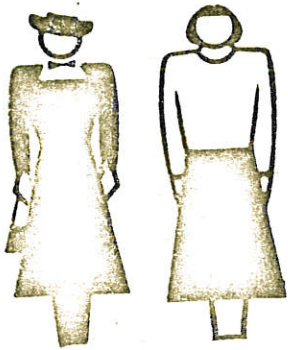
