FROM THE HELM

July became a banner month for all Niguel Shores residents! I'm happy to announce that plans have been approved for the complete refurbishment of the Multi-Purpose Room -- all of it, meeting room, kitchen and conference room.

There are many people responsible for bringing this plan to fruition. First, the committee under Dottie Foth's chairmanship for their planning. Many long hours were spent in interviews with potential suppliers, selecting the schematic, securing bids and ultimately presenting their plan to the Board.

Second, the Men's Club who, with the Board's encouragement, heard the presentation and voted to allocate the balance of funds from the Paper Salvage account expressly for this purpose.

Thanks are given to Russ Paslaqua for his many years of service in managing the paper salvage program, raising approximately \$80,000 which was used exclusively for the benefit of Niguel Shores residents.

It is hoped that work will commence in September and be complete by the holidays.

There are several pedestrian items to bring up, too:

- 1) The word "security" is a misnomer when applied to the Shores. We have patrol officers and gate guards who monitor for common area rule and CC&R violations, but they are not law enforcement officers. Any semblance of criminal activity should be reported to the sheriff and an incident report provided the Niguel Shores office.
- 2) Please re-read your instructions from Solag relative to placement to containers and what can and cannot be collected. Overloaded bins, plastic bags and/or cartons will not be picked up.
- 3) Our good neighbor to the North -- the Ritz-Carlton -- has advised us that a number of residents are walking their dogs through the hotel grounds, using the space as a depository. More seriously, we are told that there have been instances where animal wasted is thrown over the wall onto their property. Please read the additional article on this subject and adhere to the county and local ordinances applicable to Animal Control. We urge you to comply, within the Shores and without.

Finally, let me thank those who wrote directly to me in July. Although its not always possible for me to respond in writing, your letters are seriously considered. Whenever possible, avail yourself of the Homeowner's Request form in the office; it's a quick, succinct way to communicate with both Board and Management.

JUNE BOARD ACTIONS

- 1. Appointed Bobbe Kahn to the Architectural Control Committee and Dick Luedeke to Recreation Committee.
- 2. Appointed Rick Foth as Co-Chairperson of the Maintenance Committee.
- 3. Approved reimbursement for damage to homeowner's driveway from common area tree roots. Also, approved repair to next door neighbor's driveway for damage from same tree roots.
- 4. Accepted bids from Brongo Construction for repair of Selva slope in Sea Terrace II and installation of gravel drainage pits at end of Breakers Isle, on down slope of Cabrillo Isle.
- 5. Approved special request from homeowner's to allow minor son & therapist to use jacuzzi one hour per week. Approval was granted because of medical condition.
- 6. Voted to give George Williams and Jack Broering a two-year term on the Board and Don Beaver received the one-year term.
- 7. Waived a late charge on a homeowner's assessment payment because of extenuating circumstances.
- 8. Authorized Management to have three large eucalyptus trees removed because they are damaging the Selva wall. Board directed Management to discuss this with Landscape Committee, and if they concur, have the trees removed in July.
- 9. Accepted a change in the approach with the investment of reserve funds, as recommended by Finance Committee. A laddering approach will be used.

JULY BOARD ACTIONS

- 1. Appointed Dick Luedeke as chairperson of the Recreation Committee.
- 2. Appointed Jo Turner to the Tree View Blockage Committee.
- 3. Accepted bid for \$610 to remove three eucalyptus trees in the area of the Selva wall across from Flying Jib.
- 4. Turned down the written request from a homeowner to waive rule 2714 C because two key cards were in vehicle that was stolen. Homeowner felt he should not have to pay \$25 per item for replacement.
- 5. Authorized the Tree View Blockage Committee to investigate all common area complaints from residents for tree or shrub blockages(see article).
- 6. Turned down the written request from a homeowner to waive two quarters late charges involving quarterly assessments.
- 7. Authorized management to allocate another \$1200 from contingency funds to pay for the plantings around the boulders in the Sea Terrace I greenbelts.
- 8. Accepted resignation of Sharon Stewart from the Community Relations Committee.
- 9. Accepted resignation of Lynn Dawson as the NSCA representative to the Monarch Beach Civic Association and appointed Steve Stewart as her replacement.
- 10. Appointed Ed Black to the Finance Committee.
- 11. Authorized management to have two 25 MPH paint stencils added to Niguel Shores Drive, north of Mariner and south of the Mariner intersection. The Traffic and Safety Committee made the request for the stencils.

- Authorized a policy change when dealing 12. with homeowners who have been cited by the Tree View Blockage Committee for violation of Rules 4112 and 4113. The violator will be sent a first letter giving them 30 days in which to comply or appeal to the Committee. If nothing happens, the second letter will be a hearing letter before the Board of Directors for the purposes of deciding if a fine of \$100 will be assessed. The ability to fine is included in the governing documents. If there is still no compliance after the levy of a fine, the matter will be referred to the Association's attorney for legal action.
- 13. Authorized the refurbishment of the Multi-Purpose Room, with total costs not to exceed \$20,000. The Men's Club Paper Salvage Fund will supply most of the funding, with the Associations reserves funding approximately \$7000 to \$9000 of the costs.

STATUS OF NEW OFFICE COMPUTER SYSTEM

The office staff would like to thank all the homeowners who have cooperated in July while the office was closed. Closing down for several hours each day allowed the staff to concentrate on inputing homeowner and resident information.

Management hopes that by the time this issue of the Seashore News is distributed, the process will be completed. If not, the office will continue to close down Monday through Thursday, 10 am to noon and after 4 pm. Please look for the updated signs at Mariner and Selva gates, along with the community center, for specific dates and times.

LANDSCAPE COMMITTEE UPDATE

Both the office and several committee area representatives have received comments from residents that the impatiens in their common area are not doing well. Not all areas in the community have this problem. However, about one-third of the community has for the last eighteen months.

Wendt Landscaping hired a plant pathologist to investigate. The report stated that our soil contains four fungi. Prior to planting the impatiens last April, Wendt Landscaping applied several chemicals to neutralize the fungi in the soil. This procedure was successful in many areas, but not all.

Discussion is now centering on what to do about the areas that will not allow the color plants to grow properly. It may be that these areas may not receive color plants for at least a year. Allowing the soil to "rest" may help to rid it of the fungi. A perennial plant such as gazania could grow in these areas. This will give the areas some color for most of the year.

The Committee should receive more information in the next one to two months as to the options available. The 1994 budget will be changed accordingly, if necessary.

PROJECTS FOR AUGUST

- 1. Remove the remaining escallonia shrubs on Selva Rd. slope and replace with oleanders that are white and pink.
- 2. Begin removal of the fescue grass on Sea Terrace II interior slope behind Gourami Bay. This slope will be replanted using honeysuckle.
- 3. Rehabilitate section of slope on Windjammer, west of Lateen.
- 4. Continue front yard plant replacement in Sea Terrace I. Management is going street by street until allocated funds are used up. The next street will be Flying Jib.
