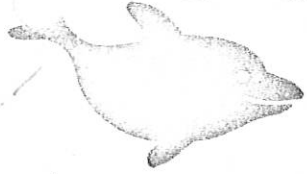

REPORT FROM YOUR BOARD OF DIRECTORS

ANNUAL ELECTION OF DIRECTORS

Highlighting August activities was the annual election of new directors. At the annual Members Meeting on Aug. 15, the necessary quorum (50% of the 960 lots) was not present or represented. As authorized in the By-Laws (Article VI, Section 5), the meeting was duly adjourned until 9 A.M. on August 18, at which meeting the quorum requirement was only 25% of the total lots. James Paul and Frank Taylor were elected.

ASSOCIATION OFFICERS

The Association will continue with a President, who is chief executive and administrative officer, and a Chairman, who is chief policy officer. Phyllis Luengen remains as President, and John Bulleit as Chairman. Carol Sue Mullen, James Paul and Frank Taylor were elected Vice-Presidents. Lois Songer is Secretary, and Bill Bierman is Assistant Secretary. Frank Taylor will serve as Treasurer and Carol Sue Mullen Asst. Treasurer. AUGUST BOARD ACTIONS

Liens and Foreclosures: Properties will be subject to liening when assessment payments become 60 days delinquent, and to foreclosure when 90 days delinquent. This more restrictive policy is necessary to protect the community against loss. Adequate notices are provided delinquent members.

Gate Damage Information Reward: Accepting the Mens' Club offer of \$100 for the purpose, a reward will be offered for information leading to the arrest of anyone convicted of vandalizing and/or wilfully damaging any of the NSCA vehicle gates.

Geotechnical: Converse, our geotechnical consultant, has been authorized to develop remedial recommendations for drainage problems (a) above and below Naticus Isle (b) above Breakers Isle, (c) below the Windjammer slope, at an estimated design cost of \$3,800. No construction authorization has yet been made.

Community Center Improvements: New neon light fixtures were approved for the pool area. The diving board will not be put back in service because of the stress it imparts to the concrete deck. A handrail will be placed on the handicap ramp at the entrance.

County Beach: Effort continues to get the county to repair the slope, fence and lighting alongside the ramp leading to the beach; and to replace the sunken boulders protecting the slope below the Breakers Isle homes. Any individuals wishing to add to this emphasis may write to Kurt Brittain, Supt. of Recreational Facilities and/or Supervisor Thomas Riley.

30 DAYS AFTER IT BECOMES DUE.

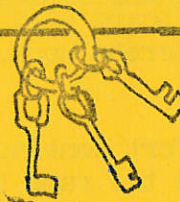

NEWSPAPER AND ALUMINUM RECYCLING PROGRAM

Newspaper pickup days in September will be the 10th and 24th, (second and fourth Mondays). Watch your Seashore News Calendar.

Aluminum is picked up at the container next to the Community Center once each month.

We know that a number of households save their newspapers for their church, school, or even for the bottom of their canary cages, BUT THERE IS NO GOOD REASON FOR PUTTING THEM IN THE TRASH CONTAINERS ON TUESDAYS. Please set your papers aside for the second and fourth Mondays each month. Our recycler truck will pick them up before two P.M. in front of your home if you place them at the curb. Do not tie your papers, simply stack them with a weight on top, or place them in a carton.

Please don't feel offended if your slick paper magazines or telephone books are left. There is simply no way that our recycler can take them as the paper can't be used by the recycle mill. The telephone book pages are fine, but the glued-back binding will not dissolve in the recycling process.

Occasionally the pickup man misses a home, or even a street. We are not all perfect. If this should happen to you, please be assured that they will be welcome on the next pickup day. Don't TRASH them.

Thanks to all our supporters, we are doing great things for the community with these extra funds, and we are supporting our government in its quest for conservation of natural and other resources.

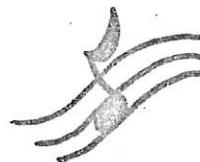

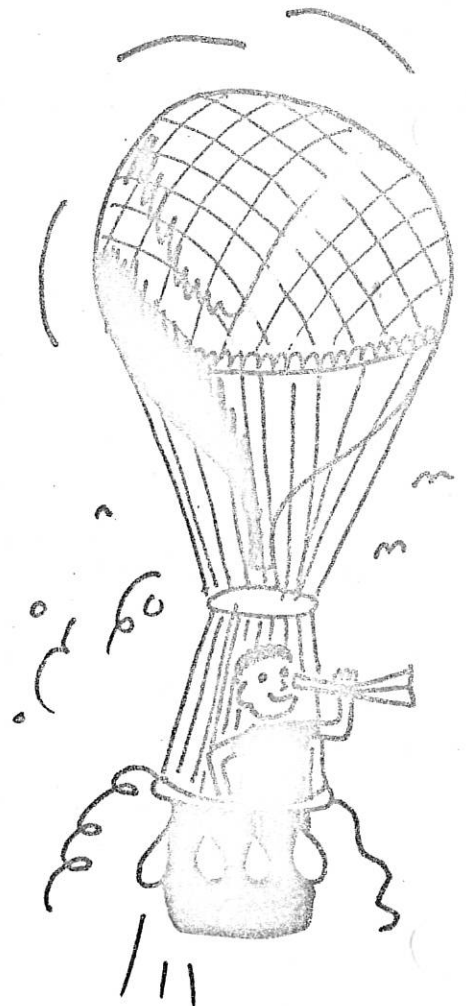

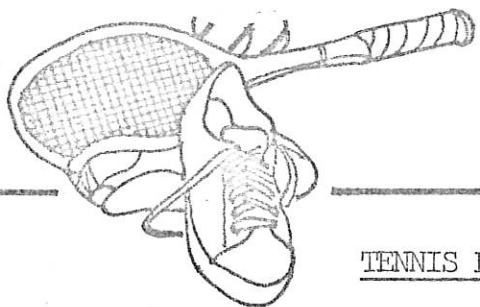
Ladies Day Tennis

SHORES CUISINE

COCA COLA CAKE By Glenna Whitney, Bookkeeper

2 cups flour	1/2 cup buttermilk
2 cups sugar	2 beaten eggs
2 sticks margarine	1 tsp. soda
3 tbsp. cocoa	1 tsp. vanilla
1 cup Coca Cola	1 1/2 cup miniature marshmallows

Combine flour, sugar in large mixing bow. Heat margarine, cocoa and Coca Cola to boiling point and pour over flour and sugar mixture. Mix thoroughly. Add buttermilk, eggs, soda, vanilla and marshmallows. Mix well. This will be a thin batter with marshmallows floating on top. Bake in 13x9x2 pan at 350degrees for about 35 mins.

ICING

1/2 cup margarine	1 lb. box powdered sugar
3 tbsp. cocoa	1 cup nuts, chopped

Combine margarine, cocoa and cola and heat to boiling. Pour in powdered sugar. After beating well, add nuts. Spread over hot cake.
