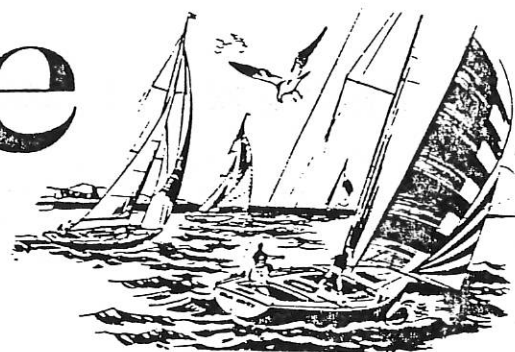
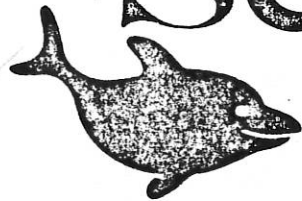

OVERNIGHT PARKING OF RESIDENT VEHICLES

At its meeting of August 15 the Board entertained an open discussion of the proposed rule to limit overnight parking of resident vehicles on the common areas.

The rule came into being as a result of complaints and problems reported to management and to the Traffic and Safety Committee. The rule was drafted in an effort to alleviate parking problems in various areas of Niguel Shores by encouraging residents to use their garages and driveways for vehicle parking.

Several advantages were envisioned as a result of the enforcement of the rule. First, it was felt the rule would aid in the control of vehicular access to the community by creating a device to further control unauthorized vehicle entry into Niguel Shores. Second, the appearance of the community would be enhanced through the decreased number of vehicles being visibly parked. Third, there would be a reduction of neighbor conflicts over street parking.

While the Board has received tremendous support for implementing the rule, several objections were raised at the meeting. First, that the rule would create a logistical problem for individual homeowners with multiple vehicles. Second, that the Association was working to limit individual freedom as a result of the inappropriate actions of specific individuals.

Two suggestions were presented as alternatives. First, to designate specific guest parking spaces. If resident vehicles were found parked in these spaces, they would be subject to citation and tow-away. Second, to deal with the problems on a case-by-case basis rather than a blanket policy or rule.

The Board has tabled further action on this rule pending further input. Those individuals with suggestions and/or recommendations are to submit them in writing to the Association office no later than September 11. The Traffic and Safety Committee, at the instruction of the Board, is to review the suggestions and recommendations and to further discuss alternatives to the proposed rule and make specific recommendations to the Board for consideration at its meeting of September 19.

POSTING OF SIGNS

All residents are reminded that no signs of any kind may be posted anywhere in Niguel Shores on common property. This restriction pertains to all signs, including those referring to lost or missing dogs, cats, or other animals. The only exception is that signs may be posted in designated locations at the community center with the approval of Niguel Shores office personnel.

Our landscaping and maintenance staffs have been instructed to remove and return to the Niguel Shores office all such signs they see posted in the community.

We residents should ask why we have guards when burglaries are on the increase, etc. Nighel Shores should aim for zero crime. If you are concerned, call me.

At last month's Open Board meeting an incident occurred which demonstrates dramatically the tunnel vision with which unfortunately many of our homeowners are afflicted.

The Board had not only taken great pains to describe a problem involving overnight parking in the August Seashore News but had specifically invited those concerned to attend that meeting and air their input. As usual whenever a specific problem hits the individual home, its residents flock to the Rec Center and fill the room to overflowing. That was nothing new.

But the Board, which by the way, has already proved to be one of the most responsive in this community's history, made the mistake of being gracious enough to place this matter first on the agenda. Patiently they listened for over forty-five minutes during which partisans from both sides argued their points. With admirable restraint they still remained civil while apoplectic residents attacked them for what at least one indignant homeowner perceived as an attempt to "ramrod (sic!) this bad rule". Another irate citizen accused the Board of deliberate malice in "making me treat my visiting son like a stranger".

Whatever one thought of the issue, pro or con, the truly outrageous climax was reached when, at the close of discussion, this group of "concerned" residents rose in a body and departed the meeting. They had had their say and displayed no further interest in learning of any other matters affecting the community. It's called the whose-ox-is-gored syndrome. Why care about anything else so long as one's own problems are addressed?

Most of those departing the hall seldom if ever attend Open Board meetings. When they do, it's only to support or attack a specific issue affecting them personally. Our Board is composed of dedicated VOLUNTEERS who selflessly devote their time, energy and efforts to this community. Those who criticize their efforts should

demonstrate their own civic-mindedness by attending Open Board meetings regularly to learn something about this community in which they live and indicate by their attendance at least some small interest in helping to improve our quality of life. Gamblers say it more succinctly -- put up or shut up.

NEIGHBORHOOD WATCH

The recent rash of burglaries and attempted burglaries in our community helps to emphasize the importance of the common sense suggestions that are a part of Neighborhood Watch. These are some of them:

1. Be sure your doors and windows are kept locked whether you are away or at home.
2. Be sure you have dead bolt locks on exterior doors and windows. For windows a hole drilled through the window casing and into the window frame to accommodate a small screw or cut off nail can do the job. This idea will also permit you to lock a window into a partially open position.
3. Be sure to call the Sheriff's Office whenever you see a suspicious person around your home or in the neighborhood. Call 647-7000 if the person is acting suspiciously. Call 911 if the person is entering or attempting to enter your house or a neighbor's house.
4. If you have a burglary or an attempted burglary notify the NSCA office as well as the Sheriff's Office. Your experience may provide some helpful reminders for other Shores residents.

BENVENUTO a ITALIA! This month the Potluckers will visit Italy through the culinary arts and the efforts of the hosts on Sunday night, September 16th.

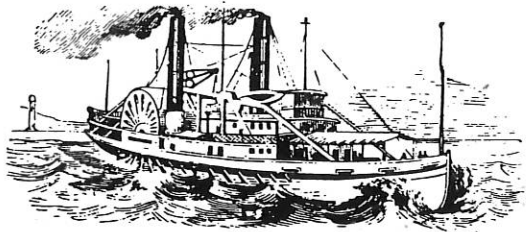

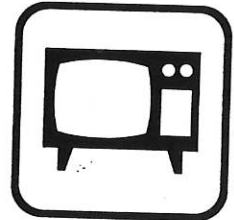


ARTISTS' MEETING

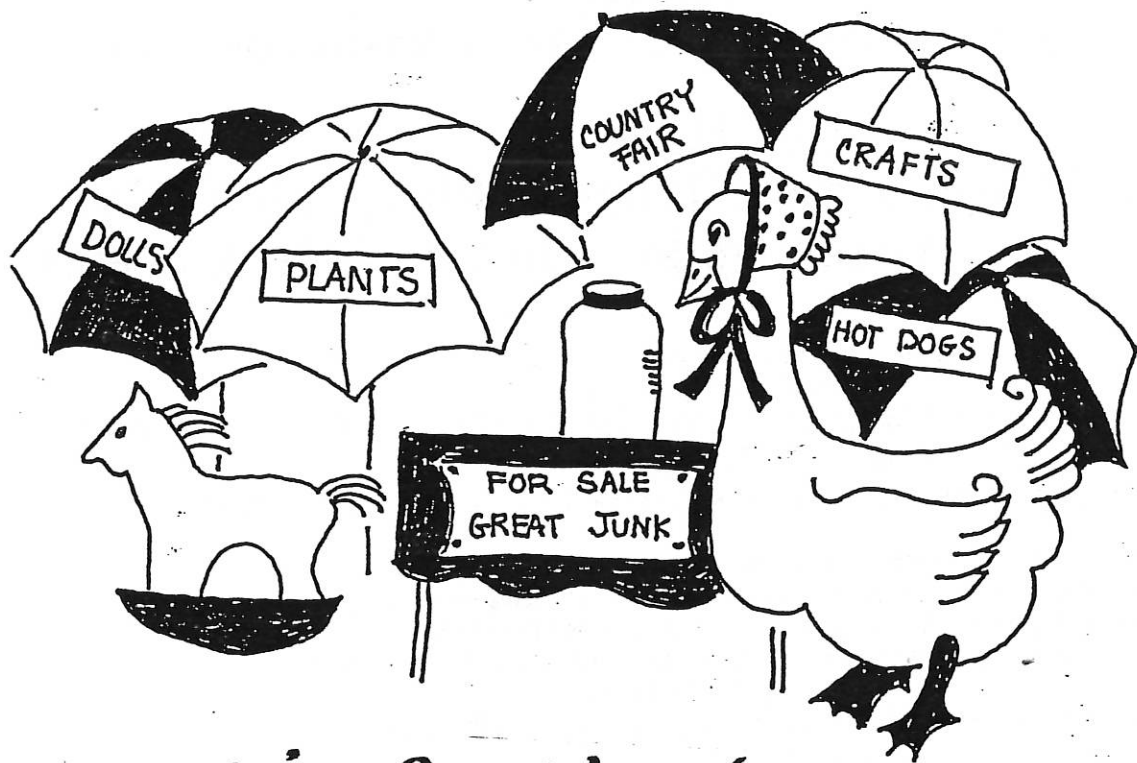

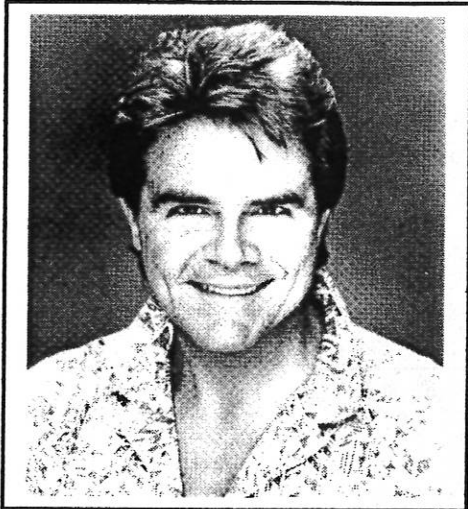
