EXTENSIVE TALL TREE TRIMMING TO OCCUR

Over the next several months, an outside tree trimming company will be working within the Community. In December, some of this work was done along Magellan Isle with the removal of four trees and the removal of several large limbs on remaining trees. Eucalyptus trees on the north side of Niguel Shores Dr. at Leeward should be trimmed by the time this issue is delivered. These trees are on the slope behind the short section of Spinnaker Dr.

During January, it is expected that the eucalyptus trees near Marlinspike and Flying Jib will be trimmed. Many of these trees are along the property line with Monarch Del Mar homeowners association. During March, the eucalyptus grove along Leeward, in Sea Terrace I, will be trimmed. Both of these areas are on a three-year trimming schedule.

The Board has received the recommendations from the Landscape Committee on how to address the eucalyptus trees at PCH and Selva Rd., along PCH and PCH and Ritz Carlton Dr. The Board has not acted upon the recommendations but should in January. The general plan calls for the removal of some trees and the trimming of the remaining ones. The Landscape Committee recommends that the remaining trees be put on a trimming schedule of every other year to every three Once the Board acts on the vears. Committee's recommendations, staff will publish more details. It is also expected that homeowners affected by the removals will be notified by letter before the work commences.

One last area involves Mariner Dr. The Landscape Committee has decided to have Wendt Landscape remove several eucalyptus trees that are behind the pine trees that line Mariner Dr. They are scattered along a large turf area and the Committee believes they serve no purpose. It is expected the trees will be removed in the middle of January.

EMPLOYEE CHANGES CONTINUE

There have been many staff changes over the last four months. Jeanette Federico has left as our full-time Administrative Assistant. She has decided working from her home and caring for her son is better for her family. Lee Evans has been hired to fill the opening and will start on January 6. Lee has experience in the homeowner association field having worked for an off-site management company. It will take Lee three to four months to learn the Shores way of doing things, and we ask for residents to be patient with her. Julie White will continue as our part-time Administrative Assistant, working mornings.

Chris Pierce, our part-time Afterschool Recreation Director, has left to pursue full-time employment. Staff is looking for a replacement so that the after-school program may resume the middle of January.

Changes have also occurred in the Maintenance Department. As of early November, full staffing returned when Chris Webber rejoined the staff. He damaged his knee during the summer and had to have surgery. A vacancy also occurred on the staff, and David Reinhardt was hired to fill it.

With the many staff changes in the last several months, some projects have fallen behind. We hope to be able to catch up during the winter months before the busy summer season starts.

BOARD ACTIONS



- ✓ Accepted bid from LaBelle Marvin to perform asphalt study of streets in the Villas/Sea Terrace II in preparation for major asphalt repairs. Cost of the study is not to exceed \$4,950, without authorization.
- ✓ Authorized the Tai Chi class to use the MPR on Saturday mornings from 11/23/96 to 1/11/97, from 9:30am to 11am.
- ✓ Appointed Forrest Owen to represent the Association on Monarch Beach Civic Association.
- ✓ Decided the Board will meet on Wednesday, January 8, 1997 at 11:30am for their first Board meeting in January.
- ✓ Accepted Pat Long's resignation from the Traffic and Safety Committee.
- ✓ Appointed Jerry Moon as Chairperson of the Traffic and Safety Committee.
- ✓ Authorized staff to purchase another HP laser printer at a cost of \$429 plus tax.
- Authorized staff to reimburse a homeowner \$1,000 for blockage in the home's sewer line from tree roots. Staff verified that an old eucalyptus tree had invaded the line which was within the front yard easement area the Association was responsible to maintain.
- ✓ Authorized staff to reimburse another homeowner, up to \$1,000, for blockage to the home's sewer line provided staff is present when the line is unearthed and can verify the problem is the Association's responsibility.

NEW HOMEOWNER VEHICLE DECALS TO BE ISSUED

Staff is currently awaiting receipt of the new vehicle decals that will be used in 1997. They will be sending letters advising homeowners of the new decal and asking that vehicles be brought to the Community Center for office personnel to remove and replace the decal. The new decal is blue and white, the same size and appearance as the current one.

Staff will be distributing the new decal during January, February and March. During this period, the existing vellow decal will be accepted for entry. However, there will come a time this spring when the yellow decal will no longer be accepted. There will be an article in the Seashore News advising of the cut-off date and posters will be displayed at several gates.

COMMUNITY CENTER TO BE REPAINTED

Many residents are aware that the Community Center has been undergoing major repairs in the last year. The buildings have received new roof covers. Beams and posts supporting the patio walkway roof have been replaced along with its cover. The large doors to the MPR were also replaced. In the coming months, the office entry door will be replaced and possibly widened for easier entry.

Many are aware that the Community Center is in need of painting. This work may have already started by the time this issue of the Seashore News is delivered. Both the stucco and wood trim will be repainted. Residents are asked to be careful walking around the Community Center while this work is in progress. The wood trim will remain Dunn Edwards "Bone White," and the stucco will be painted Dunn Edwards "Badger."



This is a good time for trimming Christmas trees and all other trees which have grown tall during our extended growing season and which now may interfere with the cherished views of our dear neighbors.

Take a look at the trees and shrubs in your garden and see whether they exceed the height of the adjacent roof line or extend more than three feet above the top of your back slope. Also, those trees/shrubs in a view corridor between homes may also require attention if they exceed fence height (6 feet).

Those who in the past have received a notice of complaint from the office about trees or shrubs blocking views, use this season to insure that those trees are pruned back early to avoid the necessity of receiving another complaint. It's much more comfortable doing the job at your convenience now than facing a deadline later.

Your neighbors and the Tree View Blockage Committee will thank you from the bottom of their hearts.


Don works as an insurance broker and enjoys golf. He attended Dartmouth College in Hanover, NH; Betty chose the University of Colorado in Boulder.

Many questions have been asked about the El Camino Real Bell which is located just outside the Multi-Purpose Room at our Recreation Center. This bell was donated to Niguel Shores by Dale and Helen Baltimore and family November 25, 1995.

This bell is one of 450 that were placed at each Mission and every mile along the El Camino Real (The King's Highway) between San Diego and Sonoma. highway began as just a footpath in 1769 by the Franciscans and the missions were established through the influence of Fr. Junipero Serra.

The idea of placing the bell as a marker came about in 1906. That is when the first bell was placed in Los Angeles in front of the Plaza Church where it still stands today. Our bell was erected in 1913 by the L.A. County Board of Supervisors. It is one of many which no doubt had to give way to "progress and growth."

The missions, the El Camino Highway and Father Serra and the bells are a large part of our California heritage. They are studied by all 4th graders in our schools.
