FROM THE HELM

In recent action, the Board has:

- Authorized purchase of two \$100,000 90 day certificates of deposit at an interest rate of 17.75%: one from Monarch Bank and one from Security Pacific Bank.
- Approved expenditure \$2000 for repair of the Selva fence.
- Decided unanimously to ask standing committee members and chairpersons to continue to serve the community.
- Appointed Nancy Taylor, chairperson of the Communication Committee.
- Reappointed Ed Tisch, chairman of the Architectural Control Committee.

 Also appointed D.G. Anderson and J.K. Anderson to the committee.
- Raised the salaries of our bookkeeper, Keith Lavery, and the administrative assistant, Francie Werner.
- Appointed Lois Songer, Board liaison member to the Security Committee.
- Directed management to obtain cost estimates for tennis court fence extension.
- Received and unanimously declined an offer of settlement from counsel representing Sea Terrace II in its suit against the Niguel Shores Community Association. Trial date has been set for September 28, 1981.
- Received reports relative to vandalism to community toilets and gate card readers.
- <u>Discussed</u> our reward policy, under which monetary rewards are given persons providing information relative to vandalism and/or destruction of community property.
- Heard a request from the manager that he be provided with guidelines and peer recommendations regarding homeowner complaints relative to maintenance of private property. The Landscape and Maintenance Committee will be asked to make suggestions.
- Discussed an upcoming (Sept. 22) meeting with the South Coast Water District. Purpose: to obtain background information relative to the proposed change to reclaimed water for landscape irrigation. Information obtained will be subject to discussion by the Board and members of the association.
- Agreed with a suggestion from the audience that committee chairpersons, or representatives should be asked to summarize the committee's activities at each open Board meeting. It has been suggested that since budget time is upon us it might be timely if the Finance and Landscape/Maintenance Committees be asked to report briefly on their recommendations at the next meeting.

MANAGER'S COLUMN

Dear Residents:

No Lifeguards on Duty

As of September 14, no lifeguard is on duty at the swimming pool at the Community Center. Therefore, parents are cautioned that an adult must accompany a child of 12 years and under when no lifeguard is on duty. It is important that members impress upon their children the necessity of abiding by rules which have been developed to minimize the safety hazards.

Pool Hours - unauthorized use

The winter hours of operation of the swimming pool now in effect at the Community Center are from 9:00 a.m. to 9:00 p.m.

An important reminder!

Use of the pool or jacuzzi by anyone after 9:00 p.m. is not authorized. Those who see fit to enter the Community Center enclosure, jacuzzi or pool areas except during normal hours of operation may be subject to trespass charges.

One of the most serious problems or hazards we can face with a Community like this is "unauthorized use" of the swimming pool, as swimming in an unattended pool is literally a "life and death" situation where one slip or a foolish act may cause a drowning.

Rewards

Members are reminded that a reward is offered for information leading to the arrest and conviction of anyone vandalizing and/or willfully destroying property in Niguel Shores Community Association. The same reward will be given for information leading to apprehension of persons who make full restitution for any such destruction.

Quarterly Passes - Security

Certain changes in security procedures have recently been approved by the Board of Directors and will be explained in up-coming newsletters. The procedures are anticipated to be effective January 1932. In the meantime, quarterly passes will be reissued effective October 1. Tenants and others using the quarterly passes should be aware that their current passes will expire September 30. These passes should be enewed before October 12.

The September 19 Niguel Shores Steak Burn was a success. The bank and food were enjoyed by all who attended. Indications are that all went off without a hitch. Congratulations to the Recreation Committee!

RECOMMENDATION: A "NO" VOTE ON MAC

The Niguel Shores Men's Club, by unanimous vote at its September 29 breakfast meeting, urges that residents vote "NO" on the proposal for a Municipal Advisory Council (MAC) which appears on the November 3 ballot.

Our study committee, composed of well-qualified homeowners, has spent many hours exploring the pros and cons, and in meetings with County officials. Its conclusions, enthusiastically approved by the Men's Club, are that a MAC is not in the best interests of Laguna Niguel residents, either individually or collectively.

A MAC is not in our best interests for the following reasons:

- There is little indication that a MAC would provide broader land planning and advisory authority than presently exists. Both LNCA and MAC are solely advisory. Neither is a legal entity possessing governmental powers.
- 2. A MAC would require administrative expense, possibly \$10,000 to \$25,000 annually. This sum would come from County Service Area #3 (of which we are a part), and would represent a diversion of these funds from purposes for which they are presently being utilized.
- 3. The needs and concerns of Niguel Shores, as a coastal community, are often at variance with inland residents. Our interests would likely be at variance with inland residents on ever growing use by others of beaches in the area (as well as our parking lot), on ever growing use by inlanders of Pacific Coast Highway rather than creating arterials so as to relieve the heavy traffic flow, and on the location of low cost housing, which is more compatible economically to inland housing and, thereby, better situated inland than close to the ocean.

The Men's Club Committee will be meeting with the NSCA Board in pursuit of a different political structure (an independent Community Service District) which offers potential for decreasing our NSCA homeowner assessments and providing Federal tax deductions for individuals.

We urge that you vote on November 3, and that you vote "NO" on MAC. We also urge that you contact your neighbors to enlist their votes. Copies of this bulletin are available at the Center for your use in canvassing your neighborhood.


ARCHITECTURAL CONTROL COMMITTEE

Homeowners in Niguel Shores have undertaken an obligation to abide by the rules of the Association. These rules, as they pertain to the Architectural Control Committee, include obtaining approval for any modification to the exterior of their homes (including color changes). Applications are available at the Association office during normal business hours. They are reviewed by the Consulting Architect to the Committee for consideration by the Committee at their regular meetings on the first and third Wednesday of each month. (Submittals to be reviewed must be in the Association office at least three (3) business days prior to the meeting date).



It is a further obligation to take care of vegetation growing on the property of each Homeowner. As a general rule, trees should be trimmed so that they do not exceed roof-top height. Shrubs should be maintained at wall or fence-top height so as not to impair the views and light of neighbors. Leaves, limbs and other debris should be removed promptly to eliminate fire hazard and breeding grounds for rodents and termites.

Questions regarding these basic rules should not be made orally but in writing so that the entire committee can hear the problem, if any, and then a considered reply will be made in writing. Complaint forms for matters coming under the responsibility of the Architectural Committee are available in the Association office. Again, oral complaints will not be acted upon.

GREAG ALL ADOUG IS?

"PEAR BLIGHT PROBLEM"

As your Landscape Contractor, I have had several people in our community ask me about the problems and the poor appearance of most of our evergreen pear trees. Let me say a little bit about this problem and what we are attempting to do about it.

Pear blight, fire blight, or simply blight is a bacterial disease which this year has been worse than in the past. It affects plants in the Rose Family (Rosaceae). We see it mostly on our pears, but it can also affect Pyracantha, Loguat and others in this family. It usually does not cause the loss of a mature tree. We have not lost any pear trees to this desease. It is favored by temperatures of 70° to 85° and high humidity. The bacteria is spread by bees, flies, ants and splashing rain. What we see on the tree is a sudden wilting, followed by shriveling and blackening of the ends of tender shoots.

Control may be attempted by two methods. The first method is to spray each tree with a copper containing or streptomycin spray before 10% bloom and repeated at 4 to 5 day intervals until late bloom is over. This may mean as many as 12 applications for each tree per season. The trees will not all bloom at the same time which complicates the matter. Effectiveness will not be 100% but some control will occur. We have found that spraying is not a cost effective method of treatment for our area.



The other method of control is pruning out the diseased material approximately 18" below the infested area. After each cut, the tools must be sterilized with a disinfectant such as a 5 to 10% solution of Lysolor bleach. Normally this is done near the end of the growing season. We will begin this type of pruning very shortly.



RECYCLING PROGRAM

The Niguel Shores recycling program is operating efficiently, with regular paper pick-up by Dalton Enterprises, and delivery of aluminium to D & J Recyclers whenever the bin is full.

The first papter pick-up from our storage shed occurred June 1 and for the three month period 6/1 - 8/31 we recycled over 135.000 lbs (67.5 tons) for a total of \$904. Over the same period, approximately 600 lb of aluminium brought us \$196.00. Expenditures since our last report are:

\$99.40 for two armchairs at the Community Center for use by handicapped persons; \$75.14 for paint and supplies for repair and replacement of damaged and stolen street signs; \$74.20 for wooden signs for newspaper shed; and \$335.13 for an individual pin on the microphones and audio equipment to be used by the Board of Directors at public meetings.

CASH ON HAND - \$5159,57

Our Association maintenance staff has been monitoring the paper and aluminium storage areas and have asked that our residents use more care in stacking papers in the shed. Bundles and boxes should be stacked as high as possible, and always stacked as far to the rear as possible.

Aluminium should be delivered in <u>plastic</u> bags if possible. Loose aluminium should be dumped into the trash can placed beside the large wooden aluminium storage box. Aluminium is now handled by loading plastic bags filled with aluminium onto a pick-up truck and delivering to the recycler. Our last sale of aluminium brought \$.41 per pound, or more than 2c per beverage can. Now, more than ever, it is very profitable for us to recycle our aluminium.

However, we have been asked to <u>discontinue saving aluminium foil</u>. It seems that the foil is so thin that when heated to melting temperatures, it turns into ash and is undesired by the aluminium recyclers.

One last appeal - please crush beverage cans to save space - both in storage and also delivery. Keep saving your aluminium pie and cake containers, T.V. dinner plates, etc. They are all wanted.

A casual glance at the Community trash placed at our curbs on Tuesday shows that lots of paper and aluminium are not reaching our storage area. Those residents who are not now participating in our program can help greatly by joining the program. Very little effort is required and immense good results, both to our National Recycling effort and our own community as well.

Thanks again to those dependable supporters who have kept this program going for the past three and a half years. Over that period 632 tons of paper and 4150 lbs of aluminium have been returned to use.

Remember that not only newspaper but all kinds of magazines, phone books, pamphlets and brochures and mountains of junk mail received here are desired for recycling.

- 2. Call your representative (see below), discuss your suggestion and let the representative file your suggestion.





Jean Bulleit and her telephone committee, without whom our luncheons would not have become famous;




COUPLES BRIDGE


The Babysitting Co-op does not provide sitters for the community. We are a group of mothers who trade "sitting" with each other.




