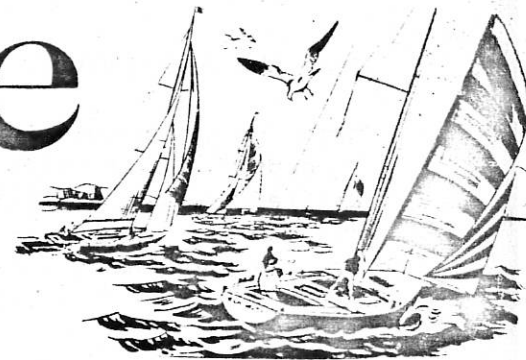

## NEW TACK

For a year or so, this "From the Helm" section of the Seashore News has consisted of a brief summary by the President of Board actions for the preceding month. The editorial staff of the Seashore News has suggested that we tentatively change the format so that this summary would appear elsewhere in the paper, and "From the Helm" would consist of more complete coverage by the President of certain of these Board actions and of other items of interest.

## SEPTEMBER BOARD MEETING

I regret that we had to postpone the September Open Board meeting. However, one week before the date of the September meeting we realized that certain information necessary to support the discussion on the three topics previously announced was not yet available, even though it had been firmly expected by September 1. Rather than disappoint members who would attend the meeting to hear these topics discussed, we chose to postpone the meeting until we had the necessary information in hand.

## BERKUS WATERING

There are 34 slopes in the Berkus tract which have no public access, which are owned by the owner of the pad below, which are not mentioned in the CC&R's as being the responsibility of the Association to irrigate but on which AVCO installed an irrigation system, and which have received free irrigation service by the Association since the tract was opened.

About a year ago a member questioned the authority of the Association to provide this free irrigation service when no legal obligation to do so was in the CC&R's.

We have, over the past year, been collecting information to support a decision to either (1) continue the free watering, (2) continue the service but charge the owners, or (3) discontinue the service.

From the Helm(Cont'd)

Much of the necessary information has been hard to come by. Association records for that period (73-74) are very sketchy, and AVCO records are not available. (AVCO installed the system, apparently promised the service to new owners, had several seats on the Board of Directors, and retained all of the documentation.) However, our attorney has now provided us with reports of interviews with persons involved at the time, with certain agreements which bear on the case, and with related legal rulings.

His report indicates that the facts obtained provide the best support for a decision "to continue to provide irrigation water to the Berkus slopes at Association expense."

The Board adopted this recommendation and is now working on a written policy which will define the service and the conditions under which it is to be rendered.

BY-LAWS REVISION (A copy of this draft is on file in the Association office)

The first draft of the By-Laws revision has been sent to the Legal Committee for review. The changes consist of:

1. Renumbering the sections so that each section number includes the number of the Article. This will permit easier reference and indexing.
2. Deleting references to the Prudential Insurance Co., the Developer, Class A and B memberships and related material which is no longer relevant to our Association.
3. Bringing the wording of certain sections into conformance with the California Corporation Code. Such changes are eliminating cumulative voting for write-in candidates, permitting the Board to act after an original quorum is lost, prohibiting the Board from changing the manner of voting without a vote of the Members.
4. Designating the first meeting of a new Board as an orientation meeting without an election of officers to be followed within 48 hours by a regular meeting at which offices would be elected.
5. Adding a brief description of the standing committees which are not now in the By-Laws (Landscape, Legal, Tree View Blockage, and Security) and of the Board liaison to a committee.
6. Designation of which Vice President acts in the absence of the President.

# SEA TERRACE TOWNEHOMES ASSOCIATION I

## RESULTS OF PAINT SURVEY

The recent survey of exterior paint colors initiated by the Board of Directors of Sea Terrace Townhomes I has been completed. The results are as follows:

138 homeowners out of 239 responded.

65 like the "earth tone" colors now in use.  
60 think some should be discontinued, but others added.  
12 do not like them.

62 like Navajo White. 18 like it but feel its use should be restricted.  
41 do not like Navajo White.

86 would like more light colors.  
6 would like more dark colors.  
13 would like colors other than earth tones.

117 feel the present balancing of colors should be maintained.  
6 believe the colors need not be balanced.

64 feel adjacent buildings should be painted different colors.  
54 feel that adjacent buildings need not be painted different colors.

At the present time the board is developing a new paint policy which will reflect the results of the survey, and is also working with a paint color coordinator to select some new light earth-tone colors to replace some of the darker colors. It is planned, at this time, to increase the total number of colors available from 9 to 12. The eliminated colors will still be available on a continuing basis to owners whose units are presently painted one of those colors.

Owners wishing to change colors will be charged for an extra coat of paint.

## MANAGER'S COLUMN

### BEACH PARKING LOT - CHANGES IN OPERATION:

As announced recently, the Niguel Shores Beach Parking Lot is closed at 10pm each night and reopens again at 6am the next day. During the closure, no parking and no loitering in the parking lot area is permitted. Most members and residents have complied, and we "thank you." Those few who continue to "party" in the parking lot area after closing have received warnings and reminders from the Orange County Sheriff's Department.

EFFECTIVE OCTOBER 1, 1984, NO GUEST PARKING WILL BE PERMITTED IN THE NIGUEL SHORES BEACH PARKING LOT.

Acting on recommendations from the Security Committee and Management, the Board of Directors voted to restrict parking in the Beach Parking Lot only to vehicles displaying member or resident decals. For some time now, the Parking Lot has been an area of security enforcement problems. The elimination of guest parking is seen as a necessary and desirable action to protect and enhance member/resident privileges and reduce security access and control problems. Management and our security force will be making necessary adjustments to enforce this new policy.

California Vehicle Code in Niguel  
Shores.....

A recent administrative search of the Association's early 1970 records, located an Orange County Board of Supervisors' Resolution (76-176) covering enforcement of the California Vehicle Code in our area. Niguel Shores Management has opened discussions with local law enforcement people to determine the extent of assistance the Community can expect from the Sheriff's Department to enforce the Law. As a result of these discussions, we can safely say that the presence of the Sheriff's Officers in the area will be more obvious from now on. Citations for speed violations, expired vehicle license or registrations, unsafe vehicle and motorbike operation, etc. will be issued. Our private security people will continue to specialize in controlled vehicle access and Rule and Regulation enforcement. For those drivers who have heretofore taken advantage of the "private street" aspect of our community to "rip and tear" about the area without fear of penalty, TAKE NOTICE!

Members and residents are asked to be sure that other family members and friends who use the parking facilities and drive autos, motorbikes etc. within Niguel Shores are made aware of these changes.

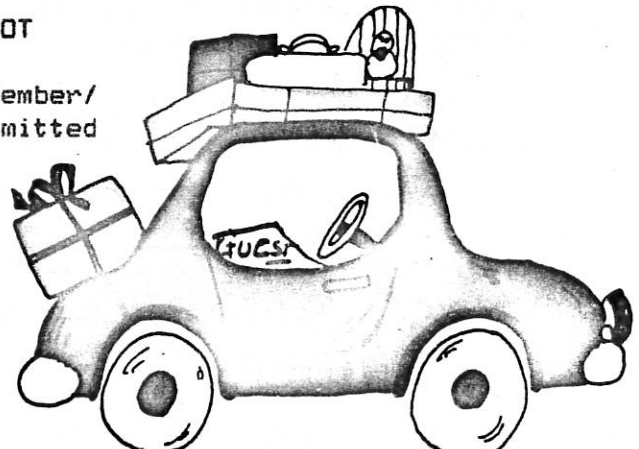

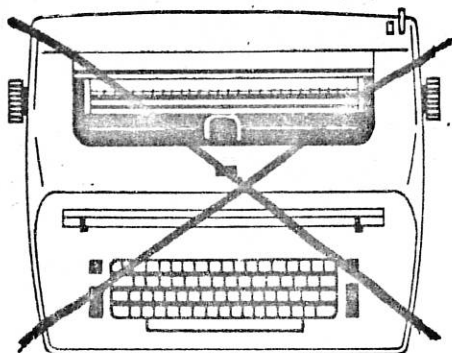
## Good Bye Typewriter Hello Word Processor!
