FROM THE HELM

I attended an interesting meeting at the Ritz Carlton in September. Every few months the Ritz management hosts a meeting for representatives of local government and Chambers of Commerce. At this one Tom Wilson, County Supervisor, was present as well as representatives from Dana Point, Laguna Niguel, Laguna Beach, Mission Viejo, the County Beach and Fire Departments and a representative from the Ritz Point homeowners' association. One of the key issues discussed was **Water Quality** on our beaches. Government at the city, county, state and yes, even the federal level is concerned. As you may have read Laguna Beach was fined \$60,000 or \$70,000 for run-off. We are essentially at a zero tolerance level.

In the past (for about 25 years) Niguel Shores had a practice of advising homeowners that construction and other debris must be cleaned up. If the homeowner did not comply, our maintenance personnel would do it for them and the Shores would bill the homeowner. Too often cleanup has been accomplished by washing the debris into our storm drain system. No more! No longer will any Niguel Shores personnel be available to help clean up.

Angela Duzich, Code Enforcement Officer for Dana Point, advises us that any construction debris, any paint residue or even naturally occurring materials such as earth will not be permitted into the storm system. Much to my surprise I found that even our gutters before the storm sewer inlets are part of the storm system. Angela told me that for any violation she would be around to "kick butt". I don't want her after me and you don't want her after you! Washing

cars and hosing down screens is O.K. but be cautious about all other chemical or solid wastes.

The offending homeowner will be responsible and in the hot seat. Niguel Shores cannot help.

On another matter covered here last month, thanks go to Bob Warren, Dana Point Director of Public Works and Engineering Services, for his expeditious handling of the Niguel Road parking situation and to Dana Point Mayor Ingrid McGuire and Councilman Bill Ossensmacher for their input.

One last but **very important** item: you will recall the concern with parking here in the Shores. Traffic and Safety is initiating a survey to ascertain if we should make any changes to **Rule 6405**. You have either received or will receive shortly this survey. **Please respond. Your input is not only important but is necessary.**

BOARD ACTIONS TAKEN IN SEPTEMBER

- ◆ Authorized staff to finalize a contract with Western States to manufacture and install new vinyl handrails for the three stairways below Breakers Isle.
- ◆ Decided to remain with Lincoln Security Service through the end of 2000.
- ◆ Accepted bid from Sparks Electric to replace the Community Center switchgear for \$6,890.
- ◆ Authorized staff to change the hours of use by the afternoon Bridge group to 12:30pm to 3:30pm, on Wednesdays.
- ◆ Agreed to pay one-half of the cost charged by the City to change the name of Shanny to Manta Court. The Sea Terrace II Association will pay the other half. Cost to NSCA is \$542.
- ◆ Accepted the recommendation of the Finance Committee to have staff review several companies that provide electrical service to see if the Association can save money by switching. The Board directed staff to return near year end with the rates available, as compared to SDG&E.

Community Center Closed on Thursday, October 5

The main electric panel at the Community Center will be replaced this day causing the shut-down of pool and spa, saunas, MPR and kitchen. Office staff may not be able to use computers nor possibly even telephones at least until 5:30 pm. Pool and spa area will remain closed for the day.

STREET SWEEPING MONDAY, OCTOBER 2

Please keep all cars off the streets and out of the parking bays. This will allow the sweeper to do a better job.

LANDSCAPE COMMITTEE

The first phase for improvement of common areas and masking utilities in Atlantic Gardens has been completed. The improved streets are Bluehill Bay, Coral Bay, Colima Bay, Kara Bay, Tasman Bay and Timor Bay. Approximately one-third of the streets in Atlantic Gardens will be improved in the 2001 planting schedule.

Remember, if you suspect the presence of red imported fire ants, make the potato chip test, collect the ants, and send them to the Orange County Fire Ant Authority. Forms are available in the Niguel Shores office.

The committee advises homeowners to put any requests, complaints, suggestions, etc. in writing rather than coming directly to committee meetings. In this way, the committee will be able to address your concerns in a more timely, efficient manner.

TREE VIEW BLOCKAGE

Frequent comments are heard by the Tree View Blockage Committee from home owners whose lateral views across adjacent gardens are being blocked, but they don't like to complain to their neighbors about it.

Owners should be aware that their pad level garden plantings should not exceed the adjacent fence height. In rear gardens, this is frequently three feet. Anything above this height can easily block views across owner's property.



TRAFFIC & SAFETY COMMITTEE

Two surveillance cameras have been installed to monitor the activity at the bridge over PCH and to assist in identifying any illegal activity that may occur in the future. These cameras may solve our problem rather than putting up an ugly wire fence over the roadway.

The total cost of vandalism in August was \$95. This is the lowest monthly amount this year. To date, the total on these senseless acts reached \$1,900 with one item alone costing \$1,100.

Recently, several homes have been broken into and burglarized. Be sure to lock your house before you leave, even for just a few minutes. If you are going to be gone for an extended period of time, ask your neighbors to keep a watchful eye on it. Also, several cars parked in driveways and in front of the house have been broken into and/or the exterior damaged. If at all possible, put your car in the garage.

The Board of Directors, members of this committee and the office staff are regularly approached by residents who say they have witnessed people trespassing, dogs running off the leash and a variety of other violations. Unless you take the time to complete an incident report, no follow-up action can be taken. We need first-hand information. Get a form and fill it out. These reports are confidential. We will all benefit from your effort.

ENTRY and TORRI GATES

Home owners west of PCH will receive a letter stating the closing dates of Ports O'Call/Cabrillo Isle gates expected the first week of October for construction of the new gate. Demolition of torri gates in Atlantic Garden Homes area may begin during the first week of October.

“Stone the Crows!”

Continued from September issue

...In it, Mr. Parsons quotes Ms. Sylvia Gallagher, bird information chairperson for the local Sea & Sand Audubon Society, as saying that her group's latest counting of family Corvidae showed a marked increase from a generation ago. She goes on to say that the five-year beak count ending in 1996 identified an average of 1,820 crows in the 15-mile diameter centered in Huntington Beach, which was 50% greater than the three preceding five-year periods, which had remarkably consistent crow counts. Ms. Gallagher states, and we quote, “that Orange County crows are pesky and too numerous. They eat chicks and eggs of other birds, including some that are endangered.” Our point exactly – and this from the Audubon Society, no less.

Clearly, we are well past the time that Corvidae requires protected species status, and we call upon the powers that be to revoke said status. Perhaps then, we can get about the business of evening the odds in favor of the other, defenseless songbird species whose melodious tones are being insidiously silenced by the raucous, croaking, cacophonous, horrisonous hordes, or murders (i.e. flocks) – there's a good reason the English historically use this term – of crows in our community and in Orange County generally.

Update on El Toro Airport

Measure F, to block an airport at El Toro, was approved by 67% in March of this year. In spite of this lopsided victory, power figures in Newport Beach, along with three county supervisors continue to seek ways to build the airport. This includes a suit claiming Measure F is flawed and should be thrown out. The appeals court judge may toss out some portions of it, retaining other sections. The size of the problem is still to be determined, leaving our group in limbo in terms of future costs to correct the problems.

Currently, a splinter group from Irvine opposed to an airport has moved ahead in seeking contributions. This same group solicited money prior to our landslide victory in March, but they refused to provide an audit of money collected or details on projects funded. These letters have been signed by Jeff Metzger, Larry Agran or Ed Dornan.

Other airport opposition groups continue to monitor the need for funds. They are all connected to the umbrella association called Taxpayers for Responsible Planning which requires strict auditing procedures.

When funds are sought within Niguel Shores, we suggest you look for an affiliation with TRP, and also look for some names of local Niguel Shores residents accompanying the appeal.

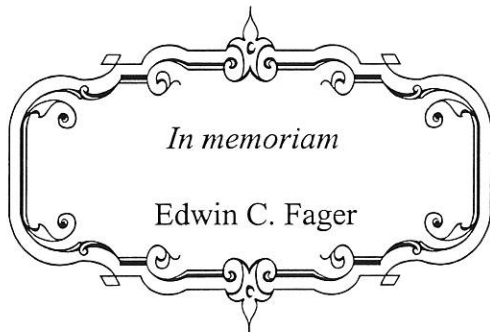
CHILDREN'S HALLOWEEN PARTY

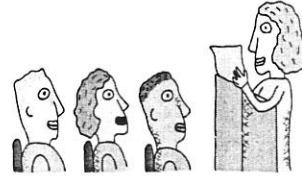
