NSCA OCTOBER BOARD MOTIONS

1. Appointed the following homeowners to the Entrance Improvement Committee: George Williams, Eve Magnus and Forrest Owen. Lydia Reeve will be the board liaison.

2. Accepted management's revisions to the rules for rental of the MPR. The rules now state which association owned equipment can be used during the rental.

3. Authorized management to install a horseshoe pit at community center, as requested by Recreation Committee. Board also authorized the use of badminton equipment at the center. Management is to develop rules of use for the Board to accept.

4. Board has accepted Maintenance Committee recommendations on how best to rebuild the coach lamps. Management is to implement program over several years and is to begin this year.

5. Board has accepted bid to install glass block in walls of each locker room at community center.

6. Board has authorized management to implement plan for the updating of play equipment in the Tot Lot as proposed by the Recreation Committee and Parents Club. Work will occur in November or December.

7. Accepted supplemental bid for additional concrete replacement in the community. Work will cost an additional \$3103.75.

8. Authorized management to drain the pool and contract for an acid wash if management deems it necessary.

REMINDER: OPEN BUSINESS
BOARD MEETINGS

As a reminder, the Board of Directors has an obligation to conduct its regular business meeting as prescribed by regulations in the California Civil Code and Corporations Code. The following was printed in the February issue of the Seashore News and it is reprinted for the benefit of all homeowners:

1. The Board will continue to hold its meetings on the first and third Wednesdays of each month. At the first meeting of each month, the Board will be meeting with staff and the association's attorney in Executive Session from 9 am to approximately 11 am. Once the Board has concluded its Executive Session, the conference room door sign will be changed to read "Open Meeting."

At the meeting held on the third Wednesday, beginning at 6 pm, the doors will be closed if the Board is discussing any item under Executive Session. The Board will handle any of these items at the beginning of the meeting. Once concluded, the same procedure will be followed.

The law mandates that homeowners may attend Board meetings; however, they do not have a right to participate in the discussions/decisions of the Board. Homeowners are allowed to observe and listen to the Board's business.

The office staff will be posting the Board agenda on the bulletin board in the office on the Monday prior to each meeting.

2. Homeowners who want a copy of Board meeting minutes may contact the office staff during regular office hours. You may purchase a copy at 10c per page. Staff will make them available 30 days after the meeting is held.

WORK PROJECTS OCCURRING IN NOVEMBER

During this month, several projects will be started or completed. We ask your cooperation by being patient and allowing our staff or contractor to complete their work. Closing the area off will be required until the work is completed. A sign will be placed on the easel at the community center prior to the start of work, advising of the time frame for completion.

Tot Lot - This project will start in November and may take until December to complete. Most play equipment will be removed and new ones installed.

Locker Rooms - This project will be done in stages. Glass block will be installed to allow natural light into the restroom areas. The interiors will be painted and the floors thoroughly cleaned. A new locker set will also be installed in the mens side.

Concrete Walks - Many areas throughout the community have damaged walks. Those areas that we could grind down were completed last summer. This project will require removal and new concrete poured. PLEASE ask your children not to vandalize the new work by walking through it or writing on it.

Stop Sign Installation - At the recommendation of the Traffic & Safety Committee, a stop sign will be installed at the Ports O'Call exit gate. This should eliminate conflict with someone exiting the Cabrillo Isle gate.

Your cooperation while the projects are being completed will be appreciated by all concerned.

RECREATION COMMITTEE REPORT

The next major event sponsored by the Recreation Committee will be the annual Art Affaire on Sunday, November 22. It will be held in the Multipurpose Room starting at noon and continuing until 5 pm. Paintings and other fine art by Niguel Shores artists will be on display and many items will be available for purchase. As in past years, there will be door prizes donated by the artists and refreshments. A donation of \$1 will be requested at the door to cover the cost of refreshments.

The Board has approved several new pieces of equipment for the children's playground to replace old and unsafe equipment. These include a Big Toy Play Unit, a Super Spring Seesaw, a "Scramble" and a "Lamb." The swings have been modified to eliminate safety problems. The Board has also approved designated areas for croquet, badminton and horseshoes and the purchase of an outside ping pong table.

The Country Western/Square Dance Class has had its first two sessions. The next class is scheduled on November 5. After the first of the year, classes will be on the second and fourth Thursday at 7:30 pm. The cost of the classes is \$4 per person for each session.

A water exercise class for men and women has been organized and will meet on Mondays from 1 pm to 2 pm at the pool. It appears that the response to a possible evening exercise class may be enough to start the class.

The Committee has expressed to the Board concern regarding the condition of the tennis courts. Skateboarders have badly marked up and damaged the surfaces of the courts.

The Friday Night Movies will continue with a new group of hosts for 1993.

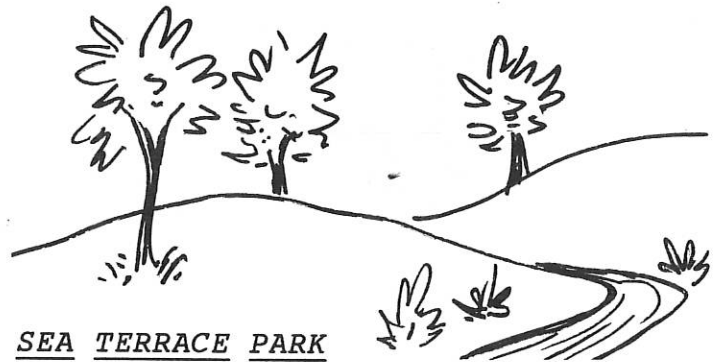
OTSUBO RETIRES FROM PARK BOARD

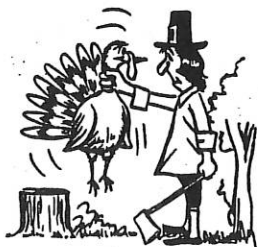

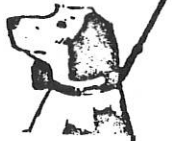

RE: Refinements for Gate Card Issuance

All of you received by mail our letter dated October 9, 1992 discussing issuance of the new gate cards. Since then, many complaints have been received because of the restrictions. In response, the Board has made several refinements to try to accommodate all situations, yet maintain control of the gate cards. If these refinements do not satisfy your situation, come to or contact the office for an appeal form that can be submitted to the Board of Directors for a decision.

The refinements/clarifications are:

1. An owner/resident may obtain a gate access package (one key card for each decal authorized) for members of their families/relatives who are not full-time residents. However, per Rule 6511, the office will only issue up to six (6) packages without Board approval. The owner/resident must attest to this relationship.
2. Homeowners and residents should also use their "No-Call" list per Rule 6604. This rule allows up to four (4) listed regular visitors to obtain a day pass without a prior call to the Mariner gate.
3. For those living in Sea Terrace II and the Villas, a four digit number will be sent to you by mail that will open the gate. This number will change at least every six months or more often as deemed necessary by management or Traffic & Safety Committee. By setting up this type of gate access, homeowners and residents are advised to be discrete as to who has the access code number.

Many of the requests for extra cards are coming from Sea Terrace II and the Villas because of their unique situation for access to their homes. These homeowners and residents will be receiving a letter in early November giving the gate access code, explaining its use and how the association will be enforcing the parking regulations, as is done in the main portion of the community.

By mid-November, all vehicles inside our community must have one of the following identifications on the windshield, dashboard or rear view mirror:

- * Owner Decal
- * Tenant Decal
- * Visitor or Service Day Pass issued at Mariner Gate
- * Special Entry Permit (color - goldenrod)
- * Six-Month Extended Service Permit
- * 30-Day Service Permit
- * Guest Pass for Sea Terrace II or Villas

Vehicles that do not have a valid pass will be subject to a citation. Accumulated citations on any single vehicle will automatically place that vehicle on the tow list.

This change will require that service contractors and visitors for Sea Terrace II and Villas have a valid pass at all times, as is the case for the entire balance of our community. In this case the contractor, sponsored by an owner/resident, will be issued a numbered six (6) month extended service permit for their vehicle. At the entry gate phone, the contractor will be required to phone the Mariner entrance, identify himself by name and entry pass number, and he will be admitted. In the letter that gives you the access code, we will include special parking passes to give to your visitors for display on their vehicle dashboard.

The association office will see that the newspaper delivery companies, utility companies, package delivery services, etc. have access to our entire community.

We hope these changes will satisfy most situations and that the revised parking restrictions for Sea Terrace II and the Villas will, when used in support of the new entry code, maintain the current level of vehicle control in these areas.

NIGUEL SHORES ANNUAL RESIDENT ART SHOW

ENTRY REQUIREMENTS:

1. Any artist who is a resident of Niguel Shores is invited to show his/her original work which has not been shown previously in a Niguel Shores Resident Artists Show. No copied work or kits allowed.
2. Wall Art (2 dimensional)
 - a. Vertical dimensions must be limited to 60" or less.
 - b. Each piece must be ready to be hung.
 - c. Each artist may show several pieces, unless larger than 24" x 30", in which case the limit will be three.
3. Sculpture (3 dimensional)
 - a. Each artist may show up to eight pieces unless space required is larger than 2' x 3', in which case the limit is three.
 - b. Work will be displayed on tables, floor or artist's stands.
4. Jewelry
 - a. No limit to number of pieces.
 - b. Plan and bring your own display materials.

DELIVERY:

1. Bring all work to the Niguel Shores multi-purpose room on Saturday, November 21 between 12 noon and 2:00 p.m.
2. Label each entry to include the following:
 - a. Artist's name, address and phone
 - b. Title
 - c. Prices (or NFS)
3. A contribution of one dollar per artist will be accepted by the Recreation Committee.
4. Read and sign the Artist's Agreement.

SALES:

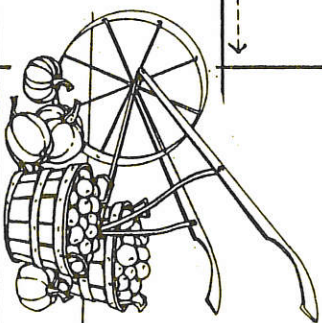
