FROM THE HELM

Last fall the Board appointed an ad hoc committee to consider the issue of vandalism in the Niguel Shores Community and to make recommendations to the Board concerning actions that could help minimize the damage. After receiving the committee's report, the Board has decided to take these steps:

- Improve the Mariner Gate. Our current plan is to require guests to be admitted only by the guard, require residents to use a key card (as we do at other gates) in a separate lane, and require pedestrians to use a proximity reader card at the locked sidewalk gates. The preliminary plans should be available for review in March and will be discussed at an evening Board meeting in April or May.
- Install new gates at the Community Center one at the main entrance and one between the tennis courts and the pool. These gates will require a proximity reader card for entrance and exit.
- Complete the security system at the beach bluff. A proximity reader device will be installed at the pedestrian gate. It will require the same type card for entrance and exit as the gates mentioned above. We will continue to lock that gate between 10:00 pm and 6:00 am.
- Continue to cite and tow improperly or illegally parked vehicles anywhere in the community. A vehicle will receive a reminder citation on the first incident and be towed away on the second or subsequent incident. We have arranged for periodic, random, additional patrols of the beach parking lot.

- Begin design of improvements at the Cabrillo Isle Gate. This will include additional fencing and pedestrian gates requiring the proximity card for entrance and exit.
- Provide security improvements at the other gates into the community from outside.

As these projects are completed, we feel we'll be better able to limit access to the community. These improvements will take place over the next two years due to the expense involved. Of equal concern is vandalism perpetrated by residents of Niguel Shores.

- We are placing more large boulders in certain locations to minimize the opportunity to drive over and tear up our lawns.
- We are working with the City and studying options in writing and enforcing rules for the use of skateboards because of damage to benches, stairs and curbs.
- We are continuing our policy of working closely with the police when we find graffiti and cleaning it up within 24 hours.
- We are asking the Traffic and Safety Committee to once again make an effort to organize an effective Neighborhood Watch Organization.
- We're trying to find ways to make certain each of our residents knows the rules for behavior in the community and accepts the responsibility to follow those rules.

We need the help of every resident. Please learn about Neighborhood Watch and get involved. It takes very little time or effort, but it can pay big dividends. It can be an effective tool in reducing vandalism as well as other crimes.

BOARD ACTIONS FOR JANUARY



✓ Appointed the Nominating Committee for the Annual Meeting to be held in May: Grover Brown, John Hall, Patty Therolf, Dotty Foth, Bob Borland, and Bob Converse as

Chairperson.

- ✓ Denied requests from two homeowners for waiver of a late charge/interest because extraordinary circumstances were not shown.
- ✓ Accepted the revised plan for additional renovations to the Womens Locker Room completed by Marshall Ininns, AIA, and directed staff to have project put out for bids.
- ✓ Authorized annual dues payment of \$50 to the Monarch Beach Civic Association.
- ✓ Authorized staff to reimburse a guest of a Breakers Isle homeowner for damage to a tire involving the Breakers Isle entry gate. Total reimbursement \$77.27.
- ✓ Directed staff to contact California Gate Systems and have them restore the traffic loops for the Manta entry gates to the original configuration. Once done, if a vehicle begins to enter and the gate starts to close, the gates will reopen and allow entry.
- ✓ Authorized staff to reimburse two homeowners who submitted claims for damage to their vehicles involving the Manta entry gates. Total cost for reimbursement \$736.74.
- ✓ Authorized staff to change the tennis racking court from court #1 to court #2, as of February 1, 1998.
- ✓ Appointed George Williams to head a committee to review the Association's Architectural Guidelines for revisions/clarifications.
- ✓ Authorized staff to replace the tape player in the multi-purpose room sound system and to add a CD player. Cost for this improvement is not to exceed \$300.
- ✓ Authorized staff to order a new tennis rules sign for the tennis court area at a cost not to exceed \$120.
- ✓ Authorized staff to purchase shirts for the maintenance staff; cost not to exceed \$850.
- ✓ Approved the 1998 Calendar of Events submitted by the Recreation Committee.
- ✓ Appointed Jack and Ann Christiansen to the Recreation Committee.

- ✓ Directed staff to have the architect issue the bid documents to general contractors for the Breakers Isle gate renovations.
- ✓ Authorized an end of year "thank you" party for committee volunteers during April/May, and to be run in conjunction with the Recreation Committee. Cost not to exceed \$1,500, with the Recreation Committee paying half the cost. This party will be in lieu of awards handed out at the Annual meeting.
- ✓ Authorized staff to pursue the electrical rewiring of the coach lamp fixtures on Kara Bay.
- ✓ Accepted the bid for \$2,460 from M&K Masonry to remove a section of rotted wrought iron fence and replace, using slumpstone. The location is along Ports O'Call, across from Salvador Bay.
- ✓ Accepted the bid from Mako Systems to install proximity readers [locking devices] on the beach access pedestrian gate and two gates at the Community Center. Installation may occur in February with activation sometime in March. Cost not to exceed \$19,000. Further description of system and operation will be published in March.
- ✓ Accepted the bid for \$2,790 from Saddleback Valley Ornamental Iron to install new access gates at the Community Center.

LANDSCAPE COMMITTEE UPDATE

The Committee is working on completing the projects list to use the available funds allocated by the Board for 1998.

Wendt Landscape has completed the long-planned project involving the tall eucalyptus trees along PCH,



Selva Road and Ritz Carlton Drive. Some trees were removed; most were trimmed. They were also able to include trimming of the two eucalyptus trees at Mariner Drive and Niguel Road at the end of the project.

The Landscape Committee has a policy of trimming these tall trees every three years. As of this date, all of the tall trees in the community have been trimmed on this schedule. Between now and April, the Committee will review the tall eucalyptus trees along Magellan Isle and at the corner of Niguel Shores Drive and Mercator Isle. It has been three years since the last time they were trimmed.

During February the pine trees along Mariner Drive will be thinned out. These trees were last thinned three or four years ago, and they have accumulated a lot of debris. Cleaning the interior of the trees is for their health. Thinning will also help bring the turf under the trees back to life.

"GREEN WASTE" CONTAINER UPDATE

In the November 1997 issue of the Seashore News a Solag Disposal article indicated that a large container would be delivered to Niguel Shores for the disposal of residents' "green waste". The delivery date has now been pushed back to early April, 1998. Solag Disposal is implementing a similar program in Laguna Niguel and has requested the additional time in order to introduce the programs simultaneously. Rules for the use of the container will be finalized and published prior to the container's delivery to Niguel Shores.

TRAFFIC AND SAFETY COMMITTEE



- 1. The Community Relations Manager will send notices immediately to residents when a report from Securtec indicates a violation of Association Rules.
- 2. The new design for the gate at Breakers Isle was approved by the Board and bids are being solicited. Breakers Isle residents are paying for this improvement.
- 3. There was a committee consensus that the new pedestrian gate access will be a key card with a magnetic activator.
- 4. The Committee agreed to review the Rules and Regulations regarding the number of parking packages issued to each household.
- 5. A new color pass will now be issued to guests whose names have been submitted for a party. This pass cannot be used for re-entry. Residents will still submit lists to the office, which will be given to the gate at the close of the day.
- 6. Mariner Gate will not be closed during the reconstruction of the new gate which is expected to begin this summer. The Ports O'Call Gate will not be upgraded this year.
- 7. There were changes made in the winter patrol hours of Securtec: more hours on Friday and fewer on Sunday.
- 8. Because of the Mens Club Camp Pendleton tour, the next meeting of the Traffic and Safety Committee will be Monday, February 2, at 10:00 am.

EFFECTIVE FEBRUARY 1, TENNIS COURT #2 WILL BE DESIGNATED AS THE RACKING COURT.

The racking court is available for reservation from 8:00 to 9:00 am on weekdays, and from 8:00 to 9:30 am on weekends. At all other times the racking court is available for thirty minute periods on a first-come, first-served basis. Please sign in, indicating the time on the sheet provided at the equipment window at the NSCA office. Note: "racking court" is a term used to indicate that tennis racquets are placed in the rack so that an order is established as to who is in line to play next.

The Board of Directors is concerned with the condition of the tennis courts and is in discussion with contractors regarding refurbishment/repair versus replacement. At this time, Court #2 is in the worst condition. By designating Court #2 as the racking court, it should receive less use.

Also, maintenance has requested that when using the Rol-Dri equipment, please hang the rollers up after use.

Appropriate signage has been posted. For your own safety, if you use the tennis courts or racking court, please take time to read the Rules and Regulations. Your cooperation is appreciated.
