## FROM THE HELM

The primary election is history and we can now begin to prepare for the next major election. On May 16 the Niguel Shores annual meeting will be held. At this time we will be able to find out who will be elected to the three open spots on the Niguel Shores Board of Directors. There are four candidates for these positions

Of our current incumbents only Gerlinde Duffy has chosen to run for another term. Don Johnston and Jerry Milner will be completing four years as Board Members and have earned a well deserved respite from the many hours required. Thank you Don and Jerry for all of your well spent hours and efforts.

Early in April you will be receiving a ballot for this election and you will have a chance to make your voice and vote heard. On Wednesday night, April 19, we will have candidates' night when each of the candidates will have the opportunity to speak to the Open Meeting of the Board. Please try to attend. Elsewhere in this issue look for the resumes of the candidates.

Also during April we are hoping to go to bid separately on both the Cabrillo Isle Gate renovation **and** the Torii Gate replacements. Sixty days will be allowed for the contractors to respond and because of the heavy construction schedule here in Orange County, we should expect construction to begin in August or September on Cabrillo Isle.

The Torii Gate replacements will start with the Atlantic Garden gates and the Shores Garden gates will probably be undertaken in 2001.

Those who were farsighted enough to buy bar-code readers for their cars did not experience wet left arms as they came in through the Mariner Gate on rainy days in March. In general the bar-code readers helped to ease and speed up access through the resident lane because there was no longer the necessity to stop, roll down the window, hunt for the gate card, use it, put the card somewhere in the car, roll up the window and then think about moving ahead. The Cabrillo Isle gate will be equipped with a bar-code sensor this fall. It is our plan to also equip Manta, Garibaldi and Selva Gates as well, as soon as we can feasibly do so.

Don't forget to vote for the Board candidates. If you all turn out as well for this election as you did for the primary election, we should have absolutely no problem in getting a quorum.

## MARCH BOARD ACTIONS

- ◆ Accepted the 2000 Annual Meeting mailing notice and proxy. Directed staff to prepare materials for mailing to homeowners in early April.
- ◆ Authorized staff to reimburse two homeowners for clearing a drain, which is the responsibility of the Association, in their rear yards.
- ◆ Authorized use of the Community Center MPR for a children's recreation program that will be run by Shilind Wheaton. The Board agreed, provided she signs an *Instructor's Agreement*, and the children who participate have their parents sign a participants waiver.
- ◆ Authorized the Tennis sub-committee's use of the tennis courts on Sunday, April 9 for an exhibition.
- ◆ Agreed with the Recreation Committee's recommendation to hold the next new resident orientation in June.
- ◆ Accepted the Finance Committee's recommendation to create an "Investment Sub-committee," which shall meet quarterly to review upcoming project expenditures.
- ◆ Appointed homeowner Bill Wolff to the Architectural Committee.
- ◆ Agreed to support the request from the Sea Terrace II Board to seek City approval to change the entry street name from "Shanny" [leads to Manta Court] to Manta.

- ◆ Appointed homeowner Gladys Hanes to the Recreation Committee.
- ◆ Authorized staff to work with our consulting architect to finalize the Cabrillo Isle gate renovation plans so that the project can go out for bids in April.
- ◆ Authorized staff to work with our consulting architect to finalize the Torii gate construction plan so that the project can go out for bids in April.



## TRAFFIC & SAFETY COMMITTEE

1. Mariner Gate:
  - a. During the recent rains, if you got wet using your key card to enter the gate then you need to purchase a Bar Code Decal. The response so far has been good. Stop by the office any weekday and purchase one.
  - b. Computer generated passes are just around the corner. They will speed up the process at the gate, but a pass can only be issued to your guest if you have included a valid PIC (Personal Identification Code). If you do not have one, now is the time to get one. Contact the office any weekday for assistance. Without this code in the system, your guest could be inconvenienced or even denied entrance.
  - c. If you are going to have a party with 10 or more guest vehicles, you **MUST** submit an alphabetized list, with your PIC, to the office 48 hours prior to the event. **DO NOT** give this list directly to the gate officer. The office staff will prepare the passes in advance so that they will be ready when your guests arrive. Failure to do so will cause your guests unnecessary inconvenience.

d. If you are going to have a party including 4 to 9 vehicles, please give an alphabetized list with your PIC to the Gate Officer.

2. Pedestrian Gates at Mariner Entrance:

It has been reported that on numerous occasions, residents, domestic workers and others when they are entering or leaving the community, have been stepping down from the sidewalk onto the roadway in order to get around the gate. This creates an accident waiting to happen. Currently, the pedestrian gates are unlocked from 7:00 to 8:30 am and 3:30 to 4:30 pm weekdays. The Committee has recommended to the Board that the gates be unlocked daily the same hours that the vehicle gates are open.

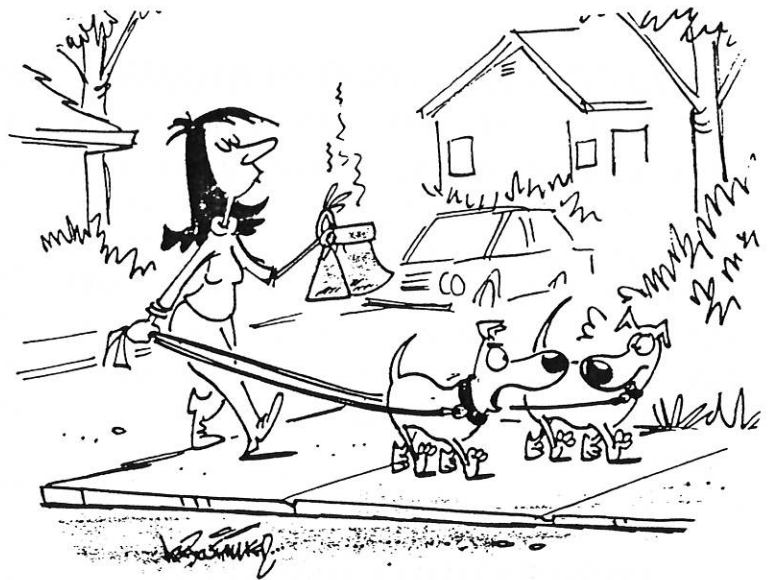
3. Disaster Preparedness Drill:

**Thought of the month:** Golf was once a rich man's sport, but it now has millions of poor players.



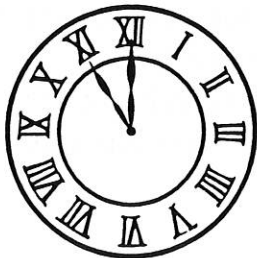
## LIBRARY NEWS
