The Niguel Shores Community Association Annual Meeting is on Tuesday, May 16.

Those who attended last month's open board meeting were able to hear the candidates speak. Their resumes were in the April edition of this newsletter. Whatever you do, be sure to turn in your proxies and vote for the persons you want to have representing you for the next two years! Your proxy is required for the quorum, whether or not you vote for the candidates.

On April 15, Niguel Shores had a Mock Earthquake Disaster Drill. This drill involved such catastrophic "happenings" as collapsed houses, a broken water main, injured persons, fires and damage to our bridge over PCH. A bunch of the Windjammer kids and others provided us with a goodly supply of "walking wounded." Street and Block Captains did an outstanding job of reporting conditions and problems to our communications center at the Community Center both on their own and with message runners.

Our thanks to everyone who participated and our special thanks to Gerlinde Duffy who set up the entire operation. On the Wednesday night before our drill Gerlinde arranged a meeting for the volunteers, a meeting that was attended by more than 70 persons - more than we would generally get at open Board meetings.

Mark Johnston, Emergency Services Coordinator for the City of Dana Point attended and monitored our drill. He was highly complimentary of how it went and had only a few constructive suggestions. Overall he felt that we were in the top 10th percentile or even higher of all of the communities in the area in preparedness. His words as he left were: "Excellent Drill."

Finally, for this message from the Helm, I want to thank Jerry Milner and Don Johnston for their efforts and dedicated service on the Board of Directors during the last four years. They have contributed immensely to our community. Everything that they have worked on has been with the well-being of all of the members of Niguel Shores in mind. The improvements occurring over these last four years have been in large part a result of their efforts and devotion.

BOARD ACTIONS TAKEN IN APRIL

- ◆ Authorized staff to change the employee medical plan to a Blue Cross PPO plan, effective July 1, 2000.
- ◆ Accepted the Retained Services Contract with Fiore, Racobs & Powers for the period May 1, 2000 through April 30, 2001.
- ◆ Decided motorized skateboards are not to be used on the Association's streets, which the DMV Vehicle Code also prohibits on public streets.
- ◆ Authorized staff to finalize the 1999 audit with the CFO and to mail out to all homeowners.
- ◆ Accepted the resignation of Barbara Crist from the Communication Committee.
- ◆ Authorized staff to accept the bid from Saddleback Valley Ornamental Iron to replace three fence locations with similar wrought iron at a cost of \$3,060.
- ◆ Authorized a program, to be supervised by the CFO, to give a financial award to employees for cost savings suggestions/implementations.
- ◆ After reviewing bids, authorized staff to purchase a new digital copier/printer from Benchmark at an approximate cost of \$11,393, along with a maintenance service agreement. The new unit is to be in place when the old leased copier is removed in late May.
- ◆ Authorized staff to issue the Annual Meeting Notice with Proxy.

◆ Authorized staff to proceed with the installation of 300 ft. of sub-drain in the Community Center greenbelt, behind the homes on the east side of Kara Bay.

◆ Authorized the creation of an ad-hoc Information System Committee to be chaired by Charlie Clark.

◆ Authorized staff to allow the pedestrian gates on Mariner Drive to be unlocked from approximately 7:00 am to 6:00 pm, daily.



LANDSCAPE COMMITTEE

White flies seem to be particularly bad this year. The committee advises you to look carefully for them in your shrubs and flowers, particularly hibiscus. White flies congregate on the underneath side of leaves and are hard to detect from a cursory glance. To eradicate white flies and to keep them from spreading to other plants, Wendt recommends that you either remove deadly infected shrubs or use Ortho brand Orthene, which is a systemic spray. However, if you use Orthene, be sure to **follow instructions carefully**, especially with fruit trees and vegetable plants.

Wendt's work schedule for April is as follows:

Custom Homes: Renovate lower slope below lots 16, 17, and 23 along Breakers Isle (originally scheduled for March).

Sea Terrace I: Turf dethatch of front yards and common areas.

Villas: Replace remaining evergreen pear trees with 89-gallon *metrosideros* trees.

Common Areas: Annual color replacement.

Note: Replacement of various oleanders in Sea Terrace has been cancelled since no problem has been found.



TRAFFIC & SAFETY COMMITTEE

1. Mariner Gate:

- a. The system for computer generated passes is being field tested. When that is completed and the homeowner data is loaded into the system, it will come on line. The computers WILL NOT issue a pass to your guest without a PIC (Personal Identification Code). If you have not already chosen one, the office will inform you by mail.
- b. The committee recommended to the Board that a second officer be assigned to the gate daily to assist in the processing of guests, answering the phones, processing the required paperwork, other responsibilities that come up during the day. Traffic through Mariner gate will increase with the upcoming construction of the Cabrillo gate.

2. Pedestrian Gate:

Our thanks to committee member, Nick Moffitt, who provided the Association with the label identifying the location of the access readers at the pedestrian gates.

3. Beach Lot:

- a. The county is moving ahead with the replacement of the fence along the public walkway, and it is expected that the project could be completed before the summer season starts. This should significantly reduce the number of trespassers who have entered our community in that area.

- b. A number of complaints have been received from residents who, while they are enjoying the beach bluff park, are offended by the surfers who are changing their clothes just a few feet away. Residents are offended, not only by this disrobing but also by the trash that the surfers leave behind in the lot. A survey indicates that most of the cars have guest passes. The committee recommended to the Board that visitors (those with guest passes) not be allowed to park in the lower portion of the beach lot.

4. Community Park:

Now that it is staying light longer and the weather is warming up, residents are using the park area, especially the picnic tables, only to find that there are dog feces throughout the park. Be courteous to your fellow neighbors and pick up the residue. It is the law.

5. Vandalism Report:

Someone with a BB gun is shooting out the coach lamps in the common area throughout the community. We spent \$193 in March to repair/replace these lamps. Some residents have reported that they have been victims too. If you have any information regarding these incidents, the office would like to hear from you.

Many thanks to you all for participating in the recent earthquake disaster drill. Kudos especially to the Street Leaders, Block Captains, First Aid and Search and Rescue Teams, Runners, and Command Center volunteers!

We staged nine disasters, from a water main break on Atlantic Drive, gas line ruptures and fires in the Sea Terrace I and II Townhome areas, a slope failure and collapsing house at Breakers Isle, bridge damage at Ports O'Call, a trapped victim and injured dog in the Villas, torn-up Periwinkle Drive, a fatality at a Torii Gate at Atlantic Avenue, to numerous injured children (and a black Labrador) in the Windjammer area.

Even if you only put your 'OKAY' sign out front and showed patience and restraint at being inconvenienced during those two hours of the drill, you helped.

Now is the time to update your supplies. There are HELP/OKAY signs and Disaster Manuals available at the office if you need them.

The community welcomes these new neighbors warmly!

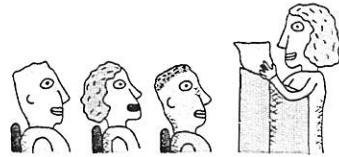


WOMENS GOLF

VACATION HOME SECURITY CHECK

At no cost to residents of the City of Dana Point, Police Services will provide vacation home checks while residents are out of town.

They will provide a physical check of a residence to ensure that no windows or doors have been left open, etc.

When residents require a vacation home check, they are to call the Dana Point Police Services at 248-3517 and give the following information:

- Name
- Address
- Cross street
- Time frame of service
- Emergency contact:
 - Name, address, city, area code+phone number, and relationship.
 - Do they have a key to home?
- Any other pertinent information like gardeners, cleaners, pet sitters; their names and hours they work; and do they have keys to the home?
- Description of any vehicles parked in the driveway.

Providing the above information, and any other information about who will have access to the home during the resident's absence, will help the Police Services to secure the home.
