NEW SUBJECT URBAN RUN-OFF

Wastewater is a major concern to the City, the County, the Regional Water Quality Board, the State, and Feds. You may be aware that many beaches in Southern California have been closed off and on due to polluted ocean water. And much of the pollution comes from urban run-off.

The City of Dana Point has installed filters in storm drain openings throughout Dana Point. We will be required to put them in our storm drains, too. We'll include that project in our budget for 2003.

A major unknown is if and when we may be required to treat the wastewater itself. So now is a good time to get used to being careful about what goes down the gutter. Please do not wash down your driveway or over-water your yard. And be sure to pick up after your pet.

MESSAGE FROM GENERAL MANAGER

SPECIAL POOL USES ON MORNINGS

The Board is requesting that pool use on weekday mornings between 8:00 and 10:00 am be voluntarily limited to physical fitness activities. Several owners have requested that there be restricted pool use hours for fitness and therapeutic use. The Board felt that Federal Law prohibitions against use discrimination based on age, family status would cause enforcement problems. Therefore they have suggested a voluntary limitation.

REMOVAL OR THEFT OF BARCODES

Two owners have reported that someone attempted to remove their vehicle barcodes. The barcode is assigned to and must be installed on the car it is registered to. When we are notified that a barcode is missing, it will be removed from the computer and thus inactivated. Barcodes are not made portable. The Blue Dolphin decal is no longer of any significance, but many owners have requested to keep them, which is okay, but serves no purpose. A car without a barcode or a gate pass is subject to towing.

LANDLORD/TENANT RELATIONSHIPS

Owners are responsible for registering tenants and providing them with copies of the rules. Tenants are often sent to the office with the expectation that office staff will be contacting the owners. Staff are not rental agents and the Association can not provide landlord services.

A copy of the rental agreement must be provided to the office for registration, and any extensions must be authorized by the owner. Owners must also be aware that they may be held responsible for actions of their tenants.

2003 BUDGET RECOMMENDATIONS

In order to start the drafting of the preliminary 2003 budget, all committees are to submit their budget recommendations to the general manager by the middle of August. A final budget recommendation and revenue projection is made by staff in September for review by the Board and Finance Committee. A budget must be adopted by the Board by early November for distribution to all owners by mid-November.

EMAILS AND QUESTIONS SUBMITTED TO THE OFFICE

Following are answers to questions from emails received at nscaadm@msn.com, calls or written requests received at the office:

Do tenants have the same rights as owners in Niguel Shores? The general answer is yes, but the relationship of the tenant to the Association is through the property owner. Our Association has a recorded contract (the *CC&R*) with everyone who buys property in Niguel Shores. Every owner automatically becomes a member when they purchase, and cease to be a member when they sell. When an owner rents property, he generally transfers most of his property rights to the tenant under the terms of the rental agreement. However, this does not relieve the owner of the responsibilities under the *CC&Rs*. Thus if there is damage to the common area or a violation fine, the claim is against the property owner, who then must collect from the tenant, since the Association has no binding agreement with tenants.

Why is there a charge for a new barcode when we get a new car? In order to minimize the monthly assessment, the cost of Association activities is divided into two categories, overall benefits and self-supporting services. Any additional barcodes or replacements are to be paid for by the owner. Each residence is entitled to two barcodes at no cost. When a vehicle is replaced, records must be changed, the old barcode deactivated and a new barcode installed and activated. Just as you must register and pay a fee to the State, the cost of the change must be paid to the Association.

REMINDER OF NEW OVERNIGHT PARKING WAIVER RULE EFFECTIVE JULY 1

The following fee schedule will be implemented for all new applications for *Overnight Parking Waivers*, per Rule 6405: A one-time \$25 application fee per waiver requested for more than a temporary period of time (i.e., more than 60 days unless extended in conjunction with an approved construction project).

Effective January 01, 2003, all waivers issued to date will expire and must be renewed annually, if still eligible. An annual renewal fee of \$10 per waiver will be implemented and charged.
