# OWNER FORUM BOARD MEETING

Wednesday, November 20 7:30 pm

- ▶ Approved a one-year extension of the Guard Service contract with no change in the contract costs.
- ▶ Approved the annual renewal of Association insurance coverage.
- ▶ Approved a modification of the Mariner Gate center island at Niguel Road in order to provide left turn lane for pending traffic signal.
- ► Authorized pool, spa and decking repairs in January.

- ▶ Accepted with regret the resignation of Ann Christiansen from the Recreation Committee.

### MESSAGE FROM THE GENERAL MANAGER

### MARINER ENTRY

Due to the pending installation of a traffic signal at Mariner Drive and Niguel Road, the center median and lane markings will need to be changed. Currently there are two entry lanes and one exit lane. The change will be to one entry lane that transitions to two lanes mid way in from Niguel Road, and two exit lanes so that left turn traffic will not block cars turning right. This requires reducing the length of the Mariner Drive center median. It is being done in advance of the signal installation so that the City can stripe lanes and install lane sensors with the signal work. The widening of Mariner Drive near the intersection to provide another lane was not considered financially reasonable due to the cost.

### PREPARING FOR WINTER

Southern California has had mild weather for such a long time that it is hard to think of winter rains or storms. However, now is the time to check your drainage and make sure the underground drains are not blocked or that plants have grown up around inlets. All drains and roof gutters should flow to the front street or a storm drain, not to a neighbor's property or the common area, unless there is an easement.

Also, timers for automated landscape watering should be cut back.

### DANA POINT NEWSPAPER LETTER

A recent "Letters to the Editor" for the Dana Point News criticized the Niguel Shores HOA. Why it was addressed to the City Newspaper is unknown since it is a Niguel Shores owners' issue. Another owner responded to the letter, a portion of which stated: "For about \$185 per month, we have completely private roads; a large full time staff of landscapers who handle the greenery on my street every Monday like clockwork; 24-hour guard service; a Community Center to envy with pool, spa, saunas, table games, multi-purpose room including kitchen; a full-time staffed office to handle the daily business of the NSCA; regularly scheduled and enjoyable events and clubs, including summer camp day care and beach bluff BBQ's; and incredibly uncrowded, private beach parking on one of the most desirable beaches in Southern California, Salt Creek/Dana Strand." Limited space does not permit me to print the entire letter which was a positive and accurate description of the benefits of living in Niguel Shores. There is always room to do things better, but it is important to remind everyone of the good things we take for granted.

### EMPLOYEE HOLIDAY DONATIONS

The optional holiday donations for employees working at Niguel Shores are still coming in, with about 40% of the owners contributing. On behalf of the workers, please accept our thanks. This new voluntary program was instigated by an owners committee that had previously coordinated food and gifts for employees, but felt they could not adequately contact all resident. Several owners expressed support for the voluntary effort. A few negative comments were received indicating "subtle coercion" and questioning why any gift should be given to workers. That is why it is voluntary.

What can be done to keep sprinklers from getting water on my parked car? If the offending sprinklers are for the common area, we will do our best to adjust them, or if you desire, to cap them. Give the office written notice and in some cases a simple drawing so we can locate the sprinkler. Staff will then check it out and make any obvious adjustments. Major changes will be reviewed by the Landscape Committee. We desire requests to be in writing in case the result is a decline in the appearance of the landscaping. If the problem is a neighbor's sprinkler, speak with them directly rather than filing a complaint with the office.

# "DRAINS --- DRAINS --- AND MORE DRAINS"

Now that the seasons are changing it is time for the NSCA maintenance staff to perform the annual inspection and clearing of the drainage outlets in our community. This involves the maintenance staff entering the exterior of approximately 300 properties,

with access often restricted by enclosures such as fencing.

It also may require the use of an outside water faucet and hose, yours or ours, to test the drains for clogging. This inspection and cleaning will be done between the hours of 8:00 am and 3:00 pm Monday thru Friday during the months of November, December and possibly January. Due to varying times required for each test we cannot provide a specific date or time for each location. If unscheduled access will create a problem for you, please contact us as soon as possible so we can arrange a mutually convenient time. We thank you in advance for your cooperation in allowing us to enter your property to conduct these tests.

### DISASTER PREPAREDNESS UPDATE

By now all of you should have received the Southern California Edison Company's San Onofre Nuclear Emergency Information and Primary Evacuation Routes in case of a disaster.

This is the same plan and information as in your NSCA DISASTER MANUAL. Please pick one up at the office if you do not already have it.

I would suggest putting the extra copy of the evacuation route in the glove compartment of your car if you are a driver, or keep the map in your wallet so you will know where to access the public transportation assembly points if you cannot drive.

In the event of an emergency at San Onofre we might not have any power to access radio or TV for information/instruction.

This is where a small investment in a battery-operated, portable radio/flashlight would be invaluable. Now is also a good time to reassess your family's emergency supplies.

Remember, panic occurs only when you are unprepared. Invest a half hour to discuss/check/update your emergency program with your family and utilize the volunteer services NSCA has put together for your safety.

As I pointed out in the letter that each of you received with a copy of the 2003 budget, the Board was able to hold the line on dues for the incoming year. One of the things that helped us was that we were running under our expense budget for 2002 and so we've been able to do some things during the last couple of months of 2002 that otherwise would have required an increase in 2003 dues or would have not been done at all.

### TRAFFIC AND SAFETY

Speed Bumps: Several residents have complained about various speed bumps in the community. As a result, the committee will review each one to determine if it meets the current codes and specifications and will present their findings to the board.

### SAFETY REMINDERS:

Many of us this time of year use the fireplace. Be sure that the chimney is in good order and that you have a spark arrestor. If not, you could suffer roof damage due to falling embers.

If you put up holiday lights, be sure that the wiring is in good condition. A frayed or broken wire could result in a fire. Also, do not leave the holiday lights on while the house is not occupied.

### **HOLIDAY PARTIES:**

If you are planning a holiday party, be sure to provide your guest list well in advance so your guests will not be delayed at the gate. If you are expecting between four and nine guest vehicles you can FAX the list, with your PIC, to the gate at 487-5432 or deliver it in person, If you are going to have a party with ten or more guest vehicles, you MUST submit an alphabetized list, with your PIC, to the office 48 hours prior to the event. DO NOT give this list directly to the gate officer. The office staff will prepare the passes in advance so that they will be ready when your guests arrive. Failure to do so will cause your guests unnecessary inconvenience.

If unscheduled access will create a problem for you, please contact us as soon as possible so we can arrange a mutually convenient time. ### DISASTER PREPAREDNESS UPDATE

By now all of you should have received the Southern California Edison Company's San Onofre Nuclear Emergency Information and Primary Evacuation Routes in case of a disaster.

This is the same plan and information as in your NSCA DISASTER MANUAL. Please pick one up at the office if you do not already have it.

I would suggest putting the extra copy of the evacuation route in the glove compartment of your car if you are a driver, or keep the map in your wallet so you will know where to access the public transportation assembly points if you cannot drive.

In the event of an emergency at San Onofre we might not have any power to access radio or TV for information/instruction.

This is where a small investment in a batteryoperated, portable radio/flashlight would be invaluable. Now is also a good time to reassess your family's emergency supplies.

Remember, panic occurs only when you are unprepared. Invest a half hour to discuss/check/update your emergency program with your family and utilize the volunteer services NSCA has put together for your safety.
