#### FROM THE HELM

In my last article, I focused on community spirit and our financial status. I would like to share with you what your Association is doing to improve its physical facilities and common grounds. First, comm.unity associations exist because offer choices, lifestyles, amenities and efficiencies that people value. Some are drawn to the architectural uniformity of the neighborhood, quality of landscaping, recreational amenities and social opportunities.

Many community associations offer services and amenities that most Americans cannot afford on their own - swimming pools, tennis courts, playgrounds, professional security, social/recreational centers, lakes and ponds, or even a beach bluff with a whitewater and panoramic view of the ocean. These communities also provide some degree of protection against neighborhood degradation deterioration. The NSCA strives to give continuity to the community, preserve the architectural integrity and to maintain the common properties. Properly run, we strive to promote the community concept and protect the community's property values. In this regard, the following highlights some of the work your Association has been doing to meet this objective:

#### STRATEGIC/PLANNING

Board approved the commendation of the ad-hoc committee to select Robert Borders & Associates to provide architectural services to develop a conceptual master plan to renovate and remodel the Community Center complex, which includes buildings and common ground area, and to evaluate the Beach Bluff property for community-use velopment. The artistic renderings and layout designs will be completed by late December and community review and input sessions will begin in January 2004.

#### SEASHORE NEWS DEADLINE

Due to new printing procedures, the Seashore News must strictly enforce the deadline of the 17<sup>th</sup> of October for all November submissions.

#### NSCA FORUM BOARD MEETING

Wednesday, 22 7:30 pm

- Developed a proposed design for the Beach Bluff Park to include additional grassy area, decking, picnic tables, benches, small trees, landscape and modification of the parking area. The plan received various comments both positive and constructive that will be reviewed with the architect. The plan is still open to changes and we plan to display the final design in January 2004 and to make the improvements in March-April 2004.
- ▶ 2004 Budget preparation is being finalized which will set the annual goals, priorities, funding requirements and dues assessment for the next year.

#### **OPERATIONAL**

- ▶ Completed the slurry sealing of Niguel Shores Drive and streets in the Sea Terrace II and the Villas home areas.
- ► Completed the asphalt overlay of streets in the Berkus and Shore Garden home areas.
- ▶ Overseeing the annual landscape maintenance and improvements of community grounds.
- ► Completed the beautification and landscape improvements of the Mariner Street entrance area.
- ▶ Issued a contract to Converse Consultants to provide an updated slope assessment, a community-wide groundwater seepage assessment and other identified slope survey work.
- ► Completed the resurfacing, tiling and coping of the swimming pool and spa.

Placed commercial advertising space in the Seashore News beginning with this October newsletter that will generate revenues to offset the cost of production.

All this work is performed with our self-managed staff with the support of a strong cadre of committee volunteers. Many thanks to our committee volunteers who dedicate an enormous amount of time to help our community without compensation. Special thanks to the Maintenance Committee, chaired by Don Johnston, and the Landscape Committee, chaired by Janet McKaig, for their leadership in overseeing a significant portion of the annual budgetary funds to properly maintain and improve the infrastructure and beautify the common grounds.

When people work together in an atmosphere of trust and accountability toward a common goal, they put aside turf issues and politics and concentrate on the task to be accomplished. This focused application of

resources breaks through barriers, identifies new opportunities and creates a momentum that leads to three major bottom-line benefits: (1) better problem solving, (2) greater productivity, and (3) more efficient use of resources.

#### **BOARD ACTIONS IN SEPTEMBER**

- ► The Board approved a contract with Scott and Whitehead, a law firm that specializes in employment law, to develop an Employee Handbook after January 1, 2004.
- ▶ The Board reviewed a letter from a resident regarding non-residents using NSCA facilities. The Board will be discussing the matter and making a decision on a solution after additional information is gathered, e.g. liability issues, extent of non-resident use, etc.
- ▶ Commercial advertising in the Seashore News was approved by the Board. A new rule #5226, which is included in of this issue of the Seashore News, establishes guidelines for and procedures for offering advertising space.
- ▶ The Board approved designating three reserved parking spaces for staff in the parking lot near the office.

Board of Action Continued...

- ▶ Rule 5102 Use of Community Center was amended by the Board. Amended rule 5102 Rules for Use of the Association Facilities is included at the end of this issue of the Seashore News.
- ▶ The Board again discussed the on-going problem of unauthorized pedestrian access at the main gate. They were unable to reach a resolution on the matter.
- ▶ The Board requested the General Manager obtain bids for installing spikes at the Selva entrance gate that would deter unauthorized persons from tailgating into the community.
- Authorization was given to install two signs at the Beach parking lot advising that vehicles that do not display a barcode or proper pass will be towed within one hour. One sign will be installed at the gate entry and another on the fence spanning the bluff.

The Niguel Shores business office is open Monday-Friday between 9:00 am and 5:00 pm. Owners who do not live in Niguel Shores full-time and those who are not able to come to the office during normal business hours should contact NSCA staff at

493-0122 Monday thru Friday between 9:00 am and 5:00 pm for information and to have their questions answered. The clerks who work after hours and on weekends monitor the community center but they cannot conduct business or change/update your records. They do not issue vehicle decals or distribute fobs, they aren't trained to register new owners and tenants and they are not authorized to change "no-call" information at the Mariner Gate.

If you will call the business office during normal business hours, we can advise you how to accomplish your NSCA business with minimum inconvenience.

Association facilities are defined as the Community Center Facilities and Recreation Grounds, the Beach Bluff and all Common Areas

- A. Community Center hours are 6:30 a.m. 9:00 p.m., daily. Hours for the Beach Bluff are limited to 6:00 a.m. to 10 p.m. daily.
- B All persons using the Community Center facilities are required to sign in when entering.
- C. Guests using any of the Association facilities must be accompanied by a member, or be registered at the office by the member. A member is responsible for the conduct of his/her guests and their observance of the rules.
- D. Access to the Community Center and Beach Bluff is restricted to authorized hours. Any member or guest who enters during unauthorized hours is subject to illegal entry and trespassing laws, and may be prosecuted. Violations of this rule may be cause for suspension of member privileges.
- E. The NSCA staff has the authority to enforce all rules and regulations. Members are requested to report infractions of the rules to the NSCA staff.
- F. No pets or other animals are permitted within the Community Center gates.
- G. Glass containers or objects are not permitted in the outdoor Community Center area. Food is not permitted in the swimming pool area.
- H. Smoking is prohibited in all Community Center buildings and in other designated "No Smoking" areas.
- I. Rough or boisterous conduct, profanity, gambling or other than moderate use of alcohol is prohibited.
- J. The maintenance area, all storage areas, pool filtration rooms and staff office space are off-limits to members and their guests.
- K. Misuse or vandalism of any Association facilities may be cause for suspension of privileges and referral to local authorities for prosecution. Property owners may be subject to a fine.
- L. Skateboarding, roller/inline skating and roller hockey are not permit within the Community Center gates or parking lot. Surfboards and bicycles are not permitted within the Community Center gates. Bicycles must be left in the bike racks outside the gates.
- M. Loitering is prohibited in or about any Association facility.
- N. Individuals using the Association facilities may be required to furnish proof of membership or authorized guest status.
