BOARD ACTIONS

- The Board conducted several violation hearings and imposed fines.
- The Board presided over an appeal hearing requested by a homeowner regarding reversal of the Architectural Committee's disapproval of his request to expand his house. The Board ultimately upheld the decision by the ACC to deny the request for expansion.
- Approval was granted to install a fob locking device on the second pedestrian gate at the Manta entrance.
- The Board reviewed bids for the purchase of a new copy machine for the NSCA office and approved the purchase of a Sharp 450N for a total price of \$10,000 plus tax.
- The Board discussed a proposed cover letter and written ballot that will be sent to all NSCA homeowners for their vote on financing of Community Center Renovation project.
- The Board reviewed revisions to the "ACC Exterior Modification Submittal" form and referred the document back to the ACC. The revised form was approved.
- The Board reviewed procedures it should follow when proposed homeowner improvements on Breakers Isle properties extend into Association maintained slope easements, thus requiring Board review after the ACC has reviewed

BEACH BLUFF COURTESY

Just a few reminders about your enjoyment and that of your fellow NSCA residents when using the Bluff area.

- If you arrive late and the table you want is already reserved, please don't take it upon yourself to relocate the reserved spot.
- · DOG OWNERS please keep your pets on a leash and pick up after them. The Board has received several complaints in the past several months, and one resident has gone so far as to ask Board consideration to ban dogs from the bluff altogether because of the lack of courtesy and concern for non-pet owners by pet owners.
- Far too many guests are arriving at the NSCA beach access gate and expecting (or intimidating) residents to let them into or out of the gate. Just a reminder that guests wishing to use the beach gate (like all other access gates to common area facilities) must be accompanied by the resident host. There are no exceptions to this rule.

DON'T FORGET ABOUT THE NEW ACCESS NUMBERS

On August 4 the new access codes for the gates and telephone numbers for the gatehouse will go into effect. If you haven't received your mailer with the numbers by now, call the office for them. Be sure you have your PIN number as we won't give out this confidential information over the telephone without proper identification.

TRAFFIC AND SAFETY COMMITTEE

- 1. When going to the beach, remember the Vehicle Code prohibits ANYONE from riding in the back of a pickup truck. This is a very dangerous practice.
- 2. Miniature motorcycles, "Pocket Bikes" etc., either electric or gas powered, are prohibited by law on ANY roadway or sidewalk including Niguel Shores as governed by the California Vehicle Code.
- 3. Mariner Gate: There continues to be a high number of guests being turned away because they do not have prior authorization to enter. Call in your guests well in advance of their arrival to allow the gate officer time to process your request. Remember, you must include your PIC identification when you call in or FAX your guest information. A request is not complete without a valid PIC number.

ARCHITECTURAL CONTROL COMMITTEE

PROCEDURE FOR SEA TERRACE I AND II SIDING CHANGE

All pre-requisites of the Davis-Stirling Act, Section 1357.130, have been met, and the expanded options of the siding material for Sea Terrace I and II are now part of the NSCA Rules and Regulations [Rule 3142, 6) and 7)].

The Architectural Control Committee recommends the following procedure for townehome owners planning to modify their siding and/or accent material of construction:

- 1. Request an Exterior Modification submittal form in the office.
- 2. Fill out this form, checking the preliminary proposal box and submit to NSCA office.
- 3. Arrange to meet with the ACC at one of their regularly scheduled bi-monthly meetings.
 - 4. Submit a final proposal to the NSCA office.

A booklet is available in the NSCA office containing Rule 3142, 6), 7) and including pictures of houses within Niguel Shores having the siding and accent modifications now allowed for Sea Terrace I and II. See Jamie Posey, Community Relations Manager, for additional information.

VOICE OF THE PEOPLE

Letters are welcome and limited to 200 words, typed if possible, including name, address and phone number of writer. Refer to NSCA Rule #5221,2,3. Submissions are due on the 17th of the month except in Feb., Nov, and Dec. when due on the 15th of the month.

At 10:30 am when the Mens Club stopped serving the pancake breakfast on July 4 the Womens Club moved into the MPR kitchen to start heating water for the hot dog lunch. So that the men could clean up the stove and griddle, we used the electric stove. With less than an hour to get ready we were dismayed when the water stopped heating. We discovered that the electric stove was not working and that the use of only two heating elements had blown the fuse. We had to ask that someone relight the gas stove so that we could get the water hot. We barely had time to get the hotdogs ready for the 11:30 serving time.

This is one more example of why we need to renovate the 30-year-old kitchen. Please vote for the renovation.

Response to Rich Hill's questions in the July issue:

Buildings are not normally reserved for by Associations. A reserve sinking fund might have been set up but we were more concerned with covering an \$800,000 shortfall in the Asphalt Overlay accounts. Current reserves are designated for specific replacement items and cannot be used.

A construction-experienced Maint. Mgr. will be used to prevent overruns. El Niguel C.C. just completed a \$7 million upgrade on time on budget.

Two hundred thousand dollars will be available from reserve line items that will be a part of the renovation, e.g. painting, wall coverings, carpet, pool decking, roof replacement. Those funds could be used to cover overruns or reallocated if not used.

The Association will have to bulldoze the office building as it has no plumbing nor meets any kind of earthquake or fire standards. There is no intention to bulldoze the M.P. Room.

If C.C. renovation is approved, it will be only the 2nd special assessment in 32 years; a pretty good reputation, which will have less effect on property values than \$100 per quarter dues increases. The length of time a member has lived in the community is not relevant to what needs to be done.

I totally agree with Rich Hill in his letter of response to "D. Mackaig, June Letter."

In addition to the points Rich makes, I should like to add the following in response to D. Mackaig:

- (1) If there are "several hundred thousand dollars...available to cover any overrun," why can't this money be used to repair existing facilities? Also, this is a vague statement. What, exactly, is the amount available?
- (2) D. Mackaig's letter sounds like a veiled threat that if homeowners don't vote for the Board plan, then repairs "will substantially increase your annual dues." What about budgeting for deferred maintenance to cover costs of repairs? Also, keep in mind the "several hundred thousand dollars" already in the budget.
- (3) Finally, D. Mackaig contends that "the options are annual assessments or more moderate annual assessments." My only response to that statement is, "Huh?"

My reaction to the initial proposed projects either for a beachfront clubhouse or the renovation of the existing Community Center was how lovely for those able to entertain and afford either idea.

But as one who saved my pennies and waited until the magic age of 55 (Prop 13) in order to consider moving to Niguel Shores, this expenditure comes as a painful blow. The proposal not only defers to those who can afford to pay up-front, it penalizes those who cannot. The intimidation was not lost on me. If you don't do this we're going to do that and if you don't do that we're going to do this. The timing of your brochure, one day before the deadline for the August newsletter will not go unnoticed by those opposed to the expenditures.

My position is not by choice but by reality, a reality that does not allow other people to choose how I spend my money.






