GENERAL MANAGER REPORT

olden Rule—What does that mean to you? The Gold-Jen Rule (which most of us grew up with and heard many times) says, "Do unto others as you would have them do unto you." It advises that we should treat others as we would like to be treated. This should inspire us to treat others with respect, kindness, and fairness. After all, isn't that how we want to be treated? I sometimes see this concept become twisted into a strategy or way of "getting what I want!" by all means possible, disregarding the values of respect, kindness, and fairness. If we could all take a step back to when we were young and remember the Golden Rule in its entirety as we engage with others—what a wonderful world this would be!

Tree Trimming

Tree trimming throughout the community should begin in September and run through to completion in December. Although we receive view complaints throughout the year, the fall months are the time when our community trees are trimmed. Once the tree trimming is completed, the trees will not grow much during the winter months and then you can expect them to come back during the spring. The trimming of our trees will start over again with the same process next fall.

Since Niguel Shores has over 1,650 trees throughout the community, your patience is greatly appreciated during this process. In addition, as the workers are trimming, you may want to be aware of the locations and if there is a tree close to your driveway or where you park your car, please move it to allow the trimming to progress. If there is a car in the way, the tree will be skipped and then the tree trimmers must come back and trim another day, causing delays. Thank you for your cooperation during this process.

Turf Over-Seeing

Fall is here now, and this is the time to scalp the warm season turf and over-seed with a cool season turf blend. October is a key transitional month in the turf lifecycle. It is the month when the warm season grasses begin to go dormant, which causes lawns to look dead and brown. Of course, the lawns are not dead, but in order to keep the lawns looking lush and green, the warm season turf needs to be scalped and new cool season turf seed blend needs to be applied.

Although the final results of this process look great, the process itself is somewhat lengthy (approximately 3 to 4 weeks) and not aesthetically pleasing. The process we adhere to is as follows:

- The irrigation will be shut off in all turf areas to allow them to dry out.
- All turf will be cut at the lowest motor setting possible (This will leave exposed dirt and is unattractive).
- The lawns will then be over-seeded with a perennial rye blend and topped with steer manure.
- In approximately one (1) month the seed will begin to germinate and there will be beautiful new grass.
- During this one-month germination period, the water will be on several times a day in small increments each time.
- As always it will look bad for a little while, but once seeded and watered heavily the grass will come back quickly looking better than ever.

MAINTENANCE

Happy Fall to all! As we move into the new season, the work in Niguel Shores shifts to more annual maintenance projects but, because we enjoy such excellent weather year-round, we always keep an eye on the most popular amenities like the beach bluff, clubhouse and pool.

Bluff Benches—Next time you are at the bluff taking in a beautiful fall sunset, be sure to notice the teak benches along the bluff edge and the newly installed double bench at the entry from



the parking lot. Seeing this area, I am really amazed by how great it looks and appreciate all the hard work of the Maintenance Staff that goes into protecting this jewel of our community.

Future Repairs—Our residents on the Selva side will want to watch for coming repairs to the Manta Gate. The repair will be to the entrance gate only, so the exit gate will be utilized for two-way traffic for a short time.

Off of Atlantic Avenue, Premier Paving will start our annual street paving project on November 29 with the closure for asphalt repair and overlay slated to begin on December 9. The project will involve all the streets in that area including Colima Bay, Timor Bay and Bluehill Bay. Because the paving involves complete closure of all these streets, details and workarounds for parking and trash pickup are being developed.

Be on the lookout for further notice of both of these projects with a written plan and map to be sent by letter, email and also on our website.

Pool Maintenance—For our pool lovers, the semiannual pool maintenance is scheduled for Monday, October 11 to Friday, October 15 and will also include the replacement of the three pool filters at the same time which will help minimize disruption. You have to love good planning!

Your request will be reviewed by the Maintenance Committee and addressed at our next meeting. TRAFFIC AND SAFETY

Mariner Gate Entry—As summer draws to a close, our Mariner Gate attendants will have screened a record number of guests and service providers. Each one had to be individually screened for access and control reasons. With the ever-increasing volume, traffic has at times backed up toward Niguel Road, causing a potential hazard. A few impatient and frustrated people waiting to be screened have lost composure and their reactions delayed the process even further.

A majority of entries that require the "extra screening" are simply not on a host's guest list. In the past, our gate attendants would try to phone the prospective host to resolve the issue. However, this effort to afford a bit of courtesy caused a delay in waiting traffic. In order to minimize waiting time at this gate, we are implementing a new procedure to minimize frustrations, ensure for safety, and improve the overall efficiency of our screening process. For the time being, unlisted prospective guests will be directed to turn around and leave the premises to resolve their absence from the host's guest list with that individual.

In the meantime, everyone can expedite the flow of traffic into our community by ensuring our party and guest lists are up to date.

Post-Commander Moving On—We are saddened to announce that Post Commander Jesus Banda, who was one of the original Securitas patrol and gate attendants assigned to Niguel Shores, is moving to another HOA in San Diego County. He will still be employed by Securitas as a Post Commander, but the move will allow him to work closer to his home. Post Commander Copeland is pleased to be here at Niguel Shores as it is close by his residence and offers a variety of challenges. He believes that his fifteen years of




lucky members won copies of Pam's book The Inspiring Wisdom of Victor E. Frankl in the raffle.

At the Men's Club meeting on **September 7**, I had the honor of interviewing 100-year-old **Dudley F. Gladding, World**

War II Bomber Pilot. Dudley flew the B-24 Bomber off the small Island of Angaur in the island nation of Palau. Dudley and his crew flew over 600 miles each way, over water, to reach the Japanese targets in the Philippine Islands. He flew 40 combat missions and was forced to bail out of his B-24 on his 31st

mission. Dudley's interview was both entertaining and fascinating. We hope to have him back at a future Men's Club meeting.

Our **September 21** meeting featured **Brian Maryott**, **49th Congressional District Candidate.** Brian discussed the results of the Gavin Newsom recall attempt and the hot issues for his upcoming congressional campaign.

In October, we'll host two excellent speakers. On **October 5**, we will hear from **Alan Hess**, architect and historian. Alan is the architecture critic of the *San Jose Mercury News*. He has written nineteen books on modern architecture and urbanism in the mid-twentieth century, including his 2012 book, *Frank Lloyd Wright: Natural Design, Organic Architecture*. Alan will discuss Hollywood's modern homes of the stars.

Our October 19 gathering will feature Dr. Dwight Stirling, CEO of Center for Law and Military Policy. During his 20-year career as a JAG officer in the California National Guard, he has tried more state courtsmartial than anyone else in California's history. GARDEN CLUB Celebrating 20 Years

To kick off the holiday season, our club will take a field trip to **Roger's Gardens** on **Tuesday, October 19.** Their garden shop will be decorated with festive Christmas trees, special ornaments, and holiday plants and bulbs available for purchase. We will meet at the Clubhouse Parking Lot at 10:00 a.m. to carpool. We've made lunch reservations for twenty people at the **Farmhouse Restaurant** on the grounds of Roger's Gardens, and we can reserve more places if needed. You may also choose to have lunch elsewhere.

The Garden Club is happy to announce the return of our popular **Lobster Fest**, to be held in the Clubhouse at **6:30** p.m. on **Thursday**, **October 28**.

What do lobsters have in common with the Garden Club? We have forests on land, but there are also kelp forests along our Pacific Ocean shoreline. And that's where the bright orange California Spiny Lobster lives.

Kelp forests are some of the most productive ecosystems on earth. They are dominated by Giant Bladder Kelp, which resembles tall grass, but is really a brown seaweed algae.

Since kelp is not a plant, it doesn't have roots. It grows in large colonies, and attaches to rocks with anchors called *holdfasts*. Kelp obtains all of the necessary nutrients directly from ocean water, and harvests the sun's energy through photosynthesis like plants on land. Kelp can grow up to two feet everyday!

Kelp has multiple commercial uses, including as organic garden fertilizer in both meal and liquid form. The next time you're at the bluff or the marina, watch for floating kelp and appreciate nature's bounty.

We are fortunate that Marine Conservation Areas were established for future generations to enjoy all our coastal resources. That means protecting our kelp forests, and the lobsters and other wildlife that live and thrive in them.

PAGE TURNERS

This month's selection is the historical fiction novel *Hamnet* by Maggie O'Farrell. This very popular book explores the lives of Shakespeare, his wife Anne Hathaway (in the book called Agnes), and their children. Interestingly, Shakespeare is never named in the book and is just referred to as "the husband," "the father," or the "Latin tutor."



NPR describes the novel as follows: "A tour de force . . . Although more than 400 years have unspooled since Hamnet Shakespeare's death, the story O'Farrell weaves in this moving novel is timeless and ever-relevant. . . O'Farrell brilliantly turns to historical fiction to confront a parent's worst nightmare: the death of a child. . . Fierce emotions and lyrical prose are what we've come to expect of O'Farrell. But with this historical novel she has expanded her repertoire . . . "

The death of Shakespeare's son Hamnet from the plague ravaging the country at the time is said to be the catalyst for his famous play *Hamlet*. One of the discussion questions (see below), I think is likely to make for a lively discourse among members:

"Hamnet was published in 2020, a year of global pandemic. In the middle of her novel, O'Farrell transports us to the Mediterranean Sea, where readers are given a horrific lesson in 16th-century epidemiology. How does the spread of the Bubonic Plague 400 years earlier parallel our own recent experiences with COVID-19?"



Wellness . . . Anxiety

Idon't need to tell you that we are living in stressful times. When we start adding up all the events happening faster than the speed of light around the world, and then ice that cake with a global pandemic, it really can jangle the nerves!

People are anxious and simultaneously depressed these days, and their numbers grow daily. I'll bet you know someone whose life has become filled with anxiety or depression, and I'll also bet some of you reading this are experiencing anxiety yourselves in one way or another. It comes on as a quiet fear that builds over time until it is part of your everyday existence, coloring every thought you have and decision you make.

Stressful events like losing a job, having a baby, losing a loved one, or even getting married are familiar to us as examples of what can trigger anxiety. However, these major

life events don't happen every day, and usually the anxiety decreases after the one-time situation resolves. For instance, the fear of "Am I doing the right thing?" as you begin walking

down the aisle will hopefully be assuaged by the time you say "I do."

In contrast, the stress of everyday life and the resulting anxiety are ongoing. Yet, when viewed from an evolutionary standpoint, this anxiety may be a good thing in our lives. That may sound counterintuitive, but it's true! During the stone age, for example, humans were on constant lookout for threats to their existence, such as predators like saber tooth tigers. Talk about anxiety! But the threat caused them

to become more alert and inventive in protecting themselves.

Today we're not facing saber tooth tigers, yet we do become anxious over events and everyday worries that create not only emotional symptoms but are manifested by physical symptoms that reduce our ability to enjoy life and move ahead. Racing heartbeat, muscle aches and tension, shortness of breath, tightness of one's chest, and more. Anxiety out of control can bring on any number of potential disease processes. Let me also say, this brief article is not to be confused with a discussion about major depressive disorder which includes anxiety. In that case, when you can't face the world at all, when you truly just want to pull the covers over your head and stay there because the whole world looks dark, it would be appropriate to consult a mental health professional.

What we should consider doing is reframing our anxiety by learning to recognize the value of those uncomfortable emotions and what they may reveal about our lives. We actually need to *keep* some fear in our lives, as it is a protective mechanism built into our neural wiring. Fear of fire is

healthy. We could get burned! Fear of a job interview is normal. When the fear becomes immobilizing, it could just be anxiety out of control. At that point, we need to stop and

ask why we're feeling this way and what is that fear. Those feelings are trying to teach us something.

It helps to make a list of "What If" this or that happens and turn it into a "To Do" list. Anxiety is lessened by action, so flipping your anxiety script to a "To Do" list shines a light on the actions needed to regain control. Also, we can try deep breathing, which activates the parasympathetic nervous system. You can even use deep breathing in the middle of that very tense interview or meeting. It's a proven way to reign in anxiety—as is moving your body on a regular basis. Motion releases dopamine, serotonin, and noradrenalin which bathe your brain in a soothing, calming bath! Who doesn't want that?

Embrace anxiety in our crazy world! Breathe deeply, exercise, flip your anxiety script, and don't try to kick anxiety completely out of your life. It could save you.





CUISINE CORNER

Snooze and Ciao Pasta

Type promised our editor a cuisine ar-

ticle, but we were stifled for over a month to produce one, till now. Snooze an A.M. Eaterv opened two months ago at Crown Valley and Greenfield in the building that was T.G.I. Friday. Snooze was our first choice for a column, recommended to us as a trendy breakfast and lunch chain with several SoCal locations. We visited the first week they were open but were not willing to wait in a long line in the hot sun for COVIDlimited seating. A few weeks later, we tried again and found a roomy, bright-colored, diner-like bustling interior. They have a liquor license (!) and the menu is wildly eclectic, a real potpourri. It's worth a look online to see what might strike your fancy. After three breakfast visits, we didn't find a particular dish we liked enough to present in detail, but there is certainly a wide variety you

won't find elsewhere, and a unique experience awaits you if you go.

We also had a look inside Calo Kitchen + Tequila next door, but without a reservation our wait would be lengthy so we decided to report on them in the future. Having a party of four and growling stomachs, we went instead to our oldstandby favorite trattoria Ciao Pasta across from the Mission on Camino Capistrano. Pasquale, the handsome Chef/ Proprietor, opened his doors in this classic mission architecture building 26 years ago, in 1995. He has expanded his footprint twice, taking over the entire site which formerly housed three businesses. Ciao Pasta's growth and popularity shows the quality this Italy-born restaurateur has brought to local Italian cuisine. His dishes all speak for themselves. and you'll find very comfortable indoor or patio seating.


