Hello HOA.

South Coast Water District (SCWD) is dedicated to water conservation and efforts to alleviate the drought. On April 14, 2022, SCWD's Board of Directors voted to move to a Level 2 Water Supply Shortage which prompts a series of conservation actions outlined in our Water Shortage Contingency Plan. This mandate went into effect on May 1, 2022 and includes the key conservation actions outlined below:

- Customers must repair leaks, breaks, and malfunctions (i.e., faulty sprinklers) within three (3) business days of District notification.
- Landscape irrigation shall be limited to three (3) days per week from April to October and will notentially reduce to no more than one (1) day per week from November to March

- State Water Resources Control Board has mandated "to prevent the unreasonable use of water and to promote water conservation, the use of potable water is prohibited for the irrigation of Non-Functional Turf at commercial, industrial, and institutional sites". Within the SCWD, this means Businesses, HOAs, Government, and Schools must not use potable water for irrigating Non-Functional Turf.
 - Non-Functional Turf is ornamental ground cover surface of mowed grass and not otherwise used for human recreation purposes.
 - This does <u>not</u> apply to: School fields, sports fields, and areas regularly used for civic or community events, the irrigation of trees or other non-turf plantings, or residential lawns.

Characteristics of Non-Functional Turf:

- Not used in a recreational manner, such as parkways strips, frontage, courtyard, interior and building adjacent turf
- Too small to offer meaningful benefit
- Located adjacent to streets, thoroughfares or parking lots that affect its use
- Located in areas difficult to access or with limited access
- Difficult to irrigate efficiently (sloped, oddly shaped)
- Without nearby amenities (benches, restrooms, shade)

- Watering, or irrigating, is prohibited between 9:00 a.m. and 5:00 p.m. (this applies to lawns, landscaping, and all other vegetated areas)
- Outdoor watering CANNOT result in runoff.
 - The application of Potable Water to outdoor landscapes shall not cause runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures.

WATERING SCHEDULE LIMITS

MONDAY, WEDNESDAY, FRIDAY ONLY

Recycled Water Users are EXEMPT



WATERING HOURS LIMITS

- · Watering, or irrigating, is prohibited every day between 9am and 5pm.
 - This applies to lawns, landscaping, and all other vegetated areas.

Outdoor watering cannot result in runoff.
The application of Potable Water to outdoor landscapes shall not cause runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures

Owners and managers of commercial, industrial, and institutional properties, including HOAs, must not use potable water for irrigating Non-functional turf



WATERING DURATION LIMITS

- Watering, or irrigating, with a device or Irrigation System is limited to no more than 10 minutes per valve per cycle.
 - · This applies to lawns, landscaping, and all other vegetated areas.



Report any leaks, spills, or overwatering to SCWD.ORG/WaterWaste

Adjust the sprinkler heads so water is directed onto landscaping, not sidewalks or streets

Replace any broken sprinkler heads

Check for and Repair Leaks immediately
