The Board-approved new grass area will be seeded in April, and will be closed for 90 days after completion. Please do not climb the protective fencing!


Thanks to all for their patience and support as completion is near and plans are being finalized for a celebration with date to be determined.



Previously we featured the work of several Dana Point artists whose utility boxes brighten the city. This month, we feature one of our own—Ashley Keene, daughter of Niguel Shores residents Chris and Kathy Zoch.

Ashley Keene's Arches Over the

Ocean decorates the corner of PCH and Niguel Road/Ritz Carlton Drive. It commemorates the historic arches still standing on the cliff above the Harbor. Many of Ashley's other creations can be found throughout our area, such as her Salty Afterglow utility box in Capo Beach, a collage on a Dana Point shed repurposed as a music studio, a patriotic mural at Olamendi's, her Epiphany elephant in Pines Park, banners for a series in Laguna Beach, and a mural at Prado West. She says, "I am always looking for an interesting canvas to work with."

For the utility boxes, Ashley revealed that the process involves having a design approved by the City, then producing a digital version of the design, then having the digital version turned into a vinyl wrap that covers the box. With this method, the wrap can be removed to make repairs to the utility box, or replaced if the vinyl is damaged.

Ashley has lived in the area all her life and loves being part of

the Dana Point community. As a **Dana Point Arts Ambassador**, she assists in bringing art and culture to the City through numerous events as well as the art



PICKLEBALL

The pickleball craze is alive and well in Niguel Shores. The sport has ushered in a major shift—sporting goods stores are now stocking up on pickleball equipment. Walmart has even tripled its shelf space for paddles, balls and other merchandise. Pickleball is seemingly everywhere.

However, with all this new growth comes a downside injuries! Orthopedic surgeons now say they love pickleball—lots of new business!

To prevent injuries, here are some basic things all players can do.

Know Your Limits: Old injuries can flare up when playing pickleball. Understand your limits, even if it means losing a point here and there. Pushing so hard that you run into a fence or fall down is a serious injury waiting to happen. Pickleball should be fun—not painful!

Warm Up: You can prevent a lot of injuries by warming up with a hot shower or some light exercise. A quick warmup on the court helps too.

Stretch: Stretching your feet, legs, lower back, and shoulders gives you more flexibility which, in turn, helps prevent injury and makes your play more accurate (less wild).

Hydrate: Drink water before, during, and after play. Getting dehydrated can make your reaction time worse and hinder your thought process, which can lead to injury.

Wear the Right Shoes: The best shoes are court shoes that support your feet, legs, and back. Be sure to choose a pair in the right size that fits your arch type and has enough cushion.

Ice Your Aches and Pains: If you have aches and pains after playing, icing the affected area can help you recover faster.

Rest/Sleep: Resting gives your muscles time to recover so you can get back back out there and play another day.

ATTENTION NIGUEL SHORES! — PROPOSED APARTMENT COMMUNITY ON NIGUEL ROAD

Proposed Apartment Complex— On January 31, 2024 a revised preliminary application was submitted to the City of Dana Point for construction of 708 apartment units at Niguel Road and Mariner Drive in the spot where the current Monarch Villas apartments are now located.

The proposed buildings would rise

45 to 90 feet high (4 to 8 stories) with a rooftop amenity on the highest building. This is nearly double the density and several stories taller than the developer originally presented when explaining the project to our community.

The developer's revised preliminary application shows 108 of the 708 units are devoted to low/moderate income housing. California SB330 allows a developer with low income units to seek a density bonus, parking reductions, a development standard waiver for height relief, and possibly additional waivers, incentives and

concessions regardless of city zoning and other planning related ordinances.

Upon the developer's filing of a final application, the City will conduct an extensive Environmental Impact Report.

HOME SWEET HOME

NIGUEL SHORES BERKUS HOMES

As you come in from the Main Gate and turn an immediate two left turns you are in the Berkus homes, covering nine streets bordering on Niguel Road and Stonehill Drive. These 105 homes, often described as the "Brady Bunch Homes" for the many families who first purchased there, were built in 1972 on larger-than-standard lots.

Berkus homes are named for their designer and builder, Barry A. Berkus, who was known as a "planner and designer of custom homes that

redefined living patterns in housing." The sales brochure described the homes as a "gardener's dream" based on the unique-sized lots that gave each house front, back and side yards. Originally called Sea Terrace Homes, the development later changed to Berkus Homes.

The Berkus neighborhood was designed to have a balanced mix of one-and-two-story detached houses. Buyers could choose from five plans. Three single story plans featured two and three bedrooms, two baths and a two-car garage. These 1,560 to 1,966 square foot homes were priced from \$52,900 to \$58,900. Two other plans offered two-story homes with three to four bedrooms and a three-car garage. These homes were priced from \$60,900 for a 1,996 square foot home to \$63,900 for a 2,223 square foot home. Added to the mortgage rate was a Community Association fee in 1972 of \$33.50 monthly.

Our area was unincorporated at the time and later voted to became part of the City of Dana Point, but the early sales brochure advertised many of the "luxury features" that came with your new home to "help make Laguna Niguel living easier and more fun for everyone." Among these luxuries were the shag wall to wall carpet of the era, along with



laminated plastic counter tops in the kitchen, and cedar shingle or shake roofs. The developer specified that the homes be built to allow a wide space between homes to facilitate ocean views. The larger lots include ownership from the bottom of the slope to the top. Single-story homes could be enlarged with a second story as long as ocean views were kept.

The cul-de-sac streets led to tight knit neighborhoods, building life-long friendships. Several families still living there have known each other for decades and now welcome their children's children. One owner can recall that their street had 22 children who grew up together riding their bikes down the then-dirt road to the beach, past where the Ritz Carlton is now located. They pedaled past a barn where Hobie was building surfboards, on their way to the sand. Mature trees on the property coupled with scattered lemon trees were there to climb, along with the slopes.

Today's Berkus owners speak with pride about their unique homes with spaciousness, high ceilings and beautiful views, but most of all for their friendships that have endured over the years in their "Brady Bunch" homes.

The scope of the EIR includes items such as Land Use, Aesthetics/Light and Glare, Tribal and Cultural resources, Geology/Soils, Hydrology/Water Quality, Hazards/Hazardous Materials, Transportation, Air Quality, Greenhouse Gas Emissions, Energy, Noise, Population/Housing, Public Services/Recreation/Utilities, Cumulative Effects and Alternatives. The public will be allowed to participate in discussion of the EIR and make their comments or objections known.

Learn More, Become Involved—Members of our community and neighboring communities along Niguel Road have asked the developer and the City to explain this project and make a new presentation about their overall intentions, but there is no date set for this as yet.

Meanwhile, we encourage you to **inform yourself.** To see the plans and exterior renderings of the proposed apartments, you can visit the **developer's website** at *imaginembvillas.com*. Their renderings show architecture similar to the high-rise apartments at Crown Valley and the 5 Freeway, or the constructions on PCH in Dana Point. In the **developer's illustration** shown here, Buildings B1 and B2 are proposed to be 4 to 5 stories high, while Building A is proposed to be 8 stories high with an additional construction on the rooftop.

Wellness - NAFLD

Thave a friend. A lovely woman I met about ten years Lago. She's a gifted photographer, an animal lover, a kind, funny, and empathetic person—a delight. In her mid-50's, a decade when her adult kids were getting married and starting their families, she experienced mild and intermittent upper right quadrant abdominal discomfort, some fatigue, and just not feeling well. It was as if she had no symptoms, really, as they were so vague and mild. They could've easily been confused with just being "run down" due to weeks of an overloaded work schedule, family demands, and other responsibilities. However, her doctor found that she had fatty liver disease. Non-Alcoholic Fatty Liver **Disease** (NAFLD) to be exact. Something unexpected that could be treated, but if ignored could accelerate over time to cirrhosis and liver failure.

NAFLD is on the rise around the world, especially in Western and Middle Eastern countries where obesity is increasing. NAFLD has a rate of occurrence in the world population of about 25%, with about 100 million US residents (including children) suffering from this increasingly common chronic liver condition. From there, some people will go on to develop Non-Alcoholic Steatohepatitis (NASH) which is more serious and is associated with fat accumulation



and scaring in the liver which impacts the liver's ability to function properly. This can lead to cirrhosis and liver failure. It is also when, if one is a good candidate, a liver transplant can be considered.

People who are overweight or obese, have Diabetes Type 2, or high levels of triglycerides and/or cholesterol are at a greater risk of developing NAFLD and should probably have their liver checked annually. Of course, one should discuss this directly with their primary physician or healthcare provider to determine if taking a closer look at liver function is warranted. If it's determined that the liver does show evidence of NAFLD, further discussion of whether or not one is drinking too much alcohol, taking certain medications, or may have another disease process going on should take place before a diagnosis of NAFLD is determined. If one's doctor is concerned about the possibility of NASH, a liver biopsy is likely the next step.

One of the most important steps one can take to treat NAFLD or NASH is to reach a healthy weight and sustain it over time by cutting calories, exercising at least five days a week, and avoiding alcohol.

As for my friend who has NAFLD, her liver is healthier as she has lost significant weight, enjoys daily walks, and has changed her eating habits by excluding the rich foods that our western culture promotes. Many people have NAFLD and are unaware of it too. So, take good care of yourself, talk to your doctor at your next visit if you're concerned, and know that the early stages can be turned around leaving you in better health than when you started this journey!



MARKET UPDATE



ACTIVE LISTINGS

The active listing inventory in the past couple of weeks increased by 53 homes, up 3%, and now sits at 1,992. It is the second-lowest mid-February reading since tracking began in 2004, only behind 2022. In February, 38% fewer homes came on the market compared to the 3-year average before COVID 1,178 less.



DEMAND

Demand, the number of pending sales over the prior month, increased by 79 pending sales in the past two weeks, up 6%, and now totals 1,476, the lowest end-of-February reading since tracking began. Last year, there were 1,505 pending sales, 2% more than today. The 3-year average before COVID (2017 to 2019) was 2,422, or 64% more.



EXPECTED MARKET TIME

With demand rising faster than the rise in supply, the Expected Market Time, the number of days to sell all O.C. listings at the current buying pace, decreased from 42 to 40 days in the past couple of weeks. It was 44 days last year, similar to today. The 3-year average before COVID was 64 days, slower than today.



CLOSED SALES

There were 1,182 closed residential resales in January, up 4% compared to January 2023's 1,137. December marked a 10% drop compared to December 2023. The sales-to-list price ratio was 98.5% for all of Orange County. Foreclosures accounted for 0.1% of all closed sales, and short sales accounted for 0.1%.
