#### GENERAL MANAGER REPORT

#### **Congratulations**

ongratulations to the new 2024-2025 Board of Director members, **Bob Berkery**, **Rick Palmer** and **Brian Porter** who were elected to the Board by the community at the annual meeting held May 21, 2024. Thank you to all the candidates who volunteered to run for the Board this year (**Bob Berkery**, **Rick Palmer**, **Brian Porter**, **Doug Robinson**, and **Sandi Stauffer**) and all who participated in this electoral process. Also, a special thank you to **Jim Cobb**, **John Douglas** and **Rhonda Dunlevie** for their dedicated service to Niguel Shores.

Rules Committee Meetings and Updates: It is that time of year again when we begin looking into the rules and updating any that may need to be revised or merely reworded for clarity. The Rules Committee will be meeting beginning in June and will meet once per month until they have completed their review. Once they have completed the review, the suggested rules will go to legal and the Board. The suggested rules will then be mailed to the membership for their opportunity to review and comment. The membership will have 28 days to make comments or suggestions. All comments will then be provided to the Board of Directors along with the comments from the membership for final approval, generally done around December for a January 1 effective date.

Assessment Payments: Assessments are due the first day of the quarter or January 1, April 1, July 1, and October 1. These assessments are not late until the 30th of that same month so please remember to plan accordingly. If the 30th falls on a weekend and the payment does not get posted by the Association bank until the next business day, it will be considered late and will have a late charge applied. To prevent this from

happening it would be a good idea to schedule your payment several days before the 30th to avoid late fees. In addition, if you have payments set up to come out of your bank account remember that the bank must process a check, put it in the mail to the Association, then the Association bank processes the payment. Sometimes this takes a little longer, so allow for extra time to avoid any late fees.

#### BRIDGE

#### **Doubling**

We have all been on double dates with our friends, or we've played Doubles in Tennis. In Bridge we use "Double" when we feel we can stop our opponents from making their bid, thereby increasing our score.

"Beware!" I say this because if you double your opponent's bid and they make their bid, then this usually propels them into game. If they make an overtrick, their reward is an additional 100 points per trick if they are not vulnerable, and 200 points per trick if they are vulnerable.

Yes, it is risky, but there are rewards for the doubler. If the opponents go down one and they are not vulnerable, the doubler gets 100 points, and if the opponents are vulnerable they get 200 points. if the opponents go down two, it awards the doubler 500 points.

So when do we double? A takeout double is made by the doubler on most hands with 16+ points regardless of distribution. An example would be if the opposition bids 4 diamonds and the opponent is holding the A,K,Q,J of diamonds it is obvious this contract would not be reached. Doubling should only be used when it is obvious to the doubler that his hand, alone, can stop their opponents.

This month, members of Page Turners Book Club are reading The Only Woman in the Room, a fictionalized biography of Hedy Lamarr, written by Marie Benedict.



This New York Times and USA Today bestseller illuminates a historical figure whose talents and achievements have largely been overlooked. Hedy Lamarr, a strikingly beautiful young actress in pre-WWII Austria, caught the eye of a smitten Austrian arms dealer, her future husband. Thought to be merely a gorgeous accoutrement to a wealthy man, her intellectual powers were totally underestimated.







#### **PICKLEBALL**

After watching drop-in play on Saturday mornings in our great neighborhood, I have been so impressed with how much everyone has improved. I thought this might be a great time to give a few tips on handling



some of Pickleball's most common errors.

- Make sure you get your serve in. Don't worry about hard, fancy, or spinning serves. As your level rises, so will your opponent's and every serve will come back.
- Try and get your returns as deep as possible. The more height and depth you get, the more time it gives you to get to the net.
- Get to the net as soon as you can but don't force your way in. If you hit a high ball to the net person, stay back and relax and try and drop the next ball at their feet. In the words of famed basketball coach John Wooden: "Be quick, don't hurry"
- If you are hitting a ball that is below the net, always hit to the deeper opponent. If you have a high ball, attack the closer opponent.

- When you are at the net playing hard hitters or in a quick exchange, always have your paddle shaded to the backhand side. You'll be able to cover at least 50% more of the shots directed at you.
- Move with your partner. If your partner has to take two or three steps to the left or right, make sure you move with them.
- Always protect the middle of the court. At least 70% of all balls struck will go through the middle.

In closing, again in the words of John Wooden: "It takes time to create excellence. If it could be done quickly more people would do it " Most important of all keep having fun!

# Wellness - Emotional Exhaustion

Exhaustion. Do you feel it? I don't mean the kind of exhaustion that comes from moving pianos or battling three-year-olds to get them to eat, even though either can be relentlessly tiring. I mean, that feeling of emotional weariness – the resignation that life has perhaps grown a little too big to handle. It's like playing in the surf at the beach and realizing the waves are bigger than you thought. What do you do? You take a deep breath, go under the wave, and hope for the best. Over, and over, and over again. But trying to stay afloat amid difficulty can be exhausting, both physically and emotionally.

#### APARTMENT COMPLEX UPDATE



n May 9, Niguel Shores, Ritz Point, and Monarch Beach residents were invited to an information meeting regarding the Monarch Beach Villas apartment development proposed across from our Mariner Gate main entrance. The Niguel Shores clubhouse was packed, standing room only, as Dana Point city officials updated everyone on the present status of the project.

Shores resident Steve Stewart introduced City Council Member John Gabbard, City Manager Mike Killebrew, Assistant City Manager Kelly Reenders, and Community Development Director Brenda Wisneski. Each gave information about the status of the development and later answered questions from the audience.

Brenda Wisneski gave a summary of the project proposed by the developer. The present complex of 208 apartments would be replaced by 708 apartments in buildings from four to eight stories high. You can view their application by using the QR code accompanying this article or by visiting https://www.danapoint.org/home/showdocument?id=377 36&t=638487858819941971

Because the project designates 30% of the apartments as low and moderate income units, the State of California's SB 330 and Government Code Section 65915 allow height and density waivers – thus overriding the City's much lower height and density rules. A City handout, given at the meeting, says, "This application continues to calculate base density in a manner the City believes is inconsistent with its related regulations."

John Gabbard and Mike Killebrew added that the State's mandates for more housing are affecting cities everywhere, and builders are using SB 330 to their advantage in constructing larger and more dense complexes. Any changes giving cities more power would have to come from the State Legislature. State Senator Janet Nguyen represents Senate District 36 and can be reached at (714) 374-400. Assemblywoman Laurie Davies represents Assembly District 74 and can be reached at (949) 240-7300.

Wisneski indicated that the project developer has until July 29, 2024 to submit a full application for consideration. Following receipt of the full application, the City will begin a review process in accordance with SB330. This will include an Environmental Impact Report (EIR) which will offer opportunities for public review. At that time, items such as the impact on traffic, noise, pollution, and wildlife will be considered. The City Council has 90 days from receiving the EIR to make a final decision on accepting the proposed plan or asking for mitigations in the proposal.

Various comments from Niguel Shores, Ritz Point, and Monarch Beach homeowners in the audience all echoed the same point: The proposed apartment complex will impact traffic, noise, density, safety, and lifestyle in the area. We will need to stay involved and make our voices heard if we want any



# **MARKET UPDATE**



#### **ACTIVE LISTINGS**

The active listing inventory in the past couple of weeks increased by 150 homes, up 6%, and now sits at 2,470. In April, 32% fewer homes came on the market compared to the 3-year average before COVID, 1,272 less. 604 more sellers came on the market this April compared to 2023.



#### DEMAND

Demand, the number of pending sales over the prior month, increased by 52 pending sales in the past two weeks, up 3%, and now totals 1,759. Last year, there were 1,660 pending sales, 6% fewer. The 3-year average before COVID (2017 to 2019) was 2,765, or 57% more.



# EXPECTED MARKET TIME

With supply rising faster than demand, the Expected Market Time, the number of days to sell all O.C. listings at the current buying pace, increased from 41 to 42 days in the past couple of weeks. It was 39 days last year, similar to today. The 3-year average before COVID was 68 days, slower than today.



#### **CLOSED SALES**

There were 1,968 closed residential resales in April, up 16% compared to April 2023's 1,696, and up 10% from March 2024. The sales-to-list price ratio was 100.4% for O.C. Foreclosures accounted for 0.05% of all closed sales, and short sales accounted for 0.15%.
